SUBJECT:

Consideration of Resolution No. 637-24, Authorizing Changes to the FY 2023-2024 Adopted Budget.

RECOMMENDATION:

Staff recommends adopting the attached resolution.

EXECUTIVE SUMMARY:

Local Budget Law allows for a supplemental budget to be prepared to authorize the transfer of appropriation authority to an appropriations category that doesn't already exist in the adopted budget.

The FY 2023-2024 budget was adopted with \$132,220 in the Leveton Projects Fund Transfers category. During the FY 2022-2023 annual audit process, the Commission's independent auditors determined the appropriate category for this amount should be Special Payments. The attached resolution creates the Special Payments category and moves the appropriation from the Transfers category into the newly created category.

FINANCIAL IMPLICATIONS:

There is no impact to the Leveton Project Fund as the resolution is only movining currently budgeted appropriations from one appropriation category to another category in the same amount.

RESOLUTION NO. 637-24

A RESOLUTION AUTHORIZING CHANGES TO THE ADOPTED 2023-2024 BUDGET

WHEREAS, an occurrence or condition that was not ascertained when preparing the budget requires a change in the adopted FY 2023-2024 budget;

WHEREAS, in order to lawfully comply with the requirements of Local Budget Law, changes to the adopted 2023-2024 budget are necessary;

WHEREAS, ORS 294.471 allows for a supplemental budget to be prepared.

BE IT RESOLVED BY THE TUALATIN DEVELOPMENT COMMISSION, THE URBAN RENEWAL AGENCY OF THE CITY OF TUALATIN, OREGON, that:

Section 1. The Board of Commissioners wishes to comply with Local Budget Law, and authorize the transfer of appropriation authority to an appropriations category that doesn't already exist in the adopted budget.

Section 2. The purpose of the appropriation resolution is to create an appropriation category of Special Payments and transfer the appropriation already budgeted in the Transfers category.

Section 3. Adjustments to the adopted 2023-2024 adopted budget should be made to move the \$132,220 appropriation from Transfers to Special Payments in the Leveton Projects Fund.

Section 4. This resolution is effective upon adoption.

RECOMMENDATION:

Staff recommends adoption of the attached resolution, which includes the Budget Committee Approved Fiscal Year 2024-2025 Budget, after conducting a public hearing to consider public input.

EXECUTIVE SUMMARY:

The City of Tualatin Budget Advisory Committee approved the proposed budget on May 29, 2024. The total of the Fiscal Year 2024-2025 Budget is \$3,340,475 and is allocated between the Tualatin Development Commission (TDC) Administration Fund, the Southwest Urban Renewal District (SWURD) Bond Fund and the Core Opportunity and Reinvestment Area (CORA) Bond Fund.

Due to projects and development being considered in the Basalt Creek area, a staff position is included in the TDC Administration Fund, with a transer from the SWURD Bond Fund to pay for the position. Both SWURD and CORA are currently collecting tax increment and funds are being set aside in the Reserve category to be used for future projects.

Oregon State law requires the Commission to adopt a budget prior to July 1, 2024.

OUTCOMES OF DECISION:

By adopting the budget before July 1st, the Commission will be able to operate, expend money and incur liabilities for fiscal year 2024-20245.
