RECOMMENDATION:

Community Development staff will give an overview of key land use and transportation projects for the first quarter (Q1) of 2020 to discuss opportunities for advocacy and coordination.

EXECUTIVE SUMMARY:

The purpose of this update is to accomplish the following:

- 1. Highlight the top 2020 Q1 projects that are active in the decision-making or engagement process.
- 2. Discussion of Council, staff, and community coordination for input on these projects.
- 3. Provide a directory of projects going on within the county, region, and state that have an impact on Tualatin.

For Q1, staff deemed the following as top projects:

- Oregon Department of Transportation's (ODOT) I-5 and I-205 Tolling Study: ODOT
- 99W Corridor Study and Let's Get Moving 2020: Metro, ODOT, Tualatin, Tigard, Sherwood, King City, Durham, and Washington County
- Southwest Corridor Plan: TriMet and Metro

Attached to this agenda is a description of the top projects and a list of active and less active projects. Staff will not provide a presentation on all of the projects, but will follow up on questions, contact speakers to come to Council, or bring forward these topics to a future work session for discussion.

I-5 and I-205 Tolling Study: ODOT

Q1 Top 3

Q1 Update

ODOT started the project in early 2020 by holding technical staff coordination meetings and briefings at county and regional public meetings. I-205 tolling study will start before I-5, and ODOT began a community survey to better understand driving patterns pre-COVID that will reopen this fall. They are currently accepting applications for people who would like to serve on the Equity and Mobility Committee (apply here). **ODOT staff will be presenting at the May 26 Council meeting.**

Metro has started by gathering research and has been coordinating through <u>TPAC</u> and <u>JPACT</u>. Due to the feedback received, they are setting up a technical work group to review and provide input along the way.

At the May 11 Council meeting, staff would like to know what items or issues are important for Tualatin. What are concerns or opportunities should staff advocate for in meetings? Staff has generated the following list of items:

- 1. Fully account for the transportation, economic, and quality of life impacts from traffic diversion on local roads, especially in equity neighborhoods.
- 2. Fully account for the impact to Tualatin employees and employers.
- Study increased transportation options from tolling revenue, especially for connectivity (new roads, trails, sidewalks, etc.) and increased transit service.

Description: ODOT will continue their process of studying tolling segments (map) on Interstate 5 and 205.

Impact to Tualatin: Direct impact to Tualatin residents and businesses traveling along the interstate or state highway system. Possible impact to roads with vehicles diverting from highways to avoid tolls.

Highway 99W Corridor Study: ODOT, Tualatin, Tigard, King City, Sherwood, Durham, Metro, and Washington County

Q1 Top 3

Q1 Update

ODOT and their consultant, Nelson/Nygaard, are nearing the completion of an "initial look" at the cost and intent of a full corridor study.

Although the state legislature ended abruptly, \$1 million was recommended in <u>HB</u> 5204, also know as the "Christmas Tree" bill, to fund a 99W corridor study.

Through Metro's Let's Get Moving 2020 transportation measure, \$3.5 million is recommended to fund a 99W corridor study. The measure has yet to adjust for revenue, so 99W funding is not final. Metro staff will be coming to the May 26 Council meeting to present an update on the transportation measure.

Description: A corridor study could help prioritize and direct larger efforts to achieve transformational change to meet future equity, safety, congestion, and climate smart strategy needs. For example, Tualatin's Transportation System Plan envisioned a park-and-ride facility along 99W that would collect commuters and shift them on to public transit, thus reducing congestion on internal roads.

Impact to Tualatin: Highway 99W dissects Tualatin's northwest corner and serves as a gateway into our major employment areas. Safety and congestion are major needs for the corridor and Tualatin residents. Tualatin Moving Forward has begun to address these needs by filling in sidewalk gaps, but larger investment is necessary to meet community needs.

Southwest Corridor: TriMet

Q1 Top 3

Q1 Update

There is still a \$93 million funding gap that the Steering Committee and project partners will have to solve through additional revenue or cuts to the project. The <u>Conceptual Design Report</u> (CDR), which explains the look, feel, and design of the project, is nearing completion of public engagement (<u>website</u>). Early takeaways from the community engagement report include:

- Bridgeport Transit Center Station was the favorite!
- Concerns about at-grade crossing at Upper Boones Ferry
- Park-and-ride spaces were polarizing; less in Portland, more at Bridgeport
- Feedback from Aging Task Force, open house, and online: maintain and expand bus access, more park-and-ride at Bridgeport, extend line or don't preclude with design, and glad to see Village Inn preserved

The publication of construction drawings describing the project's impact, called the Final Environmental Impact Statement (FEIS), has been pushed from spring to late summer.

In 2020, TriMet will need a letter of support from Tualatin to include with their federal funding application. This will be an opportunity to clarify how Tualatin items or issues are being addressed.

Description: An effort to establish a new 12-mile <u>TriMet MAX line</u> (light rail) between southwest Portland and Bridgeport Village in Tualatin (watch this excellent <u>video</u>). In addition to light rail, the plan includes roadway, bicycle and pedestrian projects, a strategy to promote equitable development in the corridor (<u>SWEDS</u>), and a shared investment strategy for transportation improvements that connect the corridor's communities to the proposed light rail line.

Impact to Tualatin: Major opportunities and challenges that come with new light rail. Bridgeport Transit Center is planned to serve not only locals, but as a regional hub for transportation connections.

BUILD grant for Basalt Creek parkway extended: *Washington County*

Active

Q1 Update: Washington County is applying for a federal <u>BUILD</u> grant to pay for the construction of Basalt Creek Parkway extended. In 2019, they applied and did not receive the grant. This is an annual grant application.

\$6 million for design and right-of-way acquisition has already been provided through the Federal Highway Administration and the <u>Major Streets and Transportation Improvement Program</u> (MSTIP 3e). The estimated total project cost is \$31 million.

Description: This project is intended for design of the Basalt Creek Parkway extension between Grahams Ferry and Boones Ferry roads. Basalt Creek Parkway will be a five lane arterial with bicycle and pedestrian facilities, drainage and street lighting. The project includes a bridge across Sealy Ditch and a new signalized intersection at Boones Ferry Road.

Impact to Tualatin: As identified in the transportation study for the Basalt Creek Concept Plan, the transportation connection between Grahams Ferry and Boones Ferry roads is needed for circulation and connectivity.

Shuttle expansion in Tualatin: Ride Connection

Q1 Update: Ride Connection received 69 responses to a community survey, as well as feedback at the Tualatin Library, Aging Task Force, Juanita Pohl Center, and through discussion with city staff. With the current restrictions, they are planning to conduct phone interviews and shuttle drivers. They are working on ways to contact employers and employees.

For expansion, they are in a holding pattern. Ridership on the Tualatin Shuttle is down about 70%. The major funding source for operation comes from the State Transportation Improvement Fund (STIF). Since STIF is generated through payroll tax, rising unemployment could have significant budget implications.

Description: Through HB 2017/Keep Oregon Moving Regional Coordination funding, Washington County in coordination with Ride Connection will be evaluating and funding expansion of the Tualatin Shuttle.

Impact to Tualatin: Identify specific investments or expansion areas for the Tualatin Shuttle.

Shuttle study connecting Tualatin to West Linn and Oregon City: *Clackamas County*

Q1 Update: Clackamas County selected Kittleson & Associates to begin work on the project which includes multiple transit projects in the county. Due to time constraints, they began with Oregon City and Clackamas industrial shuttles. They are in the process to develop a public engagement plan for the shuttle study with Tualatin.

Description: Through HB 2017/Keep Oregon Moving Regional Coordination funding, Clackamas County will be hiring a consultant to lead a transit evaluation between Tualatin and Oregon City.

Impact to Tualatin: Identify specific investments and costs for a transit connection with West Linn and Oregon City.

Let's Get Moving 2020 transportation measure: Metro

Q1 Update: In April, Metro Council recommended \$3.5 million for funding a 99W corridor study as a Tier II corridor investment. The measure has yet to adjust for revenue, so 99W funding is not final.

Description: By early 2020, Metro Council will decide on whether or not to refer a multi-billion dollar transportation investment measure to voters on the November 2020 ballot.

Impact to Tualatin: If issued by Metro Council, Tualatin residents will have an opportunity to vote on a regional transportation funding measure. This funding would be necessary to build the Southwest Corridor light rail to Tualatin. It would come with additional taxes, but would establish a new source for transportation funding.

Regional mobility policy update: Metro and ODOT

Q1 Update: During 2020, Metro and ODOT staff will be preparing and analyzing mobility police options to gain feedback for a final option in 2021.

Description: Metro and ODOT have been working to begin updating the Regional Mobility Policy, which sets standards for which transportation and land use development is measured or receives investment.

Impact to Tualatin: The existing mobility standards require Tualatin to have targets for reducing emissions and single-occupancy vehicles, along with levels of service are requirements. The mobility policy and new standards will have a major impact on Tualatin's ability to develop or secure transportation funding.

Designing Livable Streets update: Metro

Q1 Update: Metro Council adopted the Designing Livable Streets and Trails guide in late December. This will serve as best practice and guidelines for Metro-funded transportation projects.

Description: Metro's Designing Livable Streets and Trails Guide provides design guidance for regional streets and trails. The guidelines were developed to help implement the 2040 Growth Concept and the Regional Transportation Plan.

Impact to Tualatin: Design guidelines set by Metro could be used as requirements for regionally funded projects or through the regional functional transportation plan, which we are required to follow in our Transportation Systems Plan.

Q1 Update: Public comment was open for projects in the 2021-2024 and amendments to the 2018-2021 STIP. In Tualatin's benefit, funding to replace the bridge travel surface and joints on the 99W Tualatin River bridge, northbound, was recently moved from the 2021-2024 STIP into the current period.

Bus on Shoulder Study: ODOT and TriMet

Active

Q1 Update: Funding has been allocated through the Metropolitan Transportation Improvement Plan (MTIP) to complete a year-long study of the feasibility.

Description: TriMet and ODOT will study "freeway express service" using bus on shoulder. The primary goal of the project is to determine where the market is for express and limited stop service.

Impact to Tualatin: This could be a huge benefit to Tualatin to increase TriMet or SMART bus speed and reliability along existing routes, as well as open a path for new connections (e.g. Oregon City).

First-last mile transportation study: Washington County

Less Active

Description: The First and Last Mile study will provide information

on how to improve connections between transit and commuter destinations. The project will result in recommendations for infrastructure investments and ideas on how to integrate mobility or new technology options. Tualatin's downtown WES station was selected as one of 10 finalist locations that will receive the full analysis.

Statewide Transportation Improvement Fund (STIF): *TriMet* and ODOT

Description: Established by the HB2017/Keep Oregon Moving legislation, this is a new state fund for public transportation.

Impact to Tualatin: This is a possible funding source for transit investment. Although it is a state program, much of the allocation control is given to TriMet and then through the counties (Washington and Clackamas). Examples of investment are TriMet's Line 76 service increase and Ride Connection's shuttle expansion.

I-205 widening and Abernathy Bridge replacement: *ODOT and Clackamas County*

Description: ODOT's I-205 Widening and Seismic Improvements Project will add a third lane in each direction and upgrade the Abernethy Bridge and the eight other I-205 bridges in the project area to withstand a major earthquake. As of April 2020, funding has not been secured for construction.

Impact to Tualatin: In addition to the transportation benefits for Tualatin, elements of the Stafford area planning agreement are coordinated with I-205 widening completion.

OFFICIAL MINUTES OF THE TUALATIN CITY COUNCIL WORK SESSION FOR APRIL 27, 2020

Present: Mayor Frank Bubenik, Council President Nancy Grimes, Councilor Bridget Brooks, Councilor Robert Kellogg, Councilor Paul Morrison, Councilor Maria Reyes, Councilor Valerie Pratt

Mayor Bubenik called the meeting to order at 6:31 p.m.

1. Tualatin 2040 Work Plan.

Community Development Director Aquilla Hurd-Ravich presented the Tualatin 2040 work plan. She recapped what has been accomplished including both analysis and the priorities. The work plan for the remainder of the project will span 2020-2021 and consist of three main pieces: comprehensive plan update, development code update, and community engagement. The comprehensive plan update will remove it from the development code and update chapters to reflect the housing needs analysis. The development code update will include regulations that reflect the policies of the comprehensive plan.

Director Hurd-Ravich stated the comprehensive plan will have several goals: to separate the comprehensive plan from the development code, add photos and graphics, update the introduction to make the plan more relatable and usable, and to incorporate the housing element to encourage a diversity of housing types in Tualatin. The timeline for team creation and kick off is Spring/Summer 2020, public outreach in Summer/Fall 2020, and plan adoption in the Spring/Summer 2021.

Director Hurd-Ravich stated the development code update is to make it consistent with the comprehensive plan updates to comply with HB 2001. The timeline includes completion of a DLCD grant for technical assistant in November 2020, team creation and kick-off in early 2021, public outreach in Summer/Fall 2021, and code adoption in June 2022.

Director Hurd-Ravich stated the community engagement plan includes heavily involving the community. Staff will be providing updates to the Planning Commission and City Council, establishing a web presence, going to where the people are, and committing to diversity, equity, and inclusion. Director Hurd-Ravich stated the next update to Council on the work plan will come in July.

Councilor Pratt asked about diversity of housing types and when they will get added into the development code. Director Hurd-Ravich stated it will be part of the development code update and done through a plan text amendment.

Councilor Morrison asked about the possibility of extending the deadline so public outreach can be conducted most effectively. Director Hurd-Ravich stated legislation would most likely have to be changed in order for an extension to be granted.

Councilor Kellogg asked if the DLCD grant had been allocated for and if the city budget appropriately in case it was not received. Director Hurd-Ravich stated they have already been allocated and the city budgeted for both.

Councilor Kellogg asked if there was a timeline for further substantive updates in relation to the comprehensive plan. Director Hurd-Ravich stated the main focus for this update is housing.

Council President Grimes suggested community outreach and soliciting input from active developers in other communities that can be applied to Tualatin.

Mayor Bubenik asked if staff is confident with the timeline with the current state of the city. Director Hurd-Ravich stated she believes the timeline is still valid. She noted she will be having further discussions with staff on community engagement.

Mayor Bubenik asked about the separation of the development code and zoning code. Director Hurd-Ravich stated it is part of this phase.

Mayor Bubenik adjourned the meeting at 7:03 p.m.

Consideration of <u>Resolution No. 5491-20</u> Authorizing the Purchase of Right-of-Way and easements for the construction of the Garden Corner Curves project, part of the Tualatin Moving Forward Bond Program.

RECOMMENDATION:

Staff recommends that the Council approve the attached resolution to purchase right-of-way and easements for the Garden Corner Curves project.

EXECUTIVE SUMMARY:

This resolution enables the City Manager to execute legal documents to acquire the property needed to construct and maintain the Garden Corner Curves project.

The majority of the project will be constructed within existing right-of-way. However, some additional right of way and easements are need along both sides of the roadway.

During the conceptual design phase, the project team evaluated multiple configurations to reduce the project footprint in order to reduce right of way impacts, avoid structures, minimize creek and wetland impacts, and reduce project costs while still meeting transportation requirements. The property we are proposing to purchase allows us to meet the goals established during conceptual design by moving the roadway slightly to the north and west to provide space for the shared use path along the east side of the roadway.

Four properties are affected. The City's offering prices were based on appraisal performed by BBG, Inc. and recommendations from Universal Field Services, Inc. and they have been agreed to by each of the property owners. Acquisitions on each property are as follows (note that offer amounts are rounded):

Karsseboom (Garden Corner Nursery)

- Property is located on the south side of Blake St and east side of 108th Ave, and includes a
 residence and the Garden Corner Nursery.
- Owners: Jonn C. Karsseboom and Tracy L. Bigej-Karsseboom

- The City is purchasing public right-of-way (435 sq ft), a public utility easement (4,185 sq ft) and a temporary construction easement (8,733 sq ft)
- **Acquisition amount \$55,200**, which includes \$21,284 for right-of-way, \$23,436 for public utility easement, and \$10,480 for temporary construction easement.

Helenius/Hall Tax Lot 1300; 10665 SW Blake St

- Property is located on the north side of Blake St and includes a residence
- Owners: Betty A. Helenius, Beverly J. Hall, and Larry E. Helenius
- The City is purchasing public right-of-way (3,606 sq ft), public utility easement (7,934 sq ft), temporary construction easement (16,052 sq ft, including area for temporary contractor storage), and slope easement (3,658 sq ft).
- Acquisition amount \$57,500, which includes \$29,257 for right-of-way, \$6,347 for public utility easement, \$2,634 for slope easement, and \$19,262 for temporary construction easement

Helenius/Hall Tax Lot 1400: 21215 SW 105th Ave

- Property is located on the west side of 105th extending to the north side of Blake St and includes a residence, vacant land, and portions of Hedges Creek
- Owners: Betty A. Helenius, Beverly J. Hall, and Larry E. Helenius
- The City is purchasing public right-of-way (1,051 sq ft), public utility easement (10,372 sq ft), slope easement (7,252 sq ft), and stormwater easement (7,236 sq ft).
- **Acquisition amount \$63,292**, which includes \$8,408 for right-of-way, \$8,298 for public utility easement, \$5,222 for slope easement, and \$41,364 for stormwater easement.

Thomson Property; 10630 SW Blake St

- Property is located on the south side of Blake St and includes a residence
- Owners: Robert Kevin Thomson and Tana M. Thomson
- The City is purchasing public utility easement (360 sq ft), and temporary construction easement (3,477 sq ft).
- **Acquisition amount \$1,410**, which includes \$576 for 360 sq ft public utility easement and \$834 for temporary construction easement.

OUTCOMES OF DECISION:

Approval of the attached resolution would allow staff to purchase right-of-way and easements for the Garden Corner Curves project.

ALTERNATIVES TO RECOMMENDATION:

Council could elect to not approve the attached resolution, which would make the project unconstructible in its current configuration.

FINANCIAL IMPLICATIONS:

The total cost of property and easement acquisition is \$177,402. This is included in the total project budget in the Transportation Project Fund (Tualatin Moving Forward bond program).

EXECUTIVE SUMMARY:

This quarterly update will provide you with a summary of construction projects planned for this summer, a summary of on-going design and planning work, an update on the overall program schedule and budget, updates on priority projects, and information about upcoming work.

In May 2018, Tualatin voters approved a \$20 million bond measure to pay for projects that improve traffic flow, neighborhood safety, and provide safe access to schools and parks citywide. Five projects are already built, nine will be constructed this summer, and five more are in planning and design. The Tualatin Moving Forward Bond Team is committed to providing the City Council with quarterly updates in alignment with the agreed-upon communication goals to:

- Be fully transparent and commit to communicating at every stage;
- Continue to engage the community in the designing and planning the projects;
- Use multiple channels to communicate with diverse audiences; and
- Demonstrate progress and build confidence with the community using score cards, quarterly reports, project signage, and other tools.

Current activity on the program

Despite COVID-19 disruptions, the bond team is not slowing down. We are meeting virtually using Zoom and other virtual meeting platforms, we are continuing to finalize plans for construction this summer, and we are designing and planning work for the next wave of construction projects. We are also developing outreach plans for each project using appropriate tools that help everyone stay safe and allow us to get much needed public input on the projects.

Design, construction, and planning work

This summer we will start constructing nine projects listed below. You can see project descriptions for each on the program website: www.tualatinmovingforward.com.

- Garden Corner Curves
- Boones Ferry at Tualatin High School
- Grahams Ferry at Dogwood Street
- Mohawk: East of Martinazzi at PGE
- 90th and Sweek Drive
- Borland Rd: Bridgeport Elementary to 60th
- Martinazzi: Avery to Dakota
- Tualatin Road and 112th
- Nasoma Lane: Near Marquis

We are also continuing to work on design and planning for five projects. Descriptions and maps for these projects are also available on the Tualatin Moving Forward website.

- Martinazzi and Sagert Street
- Tualatin-Sherwood Road: Martinazzi to I-5
- Highway 99W: Pony Ridge to 124th Avenue
- 95th Avenue and Avery Street
- Nyberg Lane: 50th to 65th Avenue

And we are starting design on two more projects and soliciting project suggestions for the Neighborhood Traffic Safety program.

- Boones Ferry Road: Warm Springs to south City limits
- 65th Avenue at the Hospital
- The next round of Neighborhood Traffic Safety Projects

And, the third page shows projects planned for the coming years. This schedule/budget summary document will continue to evolve as we complete projects, move projects from our future list to our current list, and add projects to the program for the Neighborhood Traffic Safety Program.

We are still projected to finish the bond program within the total budget of \$20-million and we are expecting to complete the program in 2023.

Updated program report card

Exhibit B is the Program Report Card that we have shared with you at each quarterly update. The report card shows how we are doing – what we are working on and how much each project is estimated to cost at the nearest milestone. Once we receive bids from contractors, we will update the report card to reflect the actual bid amount for each project.

The report card and other internal tools help us make sure we are staying on track with our project budgets so we can stay within budget through the end of the program. As we notice trends or identify potential issues, we can course correct early to deliver the program we promised for the budget we have available.

A RESOLUTION SUPPORTING THE WASHINGTON COUNTY PUBLIC SAFETY LEVY, BALLOT MEASURE 34-296

FINDINGS: The Washington County Public Safety Levy was created in 2000 to serve all the residents of Washington County with sheriff's patrol public safety services, including special enforcement teams, prosecutors, juvenile councilors, probation and parole services, emergency shelters for the homeless victims of domestic violence, and mental health response teams. This is a replacement levy that includes a five-cent increase over the current rate. This is the first rate increase since voters initially approved the levy in 2000.

WHEREAS, this levy includes funding for emergency shelter and services for women and children of domestic abuse and violence, and victims' assistance programs for victims of other crimes;

WHEREAS, this levy includes funding for mental health response teams that pair a deputy and a mental health clinician together to be sure people in a mental health crisis get medical assistance, often instead of being taken to jail;

WHEREAS, this levy includes funding for prevention programs that helped reduce juvenile crime over the past ten years, even as our population has grown in Washington County;

WHEREAS, this levy includes funding for operation of the jail and work release center at full capacity to minimize early release of offenders due to overcrowding; and

WHEREAS, this levy includes funding for interagency enforcement teams (Major Crimes, Narcotics and Tactical Negotiations) that serve every part of Washington County, including the cities.
