WHEREAS, the CDBG Program provides annual funding and flexibility to local communities to provide decent, safe, and sanitary housing, a suitable living environment, and economic opportunities to low-and moderate-income people; and

WHEREAS, the HOME Investment Partnerships Program provides funding to local communities to create decent, safe, affordable housing opportunities for low-income persons. Nationally, over one million units of affordable housing have been completed using HOME funds; and

WHEREAS, over the programs' history, our community has received a total of \$1,810,617 in Community Development Block Grant funds.

Proclamation

Declaring April 2022 as Parkinson's Awareness Month in the City of Tualatin

WHEREAS, Parkinson's disease is a chronic, progressive, neurological disease and is the second most common neurodegenerative disease in the United States; and

WHEREAS, Parkinson's disease is estimated to affect approximately one million people in the United States and the prevalence will more than double by 2040; and

WHEREAS, it is estimated that the economic burden of Parkinson's disease is at least \$14.4 billion annually, including indirect costs to patients and family members of \$6.3 billion; and

WHEREAS, research suggests the cause of Parkinson's disease is a combination of genetic and environmental factors, but the exact cause and progression of the disease is still unknown; and

WHEREAS, there is no objective test or biomarker for Parkinson's disease, and there is no cure or drug to slow or halt the progression of the disease; and

WHEREAS, the symptoms of Parkinson's disease vary from person to person and can include tremors; slowness of movement and rigidity; difficulty with balance, swallowing, chewing, and speaking; cognitive impairment and dementia; mood disorders; and a variety of other non-motor symptoms; and

WHEREAS, volunteers, researchers, caregivers, and medical professionals are working to improve the quality of life of persons living with Parkinson's disease and their families; and

WHEREAS, increased research, education, and community support services such as those provided by the Parkinson's Foundation and other organizations are needed to find more effective treatments and to provide access to quality care to those living with the disease today.

NOW, THEREFORE, BE IT PROCLAIMED BY THE CITY COUNCIL OF THE CITY OF TUALATIN, Oregon that April 2022 is Parkinson's Awareness Month in the City of Tualatin.

OFFICIAL MINUTES OF THE TUALATIN CITY COUNCIL WORK SESSION MEETING FOR FEBRUARY 28, 2022

Present: Mayor Frank Bubenik, Council President Nancy Grimes, Councilor Bridget Brooks, Councilor Valerie Pratt, Councilor Cyndy Hillier, Councilor Christen Sacco

Absent: Councilor Maria Reyes

Mayor Bubenik called the meeting to order at 5:00 p.m.

1. I-205 Tolling Project Update.

ODOT Staff Garet Prior, Heather Wills, and Chris Wellander presented an update on the I-205 Tolling Project. Mr. Prior shared a video with information on the tolling project. Mrs. Willis shared the urban mobility strategy map. She shared project scheduling stating they are currently in the environmental review process and noted the soonest tolling could begin would be 2024. Mrs. Willis explained why I-205 tolling will be starting before the regional congestion pricing noting it will serve as proof of concept for federal review and tolling is needed to complete the improvements for the project. Mr. Wellander stated they are studying topic areas such as travel time, diversion, safety, freight and sound, climate and air quality, and equity populations. He shared the local intersection analysis that studied 50 local intersections with three being in Tualatin. Mr. Wellander stated next steps will be to work with local communities to identify where mitigation is needed to address local impacts. Mr. Prior spoke to studies being done on the impact to accessibility on locations such as schools, nursing homes, medical facilities, and parks and green spaces. Mr. Prior spoke to how programs are being evaluated that will address impacts to low income, older adults, limited English speaking, and racial and/or ethnic minorities.

Councilor Pratt stated she is glad to see ODOT addressing impacts to low-income and older adults. She asked why the models show such little affect in 2045 on the outer streets. Mr. Wellander stated it is due to rerouting and the time of day. Councilor Pratt stated it would be helpful to see the results of the study showing the impacts to diversion in 2027. She stated she would like to see the 65th and Borland intersection studied as diversion will be heavy there and mitigation will need to happen. She asked if any of the tolling dollars could be used to help fund the mitigation project. Mr. Prior stated distribution of tolling funds is still yet to be determined by ODOT.

Councilor Pratt asked why the \$400 million in federal and state funds have not been used to complete the corridor. Mr. Prior stated funds were shifted because it was determined that there are higher needs in other portions of the state requiring funding.

Councilor Brooks asked why the study map does not included the Wilsonville exits that impact Borland Road. Mr. Prior stated different studies include different footprints, he stated that specific map excluding those exits looked at traffic flow regionally.

Councilor Brooks asked about individual pricing and the impacts to people who live here. She expressed concerns with people paying taxes and then again paying tolls on top of that.

Councilor Brooks asked if the tolling project is tied to the Abernathy Bridge and the delays in the area and why Rose Quarter funds cannot be used to fund that. Mr. Prior stated the Rose Quarter dollars are not flexible within ODOT as there is legislation that has assigned those funds.

Council President Grimes asked if a map was done on the transportation analysis for I-5. Mr. Wellander stated one was done as part of the regional model and one was specially done in regards to freight movement.

Council President Grimes expressed concerns with the Borland and Stafford Intersection. Mr. Wellander stated that intersection is included in the study. He stated all the intersections in the area along Stafford Road are being studied.

Council President Grimes asked about how the trip numbers were generated. Mr. Wellander stated it is a computer model. Council President Grimes stated she would like to see actual trip counts instead of a generalized model. Mr. Wellander noted the model is calibrated using actual trip counts.

Council President Grimes expressed concerns with the tolling area being fixed in perpetuity even after the projects are completed. She does not feel right about citizens being responsible for funding transportation projects in the future that are unrelated to the area. Mr. Prior stated HB 2017 outlined projects that would be funded from the legislature with the other major funding source from tolling. He stated investment dollars from tolling will remain in the corridor.

Councilor Sacco expressed concerns with the tolling impacts on businesses and addressing impacts to intersections. She stated she has concerns with the Oregon City and Sellwood bridges and the impacts to them.

Councilor Hillier asked how the work from the accessibility report will impact the environmental reports. She asked how success will be measured. Mr. Prior stated in June reports will be available that address impacts to equity.

Mayor Bubenik wants to make sure the study is done to mitigate diversion in the area. He wants to make sure the projects are prioritized and done appropriately.

2. Prosperity Planning - The Core Opportunity and Reinvestment Area.

Economic Development Manager Jonathan Taylor and Consultant Elaine Howard presented on prosperity planning for Tualatin. Manager Taylor stated prosperity planning has been a multi-year endeavor to securely position the community for long-term economic prosperity. He stated community growth and development constraints has created long-term challenges for the community's prosperity. The availability of developable land and transportation infrastructure is limited or severely restricted. Manager Taylor stated the purpose of this is to utilize a variety of financing tools to meet community needs in alignment with the broader community vision. Consultant Howard explained the background on the project including the Economic Opportunity Analysis from 2018 and the Urban Renewal District Feasibility Studies completed in 2020. She spoke to projects in the Leveton Tax Increment District and the Basalt Creek Development Area. Consultant Howard spoke to the Core Opportunity Reinvestment Area stating several strategic plans have been done that impacted the area. She highlighted different redevelopment areas including the Tualatin Commons, Bridgeport Village, Nyberg Woods, the WES Commuter Rail, and Nyberg Rivers. Consultant Howard stated the vision for the Core Opportunity and

Reinvestment Area Plan will be to establish and fund projects to create an active civic core; redevelop areas with vibrant high-quality mixed-use developments offering a variety of additional residential dwelling and retail options; increase opportunities for living wage professional and creative employment; promote and develop recreational and cultural facilities; and integrate all efforts into the natural landscape with environmental stewardship. Manager Taylor stated values for the area will be to create more housing, leave no existing businesses behind, enhance connectivity, promote identity, and maintain and grow existing employment lands. He stated priorities include small business assistance, land acquisitions, housing, developer assistance, community identity, environmental stewardship, blight remediation, and transportation. Consultant Howard stated a survey will be sent to the Council to rank and give input on the priorities. Manager Taylor proposed a working group of ten participants that will provide feedback on existing conditions, visions, values, and objectives, provide feedback on proposed boundaries and projects, identify and recommend additional projects, and review the financial analysis and impacts. Consultant Howard presented the proposed timeline with potential adoption being in November 2022.

Consultant Howard asked if the vision is on track. Council consensus was reached that the vision incorporates prior feedback and is on track.

Consultant Howard asked if the plans values and priorities are still consistent with the vision for the area.

Councilor Pratt asked for clarification on "leaving no business behind." Manager Taylor stated it is framed that way as concerns were presented around business displacement.

Councilor Brooks stated she is glad to see environmental stewardship included in the plan.

Councilor Sacco wants to make sure equity is highlighted as a priority.

Consultant Howard asked if the Council agrees with the proposed working group template.

Councilor Pratt would like to see the Core Area Parking District businesses be included as part of the group.

Councilor Brooks like to see residents of the buildings and owners included as well as Arts Advisory Committee members.

Councilor Hillier suggested having youth represented on the committee.

Mayor Bubenik would like to see CIO members included as part of the group.

Councilor Pratt asked who will select the committee members. Manager Taylor stated staff members will select candidates and bring the recommendations back to the council on March 28.

Council President Grimes stated she would like to hold the council member seat on the committee.

3. Council Meeting Agenda Review, Communications & Roundtable.

Mayor Bubenik asked if there is Council consensus on announcing April as Parkinson's Awareness Month. Council consensus was reached and a proclamation will be placed on a future Council agenda.

Mayor Bubenik shared a proposed proclamation supporting Ukraine. Council consensus was reached to add the proclamation to the agenda tonight.

Councilor Pratt stated she attended the C4 meeting, the Core Area Parking District Board meeting, met with Washington County Chair Harrington and Clean Water Services regarding the Basalt Creek extension, and the Tualatin Climate Action Steering Committee meeting.

Councilor Sacco stated she attended the I-205 tolling meeting.

Councilor Brooks stated she attended the Tualatin Arts Advisory Committee meeting, the Basalt Creek meeting with County Chair Harrington, and the Climate Action Planning meeting.

Mayor Bubenik stated he attended the GPI meeting, the Chamber of Commerce Board meeting, the Greater Portland Economic Development District meeting, the Westside Economic Alliance meeting, the Metro Mayors Consortium meeting, and the Small Cities Consortium meeting.

Special Reports

1. Update on Diversity Equity & Inclusion Efforts in the City of Tualatin Organization

Human Resources Director Stacy Ruthrauff and TsaiComms Consultants Trudy Flores and Lillian Tsai presented an update on the Diversity, Equity, Inclusion, & Belonging (DEIB) Status Report. Consultant Tsai gave an overview of the work to date including the organizational assessment that showed a strong appreciation for leadership's commitment to DEI, employees feeling included and respected, an appreciation for the mission of serving the community, and concerns around action on equity concerns. She noted some innovated programs and proactive conversations have already began and there has been a good start on DEI trainings and engagement, but there needs to be a more strategic training approach focusing on closing gaps and implementing an actionable strategy. Consultant Flores stated themes and findings about the State of DEIB include leadership and communication, policies and practices, disparities and bias, and professional development. Consultant Tsai stated short term next steps include development and communication of a DEI Strategic Action Plan, creation of an equity lens decision-making process, consideration of employee resource groups, and additional trainings. She stated long term recommendations are to ensure staff understands the DEI vision, embed DEI into strategic planning, communicate DEI commitment, instill "shared accountability", embed DEI into employee lifecycle policies and practices, develop mindful DEI leadership, review polices and processes with an equity lens, and strategically support DEI through external relationships. Consultant Tsai stated the city is currently in phase II which focuses on the DEI Strategic Action Plan. She stated a DEI Action plan core team was formed and they have drafted a DEI vision and mission statement and are working towards a draft Strategic Action Plan.

Councilor Brooks thanked them for their work as the Council is very invested in this work.

General Business

PUBLIC COMMENT

Alisa Wilson-Coleman spoke in opposition of the plan map amendment. She asked about the notion of affordable housing in relation to the 2040 plan. She expressed concerns with the amount of affordable housing in the rezone.

COUNCIL DISCUSSION

Council President Grimes stated the proposal needs to meet the intent and approval of the code. She stated the applicant is supposed to explain how they comply with the approval criteria and they have come up short in doing that. She would like to see more detail on how the amendment

is in the public interest besides increases the housing stock, how the public interest is best protected, its consistency with enhancing characteristics of the city, suitability for land use in the area, the effects on property values, and the public need for safe surroundings and conditions. She believes looking into another area for density increases would better serve the community.

Councilor Brooks spoke to property value and stated the rezone of this unit would not likely disproportionately affect property values in the area. She noted this is a specific code change and the public good will be met with this as it offers an opportunity for additional housing that is needed in the community.

Councilor Pratt stated the city is obligated to deal with the concerns that were heard during the hearing the best we can.

Council President Grimes stated she doesn't feel this fits the affordable housing market based on the current rates. She stated the applicant has fell short in explaining how they will comply with the approval criteria.

Mayor Bubenik stated Republic Services has been out to the sight to re-evaluate garbage service at the site and they will be modifying their collection pickup. He stated the applicant will still have to go through the Architectural Review process and meet all applicable criteria at that level.

Council President Grimes shared sentiments of her connection to Ukraine.

Councilor Sacco reminded citizens to complete the parks and recreation survey.

RECOMMENDATION:

EXECUTIVE SUMMARY:

Resolution No. 5606-22 authorizes the City Manager to execute legal documents to grant Washington County right-of-way and easements needed to construct and maintain the utilities associated with the Tualatin-Sherwood Road Widening Project. Right-of-way and easements were proposed on the City's water quality tract located at 20663 SW 115th Avenue (See Exhibit 1). This tract of land, approximately 0.54 acres, was dedicated to the City as part of the Tualatin-Sherwood Corporate Center Development in 2003, to manage stormwater runoff from City right-of-way. The City's stormwater operations will not be impacted by the utilities or granting of these easements and right-of-way along the site's frontage.

Washington County is designing a project to widen Tualatin-Sherwood Road from SW Teton Avenue to SW Langer Farms Parkway in the City of Sherwood. This project is planned to include two travel lanes in each direction, a center turn lane, storm drainage, planter strips, and a path for walking and cycling on each side.

In order to have space for construction, and access for future maintenance of the utilities, the County needs to acquire two (2) easements, and right-of-way as follows:

City of Tualatin (Tax Lot 2S127BD00500)

- Property includes a City owned water quality tract located at 20663 SW 115th Avenue. The
 City's stormwater operations will not be impacted by the granting of these easements and
 right-of-way along the site's frontage.
- The County is requesting a Permanent Slope Easement (1,074 sq. ft.), a Permanent Slope and Drainage Easement (1,050 sq. ft.), and Right-Of-Way (189 sq. ft.)



RECOMMENDATION:

Staff recommends the Council adopt the resolution.

EXECUTIVE SUMMARY:

The Washington County Board of Commissioners established the Major Streets Transportation Improvement Program Phase 3e (MSTIP 3e) Funding Program, which identified twenty-three (23) multi-modal transportation projects. The MSTIP 3e Funding Program includes capacity enhancements on SW Tualatin Sherwood Road between SW Teton Avenue and SW Langer Farms Parkway (Project 318).

Washington County designed the project to widen Tualatin-Sherwood Road from SW Teton Avenue to SW Langer Farms Parkway. This project is planned to include two travel lanes in each direction, a center turn lane, storm drainage, planter strips, and a path for walking and cycling on each side.

The City has existing water and sewer pipes, valves, and other utility facilities in and under Tualatin-Sherwood Road that will need to be relocated to accommodate this road widening. Per existing Intergovernmental Agreements, this utility relocation is the City's responsibility.

Staff contracted AKS Engineering & Forestry LLC, a local firm on the City's Professional Services Qualified Pool List of consultants, to design this utility relocation. Construction of the designed utility relocations will be included in the County's road construction contract to be bid in March 2022.

The Intergovernmental Agreement for consideration identifies estimated City costs for construction of \$883,029 to be reimbursed to the County on a quarterly basis as construction proceeds. Construction costs will be updated following the County's construction contract award. The Intergovernmental Agreement also defines County costs associated with the project including easement acquisition at the City's A2 water storage reservoir site as described in Exhibit B and

City permit costs. County costs will be paid to the City in the form of a \$34,201.42 credit on the cost of construction.

This work is eligible for Transportation Development Tax funding as relocating utilities to accommodate road construction.

FINANCIAL IMPLICATIONS:

The City's share of the proposed project cost is \$848,827.58 upon receipt of the County's credit for City permit and easement costs as described in the executive summary of this report and shown in the attached exhibits.

RESOLUTION NO. 5599-22

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH WASHINGTON COUNTY FOR THE TUALATIN-SHERWOOD ROAD WIDENING PROJECT.

WHEREAS, the City of Tualatin is an Oregon municipal corporation;

WHEREAS, Washington County is a political subdivision of the State of Oregon;

WHEREAS, ORS 190.010 authorizes the City and County to enter into an intergovernmental agreement;

WHEREAS, the County designed a project to widen Tualatin-Sherwood Road from SW Teton Avenue to SW Langer Farms Parkway in the City of Sherwood. This project is planned to include two travel lanes in each direction, a center turn lane, storm drainage, planter strips, and a path for walking and cycling on each side;

WHEREAS, the City has existing water and sewer pipes, valves, and other facilities in and under Tualatin-Sherwood Road that will need to be relocated to accommodate this road widening. Per existing Intergovernmental Agreements, this relocation is the City's responsibility; and

WHEREAS, it is the mutual desire of the City and County to enter into an Intergovernmental Agreement to cooperate in construction of the Tualatin-Sherwood Road Widening Project.

WHEREAS, the City finds it necessary and desirable for the continued growth, safety and welfare of the community that the aforementioned transportation project is constructed.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TUALATIN, OREGON, that:

Section 1. The City Manager is authorized to execute an Intergovernmental Agreement with Washington County for the Tualatin-Sherwood Road Widening Project, which is attached as Exhibit 1, and incorporated by reference.

Section 2. The City Manager is authorized to make administrative modifications to the Intergovernmental Agreement to fully implement its intent.

Section 3. This resolution is effective upon adoption.

INTERGOVERNMENTAL AGREEMENT BETWEEN WASHINGTON COUNTY AND THE CITY OF TUALATIN

FOR PUBLIC UTILITY IMPROVEMENTS ON SW TUALATIN SHERWOOD ROAD

THIS INTERGOVERNMENTAL AGREEMENT is entered into between Washington County, a political subdivision of the State of Oregon, acting by and through its elected officials, hereinafter referred to as "COUNTY"; and the City of Tualatin, a municipal corporation, acting by and through its City Council, hereinafter referred to as "CITY."

RECITALS

- 1. WHEREAS, ORS 190.010 authorizes agencies to enter into intergovernmental agreements for the performance of any or all functions and activities that a party to the agreement has the authority to perform; and
- 2. WHEREAS, on October 4, 2016 the Washington County Board of Commissioners approved Resolution and Order No. 16-129 establishing the MSTIP 3e Funding Program, which identified twenty-three (23) multi-modal transportation improvement projects on County facilities; and
- 3. WHEREAS, the MSTIP 3e Funding Program includes capacity enhancements on SW Tualatin Sherwood Road, specifically SW Tualatin Sherwood Road between SW Teton Avenue and SW Langer Farms Parkway (Project 318); and
- 4. WHEREAS, CITY, consistent with the powers and purposes of city government, finds it necessary and desirable for the continued growth, safety and welfare of the community that the aforementioned transportation project will be constructed as soon as practicable; and
- 5. WHEREAS, the CITY agrees to relocate waterline and sanitary sewer utilities to accommodate the COUNTY's transportation improvements, and agrees to pay for such requested work; and
- 6. WHEREAS, the CITY and COUNTY have agreed to cooperate in the relocation and construction of the CITY's waterline and sanitary sewer improvements and combine the CITY'S waterline and sanitary sewer improvements into a single construction project with the COUNTY's transportation improvements to reduce construction costs and the impacts of construction on the public by reducing the number of road closures and detours needed to accomplish the work identified and by reducing the duration of construction activities; and
- 7. WHEREAS, under such authority, it is the mutual desire of the COUNTY and CITY to enter into this Intergovernmental Agreement to cooperate in relocation and construction of the CITY'S waterline and sanitary sewer improvements, and to allocate responsibilities as detailed below:

AGREEMENT

NOW THEREFORE, the premise being in general as stated in the foregoing recitals, and in consideration of the terms, conditions and covenants as set forth below, the parties hereto agree as follows:

1. PROJECT DESCRIPTION

- 1.1 The COUNTY SW Tualatin Sherwood Road project (Project 318) will include: design and construction of improvements including road widening, curbs, sidewalks, bike lanes, street lighting, drainage, landscaping, traffic control, water quality improvements, and all necessary permitting on SW Tualatin Sherwood Road between SW Teton Avenue and SW Langer Farms Parkway, hereinafter referred to as "COUNTY PROJECT".
- 1.2 The CITY SW Tualatin Sherwood Road waterline project will include adjustment and relocation of existing water meters, and fire hydrants, and adjustment of blow-offs, valve lids, and other water infrastructure work to accommodate the road project. All these proposed improvements are located along SW Tualatin Sherwood Road, hereinafter referred to as "WATERLINE PROJECT".
- 1.3 The CITY SW Tualatin-Sherwood Road sanitary sewer project will include adjustment and relocation of manholes, cleanouts, and other sanitary sewer infrastructure work to accommodate the road project. This work is hereinafter referred to as "SANITARY SEWER PROJECT".
- 1.4 The CITY WATERLINE PROJECT and SANITARY SEWER PROJECT will collectively be referred to as CITY PROJECTS.

2. COUNTY OBLIGATIONS

- 2.1 COUNTY hereby designates Matt Meier as COUNTY Project Manager for the COUNTY PROJECT and the COUNTY representative responsible for coordination of the CITY PROJECTS with CITY pursuant to this Agreement.
- 2.2 COUNTY shall perform, or cause to be performed, all actions necessary for the design and construction of the COUNTY PROJECT, including project management, design and construction engineering, property acquisition, including right-of-way as necessary, utility relocation as necessary, regulatory and land use permits and approvals, public information related to the roadway design and construction, contract administration, inspection and construction management. COUNTY shall coordinate the design of, advertise for, award and administer the construction contract for the COUNTY PROJECT.
- 2.3 Subject to CITY obligations set forth in Article 3, Terms 3.1 3.11, COUNTY shall:

- 2.3.1 perform, or cause to be performed, all actions necessary for the construction of the CITY PROJECTS as part of the COUNTY PROJECT as described in Term 2.2 and
- 2.3.2 bid, construct and manage the CITY PROJECTS as part of the COUNTY PROJECT construction contract, with CITY project costs tracked separately.
- 2.4 COUNTY shall provide CITY three (3) work days following bid opening to review and approve bid results for the CITY PROJECTS. COUNTY may award the construction contract, including work for the CITY PROJECTS, unless CITY informs COUNTY in writing prior to award that it wishes to cancel construction of the CITY PROJECTS as part of the COUNTY PROJECT.
- 2.5 COUNTY shall perform all actions regarding compensation as set forth in Article 4 Compensation.
- 2.6 COUNTY shall not acquire any right-of-way or easements for CITY PROJECTS.
- 2.7 COUNTY shall notify CITY of any request for a change order or other deviation from the costs of the construction contract associated with the CITY PROJECTS ("CITY PROJECTS change order"). COUNTY shall provide CITY five (5) work days following such notification to review and approve any CITY PROJECTS change order request. COUNTY may approve any CITY PROJECTS change order request, unless CITY informs COUNTY in writing prior to the end of the five (5) working day period that it wishes not to agree to the request. In the event the CITY provides notice that it does not approve a CITY PROJECTS change order within the applicable time, the CITY shall be responsible for all costs, including future change orders, redesign or delay claims that are a result of the CITY's non-approval.

3. CITY OBLIGATIONS

- 3.1 CITY hereby designates Heidi Springer as CITY Project Manager for the CITY PROJECTS and the CITY representative responsible for coordination of the CITY PROJECTS with COUNTY pursuant to this Agreement.
- 3.2 CITY shall provide timely comments to COUNTY construction documents including construction plan sheets, specifications, and bid schedule for the CITY PROJECTS. Unless the CITY notifies the COUNTY as provided in Term 2.4, the CITY PROJECTS bid items shall be incorporated into the overall COUNTY PROJECT Bid Schedule.
- 3.3 CITY shall provide timely responses to bidder's questions about CITY PROJECTS during advertisement of the COUNTY PROJECT. If necessary, CITY shall provide COUNTY with addendum no later than four (4) calendar days

- prior to the bid opening if the question comes to the CITY no later than five calendar days prior to the bid opening.
- 3.4 CITY shall provide inspection of the CITY PROJECTS bid items including review and approval of shop drawings, submittals, and onsite inspections to determine compliance with the contract documents. CITY's onsite inspector shall be onsite as appropriate and responsible for enforcing all applicable CITY PROJECTS specifications during all CITY PROJECTS work. CITY's onsite inspections of the CITY PROJECTS bid items, including required night work inspections, shall be coordinated through COUNTY's lead inspector. If the COUNTY notifies CITY that CITY inspection is required but CITY inspection does not timely occur, COUNTY may proceed with PROJECT work in accordance with the PROJECT schedule and shall have no liability to CITY related to the lack of CITY inspection. CITY must approve the final acceptance of the CITY PROJECTS prior to top lift paving.
- 3.5 CITY shall assist the COUNTY lead inspector with the following construction documentation for the CITY PROJECTS bid items:
 - General daily progress reports and erosion control reports,
 - Quantity documentation used for monthly estimates, and
 - Quality documentation and test results as specified in the construction contract.
 - Change orders and extra work directives
- 3.6 CITY shall cooperate, coordinate and financially participate with COUNTY on any disagreements, disputes, delays or claims related to or as a result of the CITY PROJECTS.
- 3.7 CITY shall perform all actions regarding compensation as set forth in Article 4-Compensation.
- 3.8 CITY shall perform all necessary public involvement and notifications for water service shutdowns resulting from the CITY PROJECTS work. CITY shall assign a 24-hr emergency contact for the duration of the CITY PROJECTS construction.
- 3.9 CITY shall perform all necessary plan review and construction inspection tasks required for COUNTY PROJECT work permitted under CITY Public Works Permit, CITY Water Quality Permit, and CITY Erosion Control Permit.
- 3.10 CITY shall be responsible to obtain all necessary permits and pay all permit fees for CITY PROJECTS.
- 3.11 CITY shall grant the necessary easements as described in the separate Dedication Deeds in Exhibit B (File 32 and File 50).

3.12 CITY shall issue CITY Public Works Permit, CITY Water Quality Permit, and CITY Erosion Control Permit within 14 calendar days of payment from COUNTY as provided in Term 4.1.2.

4. COMPENSATION

- 4.1 COUNTY PROJECT
 - 4.1.1 COUNTY shall be responsible for all costs to design and construct the COUNTY PROJECT as described in Term 2.2.
 - 4.1.2 COUNTY shall pay CITY for the following COUNTY PROJECT permit fees:

i.	Public Works Permit	\$7,500
ii.	Water Quality Permit	\$7,500
iii.	Erosion Control Permit	\$11,545

The Public Works Permit fee covers all CITY costs for plan review, inspection, and materials testing of COUNTY PROJECT work within CITY right-of-way.

The Water Quality Permit fee covers all CITY costs for plan review inspection, and materials testing of COUNTY PROJECT work within CITY stormwater facility jurisdictional limits.

The Erosion Control Permit fee covers all CITY costs for plan review and inspection of COUNTY PROJECT erosion control work within CITY jurisdictional limits.

4.1.3 COUNTY shall pay CITY for necessary easements described in Exhibit B to construct COUNTY PROJECT as follows:

4.2 CITY PROJECTS

4.2.1 The CITY shall pay an estimated total of \$883,029.00 for the cost of construction of the WATERLINE PROJECT and SANITARY SEWER PROJECT, as described in Section 1.2 and Section 1.3. Specific WATERLINE PROJECT and SANITARY SEWER PROJECT costs are shown in Exhibit A and are estimated as follows:

Items ii and iii shall be calculated as a lump sum calculation on the actual costs to the COUNTY after COUNTY makes final payment to the construction contractor for the CITY PROJECTS.

- 4.2.2 CITY and COUNTY understand that the costs outlined above are estimates and are used to determine project budgets and estimated payments amount used within this Agreement. Final costs will be based on the actual contract amount realized. Final payments made by the CITY to the COUNTY for the CITY PROJECTS shall be based on actual bid prices, construction quantities and non-construction costs.
- 4.2.3 In the event the CITY and COUNTY agree to design and construction changes that will eliminate or reduce the scope and extent of the CITY PROJECTS, the CITY will pay for COUNTY's cost for re-design and/or construction change orders.
- 4.2.4 Within sixty (60) days of execution of the COUNTY construction contract, CITY shall deposit with the COUNTY the sum of \$180,000.00. COUNTY shall send CITY quarterly statements during project construction indicating the itemized amount incurred for the CITY PROJECTS and the amount due. Quarterly statements will not be sent to the CITY if no CITY PROJECTS work is performed. Upon depletion of the \$180,000 deposited under this section, the quarterly statement shall include the itemized amount due from CITY for the CITY PROJECTS work. CITY shall pay COUNTY the amount due within thirty (30) days of its receipt of this billing. Any CITY deposited funds remaining upon completion of the CITY PROJECTS, shall be refunded to the CITY within sixty (60) days.

5. GENERAL PROVISIONS

5.1 LAWS OF OREGON

The parties shall comply with all applicable laws and regulations regarding the handling and expenditure of public funds. This Agreement shall be construed and enforced in accordance with the laws of the State of Oregon.

5.2 DEFAULT

Time is of essence in the performance of the Agreement. Either party shall be deemed to be in default if it fails to comply with any provisions of this Agreement. The non-defaulting party shall provide the other party with written notice of default and allow thirty (30) days within which to cure the defect.

5.3 INDEMNIFICATION

This Agreement is for the benefit of the parties only. Each party agrees to indemnify and hold harmless the other party, and its officers, employees, and agents, from and against all claims, demands and causes of actions and suits of any kind or nature for personal injury, death or damage to property on account of or arising out of services performed, the omissions of services or in any way resulting from the negligent or wrongful acts or omissions of the indemnifying party and its officers, employees and agents. To the extent applicable, the above indemnification is subject to and shall not exceed the limits of liability of the Oregon Tort Claims Act (ORS 30.260 through 30.300). In addition, each party shall be solely responsible for any contract claims, delay damages or similar items arising from or caused by the action or inaction of the party under this Agreement.

5.4 MODIFICATION OF AGREEMENT

No waiver, consent, modification or change of terms of this Agreement shall be binding unless in writing and signed by both parties.

5.5 DISPUTE RESOLUTION

The parties shall attempt to informally resolve any dispute concerning any party's performance or decisions under this Agreement, or regarding the terms, conditions or meaning of this Agreement. A neutral third party may be used if the parties agree to facilitate these negotiations. In the event of an impasse in the resolution of any dispute, the issue shall be submitted to the governing bodies of both parties for a recommendation or resolution.

5.6 REMEDIES

Subject to the provisions in paragraph 5.5, any party may institute legal action to cure, correct or remedy any default, to enforce any covenant or agreement herein, or to enjoin any threatened or attempted violation of this Agreement. All legal actions shall be initiated in Washington County Circuit Court. The parties, by signature of their authorized representatives below, consent to the personal jurisdiction of that court.

5.7 EXCUSED PERFORMANCE

In addition to the specific provisions of this Agreement, performance by any party shall not be in default where delays or default is due to war, insurrection, strikes, walkouts, riots, floods, drought, earthquakes, fires, casualties, acts of God, governmental restrictions imposed or mandated by governmental entities other than the parties, enactment of conflicting state or federal laws or regulations, new or supplementary environmental regulation, litigation or similar bases for excused performance that are not within the reasonable control to the party to be excused.

5.8 SEVERABILITY

If any one or more of the provisions contained in this Agreement is invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions of the Agreement will not be affected or impaired in any way.

5.9 INTEGRATION

This Agreement is the entire agreement of the parties on its subject and supersedes any prior discussions or agreements regarding the same subject.

6. TERMS OF AGREEMENT

- 6.1 The term of this Agreement shall be from the date of execution until the completion of the COUNTY PROJECT, but not to exceed five (5) years.
- 6.2 This Agreement may be amended or extended for periods of up to one (1) year by mutual consent of the parties. It may be canceled or terminated for any reason by either party. Termination or cancellation shall be effective thirty (30) days after written notice to the other party, or at such time as the parties may otherwise agree. The parties shall, in good faith, agree to such reasonable provisions for winding up the COUNTY PROJECT and CITY PROJECTS and paying for any additional costs as necessary.

Consideration of Resolution No. 5605-22, Authorizing the City Manager to Execute Deeds Acquiring Easements for the SW 65th / Nyberg Sanitary Sewer Trunk Main Rehabilitation Project

RECOMMENDATION:

Staff recommends the Council adopt the resolution.

EXECUTIVE SUMMARY:

Resolution No. 5605-22 authorizes the City Manager to execute legal documents to acquire the easements needed to construct and maintain the SW 65th / Nyberg Sanitary Sewer Trunk Main Rehabilitation Project.

The majority of the project is to be constructed within existing easements. However, in order to have space for construction, and access for future maintenance of the project, the City must acquire easements from private property owners surrounding the project area.

In 2011 the City experienced a Sanitary Sewer Overflow in the Nyberg wetlands due to a blockage in this sewer line. Investigation revealed that a structural defect allowed a tree root to penetrate the line and collect F.O.G (fats-oil-and grease), resulting in the blockage. As a result, the City's Sewer Division has been monitoring and maintaining this section every 6-months. Since the monitoring began, City staff has identified three separate issues with this section of sewer line. A depression in the sewer line, tree root intrusion, and stormwater erosion that has exposed a portion of the sanitary line and an adjacent manhole. The proposed easements allow permanent repair and maintenance of approximately 800 lineal feet of aging/damaged 18-inch diameter concrete sanitary sewer trunk main.

Easements were proposed on four properties. Three of the property acquisitions were authorized by the Council per Resolution No. 5597-22 on February 14, 2022. The fourth property owner, TMV, LLC, required additional negotiations. TMV, LLC operates a medical clinic and they were concerned with project construction limiting access for sensitive patients. The attached Obligation Agreement outlines the negotiation results. The City's offering price to the fourth property owner, TMV, LLC, was based on an appraisal performed by Oregon Valuation Group and recommendations from Universal Field Services, Inc. as follows:

TMV, LLC (Tax Lot 1000)

- Property includes an existing 20-foot wide sewer easement, parking spaces, and a medical clinic.
- Additional permanent utility easement area is requested to realign, repair, and maintain the sewer line. The City is requesting a temporary construction easement (12,746 square feet (sf)), and permanent utility easement (2,717 sf).
- Acquisition amount \$84,811.

FINANCIAL IMPLICATIONS:

The total acquisition cost is \$84,811. Clean Water Services has agreed to incur all costs associated with this sanitary sewer improvement through an Intergovernmental Agreement executed March 23, 2020.



City and Owner have negotiated and accepted true and actual consideration of \$95,000 minus a credit to the City of Tualatin in the amount of \$10,189 for a total settlement of \$84,811.. The City will be responsible for restoring all areas disturbed to equal or better condition.

Notwithstanding the language in the City's Waterline, Storm Drainage Line, Stormwater, Sanitary Sewer Line, and Access Easement and the Temporary Construction Easement, the City agrees to:

- Impose a "late completion" penalty on the contractor for the portion of this project
 that will affect TMV's parking lot beyond what is needed for bypass pumping. The
 City agrees to reimburse TMV, LLC \$500 per day for time that would exceed the
 agreed timeframe of 6 weeks from the first day on site. The first day on the site is
 defined as the day that the contractor begins construction related activities within
 the parking lot outside of the existing permanent easement.
- Require the contractor to confirm possession and/or immediate availability of all necessary materials prior to breaking ground on the TMV, LLC site.
- Allow contractor to work 7 days per week during the portion of the project that affects TMV, LLC's parking lot.
- No contractor or construction worker parking or equipment storage will take place on site at the TMV, LLC lot outside of the phased construction area and laydown areas shown on the Nyberg Trunk Line Sewer Rehabilitation construction drawings, sheet C011, Site Access and Staging Plan – Tax Lot 1000.
- Make its best effort to minimize impact to the four TMV, LLC parking spaces in the southwest corner of tax lot 1000, due to the need for bypass pumping in the initial phase of construction. TMV, LLC requests the use be reduced from four spots to two or less when possible.

- Make every effort to accommodate deliveries for tenants onsite and allow for continued pickup services.
- Begin the process, with the intent to vacate a portion of the original easement alignment, once the City of Tualatin receives a valid signed copy of the Permanent Utility Easement.

It is understood and agreed that the City of Tualatin's and Grantor's performance of this agreement shall be a portion of the consideration for the concurrent real property transaction evidenced by the Temporary Construction Easement document between the Grantor and the City of Tualatin.

This Agreement, the transactions contemplated, and City of Tualatin's obligations are expressly conditioned upon the formal approval by the City Council of Tualatin, Oregon, by resolution, of the purchase of the Easement and the terms and conditions set forth in this Agreement.


