RECOMMENDATION:

Staff recommends adoption of the attached resolution, which includes the Budget Committee Approved Fiscal Year 2020-2021 Budget, after conducting a public hearing to consider public input.

EXECUTIVE SUMMARY:

The City of Tualatin Budget Advisory Committee approved the proposed budget on May 20, 2020. The total of the Fiscal Year 2020-2021 Budget is \$3,526,685 and is allocated between the Tualatin Development Commission Administration Fund (\$135,295), and the Leveton Tax Increment District Projects Fund (\$3,391,390). Funds will be utilized for expenditures for general operations, an analysis of potential future project areas and capital projects, as identified by the Commission.

Oregon State law requires the Commission to adopt a budget prior to July 1, 2020.

OUTCOMES OF DECISION:

By adopting the budget before July 1st, the Commission will be able to operate, expend money and incur liabilities for fiscal year 2020-2021.

BE IT RESOLVED BY THE TUALATIN DEVELOPMENT COMMISSION, THE RENEWAL AGENCY OF THE CITY OF TUALATIN, OREGON, that:

Section 1. The Board of Commissioners of the Tualatin Development Commission hereby adopts the Budget approved by the Budget Committee for fiscal year 2020-21 in the total sum of \$3,526,685 (including \$1,288,500 in Reserves) now on file at the City Offices.

Section 2. The amounts for the fiscal year beginning July 1, 2020, and for the purposes shown below, are hereby appropriated:

RECOMMENDATION:

Staff recommends adopting the attached resolution.

EXECUTIVE SUMMARY:

Local Budget Law allows for the preparation of a supplemental budget for an occurrence or condition that was not ascertained when preparing the budget. Appropriation of reserve funds may be completed when authorized by a resolution of the Board of Commissioners, after conducting a public hearing.

In January 2020, the Development Commission closed the Central Urban Renewal District and directed staff to transfer the remaining balance in the District to the TDC Administration Fund, to be used for analysis of potential future urban renewal districts. At the time, the analysis was not anticipated to be started until Fiscal Year 2020-2021, so the funds were placed in the TDC Administration Reserve account. Work commenced in Fiscal Year 2019-2020, requiring a portion of the reserve funds to be appropriated in the Materials and Services category in the TDC Administration Fund.

The attached resolution authorizes this appropriation.

FINANCIAL IMPLICATIONS:

The net effect in the TDC Administration Fund is zero.

RESOLUTION NO. 619-20

A RESOLUTION OF THE TUALATIN DEVELOPMENT COMMISSION AUTHORIZING CHANGES TO THE ADOPTED 2019-2020 BUDGET

WHEREAS, an occurrence or condition arose which requires a supplemental budget be prepared to appropriate funds in the adopted FY 2019-2020 budget;

WHEREAS, an occurrence or condition that was not ascertained when preparing the budget requires a change in the adopted FY 2019-2020 budget;

WHEREAS, in order to lawfully comply with the requirements of Local Budget Law, changes to the adopted 2019-2020 budget are necessary;

WHEREAS, Oregon Revised Statutes (ORS) 294.471 allows for the preparation of a supplemental budget.

BE IT RESOLVED BY THE TUALATIN DEVELOPMENT COMMISSION, THE URBAN RENEWAL AGENCY OF THE CITY OF TUALATIN, OREGON, that:

Section 1. The Board of Commissioners wishes to comply with Local Budget Law, and authorize the preparation of a supplemental budget.

Section 2. The purpose of this resolution is to appropriate funds that were transferred from the closure of the Central Urban Renewal District Project Fund in January 2020 and placed into a reserve account in the TDC Administration Fund for analysis of potential future urban renewal districts.

Section 3. Adjustments to the adopted 2019-2020 budget should be made to move \$40,000 from TDC Administration Reserves to TDC Administration Materials and Services, for work completed prior to June 30, 2020.

Section 4. This resolution is effective upon adoption.
