	Staff: Secretary/Chief Examiner Michelle Sutherland, Police Chief Jon Weiks, Fire Chief Brian Hurley, and Assistant Fire Chief Shawn Crimmins.
CHANGES TO AGENDA:	Chief Examiner Sutherland advised of the availability of the Lateral Fire Prevention Officer Eligibility List with candidate names. The list was not included in the agenda packet, as scores had not been computed for the candidates when the packet was released.
APPROVAL OF MINUTES: CIVIL SERVICE COMMISSION MINUTES, MAY 9, 2024:	Chair Tee requested a correction to the March meeting date on page 1 of the minutes to reflect March 21, 2024 rather than March 11, 2024.
MOTION:	Commissioner Chard moved, seconded by Chair Tee, to approve the minutes of May 9, 2024 as amended. A voice vote approved the motion unanimously.
STATUS OF ELIGIBILITY LISTS:	Chief Examiner Sutherland reviewed the status of eligibility lists.
APPROVAL OF ENTRY LEVEL POLICE OFFICER ELIGIBILITY LIST:	Chief Examiner Sutherland reported the list includes 16 candidates, with five candidates added since last month. Three candidates have been removed.
	Chair Tee requested information as to the reason for removal of the three candidates from the list. Chief Examiner Sutherland said one candidate's time on the list had expired and two candidates failed the Chief's interview.
MOTION:	Commissioner Chard moved, seconded by Chair Tee, to approve the Entry Level Police Officer Eligibility List as presented. A voice vote approved the motion.
APPROVAL OF LATERAL FIRE PREVENTION OFFICER ELIGIBILITY LIST:	Chief Examiner Sutherland reported the list was recently finalized with the names of eligible candidates included. One candidate is on the list with an exam score of 89%. The candidate is eligible to remain on the list until June 2025.

	Commissioner Chard asked about the status of candidates previously included on the list. Assistant Fire Chief Crimmins advised that the list, although continuous, was newly created with no other candidates on the list.

APPROVAL OF LATERAL PARAMEDIC FIREFIGHTER ELIGIBILITY LIST:	Chief Examiner Sutherland presented the proposed Lateral Paramedic Firefighter Eligibility List containing four candidates. All candidates are proposed for inclusion on the new continuous list.
MOTION:	Chair Tee moved, seconded by Commissioner Chard, to approve the Lateral Paramedic Firefighter Eligibility List as presented. A voice vote approved the motion.
UPDATES:	Fire Chief Hurley reported a Firefighter Paramedic recently completed the fire academy in North Bend and is working at the department. One Firefighter is scheduled to graduate from the South Sound Recruit Academy in the next several days. His will be joining a fire shift. A Firefighter Paramedic and a Firefighter are undergoing the conditional hiring process. The candidate for the Lateral Fire Prevention Officer position will be scheduled for the Chief's interview next week.
	Police Chief Weiks recognized Police Officer Russ Mize for his 23 years of service to the department. Officer Mize retired last week along with his K-9, James. The department has two police officer vacancies. Three new employees are attending the police academy. A fourth employee successfully completed the second phase of the Field Training Program.
	Chair Tee asked about the status of the candidate for the Commission position vacancy. Chief Examiner Sutherland said the status of the interview of the candidate is dependent upon the Mayor's schedule.

	Chair Simon Tee joined the meeting at 5:34 p.m. A meeting quorum was attained.
APPROVAL OF ENTRY LEVEL POLICE OFFICER ELIGIBILITY LIST:	Chief Examiner Sutherland advised of the recent completion of oral boards for Police Officer candidates. The eligibility list has been updated for May 2024 reflecting fourteen applicants, an addition of four applicants since the April list was established. The request is for approval of the Entry Level Police Officer Eligibility List for May 2024.
MOTION:	Commissioner Chard moved, seconded by Chair Tee, to approve the Entry Level Police Officer Eligibility List for May 2024 as presented. A voice vote approved the motion.

candidates are added after the exam. Dependent upon the candidate's score, the applicant could achieve a score higher than 100 percent.

MOTION: Chair Tee moved, seconded by Commissioner Chard, to approve the Fire Department Assistant II Exam Plan as presented. A voice vote approved the motion.

APPROVAL OF LATERAL FIRE PREVENTION OFFICER (FPO) EXAM PLAN: Chief Examiner Sutherland requested approval of the Lateral Fire Prevention Officer Exam Plan as revised. The exam is open to both internal and external candidates. The posting date is May 10, 2024 with a closing date of May 24, 2024 at 5 p.m. The proposed exam varies minimally from the previous exam plan with some corrections to the exam plan.

Chair Tee asked whether the first phase of the exam must be passed to move forward to the next phases of the exam. Chief Examiner Sutherland affirmed the first phase is an application review. A candidate successfully passes the first phase by meeting a set of minimum qualifications. Phase 2 is the oral board interview.

Chair Tee asked whether the oral board includes 10 questions in four specific areas during a 30-minute interview. Chief Examiner Sutherland said the 25% score is assigned each for communication skills, compassionate and service orientation, critical thinking and problem solving, and working with the public. The applicant must achieve a minimum score of 70%. She confirmed the minimum number of veteran preference points of 10.

MOTION: Commissioner Chard moved, seconded by Chair Tee, to approve the Fire Prevention Officer Exam Plan as presented. A voice vote approved the motion.

APPROVAL OF MARCH 21, 2024 MINUTES:

	Fire Chief Hurley reported two Paramedics and the Fire Prevention Officer are retiring at the end of June. The first exam plan was posted for internal candidates only. The department did not receive any applications from the original posting. The second exam plan will be open to all applicants.
	One new hire completed the Fire Academy in North Bend. A second employee is scheduled to complete the Fire Academy in Thurston County.
	Commissioner Chard conveyed his appreciation to both chiefs for posting information on Facebook expressing appreciation to new employees.
	Police Chief Weiks said based on the Commission's final approval of the Police Service Specialist II Eligibility List, the department extended an offer to one of the candidates. The candidate accepted the offer and is scheduled to start on June 17, 2024. The applicant is moving to Tumwater from Dallas, Texas.
	In term of the status of the Police Department patrol staff, one officer is participating in the Field Training Program, two officers are attending the Basic Law Enforcement Academy, and one officer is scheduled to attend the academy on June 4, 2024. The department has three police officer openings and is losing another officer to retirement at the end of June.
NEXT MEETING DATE:	The next meeting is scheduled on June 13, 2024.
