# Part 1 GOALS & POLICIES

Goals and Policies are important to the Comprehensive Plan because they are actions and priorities identified by the community and staff to help the City plan for the future and accomplish the vision for Tumwater. Goals and policies will help the City create work programs and plans to meet the needs identified in the part 2 document. Goals and policies are actions the City will take and identify lead departments.

## TECHNICAL INFORMATION

What are the current conditions related to the element topic? What are the anticipated changes/challenges over the next 20 years? What are the requirements and opportunities to improve outcomes for people that live and work in Tumwater now and in the future? This document provides data and information that helped create the goals and policies.

### Implementation **ACTIONS**

Goals and policies are how Tumwater will plan for and accommodate growth over the next 20 years for each specific element. The draft action items are specific things Tumwater can do to achieve the goals and policies. They are in an appendix as drafts so staff can update or change actions with the needs of Tumwater over a two-decade span.

### Element **CLIMATE**

The Climate Element is a new Element. It was created to meet the state Growth Management Act to adapt to and mitigate the effects of a changing climate. The objectives of this climate element are twofold. The first sub-element addresses reducing Tumwater's greenhouse gas emissions to achieve net zero by 2050 goals set by the State of Washington. The second sub-element focuses on adapting to climate impacts that are already being felt across the region. This climate resilience sub element aims to address those impacts that cannot be avoided regardless of whether the City reaches its net zero goals.

### Impact **EOUITY**

In 2021, the Washington State Legislature changed GMA planning requirements through House Bill 1220 and instructed local governments to identify and address policies and regulations that may have a racially disparate or exclusionary effect and address patterns of disinvestment. A racially disparate impact happens when rules, policies, and procedures adversely affect one group of people more than another, even if those rules, policies, and procedures may have been intended to be neutral. Goals and policies from the adopted previous Comprehensive Plan were all analyzed to identify opportunities for improving equitable outcomes for the entire Tumwater community.
