5. OVERVIEW OF UTILITY RATES

Recent PCAC's for Electric Utility

- PCAC (Power Cost Adjustment) noted this applies to electric rates, varies from a credit of \$0.007/khw to \$0.0413/kwh. Noted many factors, such as natural gas/fuel cost, peak demand charge (city wholesale charge)
- Rate comparisons with other utilities Compared industrial & residential projected bills to others, which shows TR Utilities lower than comparison to several investor owned utilities, which showed a favorable average annual cost for Two River Utilities

Review of water rates

- Noted most usage is residential, which leads to higher rates than high
- Reviewed comparison of 30 utilities, shows Two Rivers is approximately 13% to 16% higher than the mean of communities

Reviewed Presentation of 2019

- Storm water utility fund, storm main repair/replacement, inlets, collection system maintenance, pond
 - construction and maintenance
- Solid Waste Utility refuse collection, recycling, street sweeping, landfill monitoring, leaf collection
- Waste Water utilities 1% increase O&M since 2009, noted billing units has decreased since 2008
- Water Utility cleaned into ice 5 years ago, a recent inspection showed some sediment build up, current plant capacity @ 2.6 MGD us plant rates of 3.3 MGD. Plan on test capacity monthly to determine if rates changing.
- Will update presentation to current information

6. WASTEWATER UTILITY: UPDATES AND ACTION

Comments received from DNR on permit:

- Noted DNR is requiring a Certified Collection System Operator
- Sludge management plan update fields
- Will require PFAS testing, along with conjunction of mercury reduction program, noted proposed PFAS limit expected to be at 20mg/l, due to discharge to Lake Michigan

- Will also require re-write w/mercury plan
