MINUTES

1. CALL TO ORDER

The meeting was called to order by Chairman Brad Yaggie at 4:00 PM.

2. ROLL CALL

Commission Members Present: Mike Canty, Kris LaFond, Sandy Rohrick, Jack Gadzala, Brad Yaggie

ALSO PRESENT: Ben Meinnert, Police Chief; Chad Kakes, Assistant Fire Chief; and Greg Buckley, City Manager

3. UPDATE FROM POLICE CHIEF ON HIRING AND STAFFING

Police Chief Ben Meinnert updated the Commission on the staffing for the Police Department. Meinnert explained the job reclassification from PLST to Captain. This will allow the Police Department to have an extra roll for career planning. Due to the current sergeants not having enough experience, the best option was to promote the current PLST to Captain. The Personnel and Finance Committee unanimously approved the change. On March 6, 2023, the City Council also unanimously approved the change. The Police Captain will be considered an administrator in the Police Department.

Chief Meinnert updated the Commission on the interviews taking place during the Closed Session. There are two candidates for Detective Lieutenant, both which are currently Lieutenants with the City of Two Rivers Police Department. There will end up being a Lieutenant position open that will come back to the Commission for interviews and selection in the future. There is also a vacant Police Officer position due to a resignation.

Assistant Fire Chief Chad Kakes updated the Commission on the status of the Fire Department. The new ladder truck is working well, and fixing any issues that arise.

4. CLOSED SESSION
