Two Rivers Schools Superintendent, Diane Johnson, presentation about the facility assessment they completed as well as a survey asking for community input from all stakeholders.

5. COMMITTEE REPORTS

A. County Aging Unit - Wendy Hutterer

Wendy Hutterer announced an upcoming retirement of the ADRC's Manitowoc receptionist. The part-time receptionist at Kewaunee location will move into that position. Kewaunee location congregate meals are now open. Spoke and gave hand out regarding Aging Advocacy Day, see attached. ADRC now offering full in-person, in-home visits, prevention programs, and Stepping Up Nutrition program

B. City Council - Bill LeClair

Election of 3 new City Council members. Jason Ring, Tim Petri and Scott Stechmesser. Bill LeClair re-ran and was re-elected as a City Council member. Spoke about Manitowoc Area Visitors and Convention Buereau, or MAVCB, moved to workforce development building on Dewey St. in Manitowoc, Two Rivers is not contracted with MAVCB. "Explore Two Rivers" Visitor center is located at 1608 Washington ST. The building will have a kiosk for visitor information. Washington House will be more of a historical house and will be open Wednesday through Sunday, 12p-4p. Tourism director Amy, helping to start up the visitor center. \$510,000 of 800,000 Central Park West 365 project money raised. Donators can buy honorary bricks, benches, and picnic tables to help reach the goal. Discussed upcoming apartment complex on Forest Avenue. There will be 45 units in the complex. Council is looking into affordable housing for seniors and young adults. The Paragon building was sold to Trivers LLC for \$1.2 million. City crews have been cleaning up sand that has blown into the walking trail and streets. Planting grass to prevent blowing sand. Trail by the lake is well used.

C. Recreation Department Programs –

New Recreation Director to start late June.

D. Senior Center – Heather Ihlenfeldt

Heather, new Senior Center Supervisor, introduced herself to the committee. Spoke issue of needing volunteers for Home delivered meals program for Mishicot routes on Wednesdays and Fridays. Pamela Stevens volunteered to assist; Wendy Hutterer will assist Heather in getting in contact with the ADRC volunteer coordinator.
