# ORDINANCE

**AN ORDINANCE** to amend the District Map of the City of Two Rivers, Wisconsin, made part of Section 10-1-3(a)(1) of the Municipal Code:

The Council of the City of Two Rivers ordains as follows:

**SECTION 1**. That the District Map of the City of Two Rivers, Wisconsin, made a part of Section 10-1-3(a)(1) of the Municipal Code be and the same is hereby amended in the following respects:

Lots 1 and 2, Block 12, excluding the North 50 feet (a/k/a Tract 3 of Certified Survey Map, Volume 9, Page 199), also the North 30 feet of adjacent vacated 29th Street, LeClair's Addition in the City of Two Rivers, Manitowoc County, Wisconsin

is hereby zoned R-3 Single and Double Family Residence District.

The above-described property contains 0.29 acres of land, more or less.

**SECTION 2.** This ordinance shall take effect and be in force from and after its date of passage and publication.



# ORDINANCE

**AN ORDINANCE** to amend Municipal Code Sections 10-1-20, 10-1-21 and 10-1-22, the R-1, R-2, R-3 and R-4 Residential Zoning Districts to amend the regulations related to side yard requirements.

The Council of the City of Two Rivers ordains as follows:

- **SECTION 1.** That Section 10-1-20C(1) of the Municipal Code shall hereby be amended as follows:
  - C. Side yards. There shall be a side yard on each side of a building.
    - (1) The sum of the widths of the required side yards shall be as follows:

Lot Width		Minimum Side Yard Width
(feet)	Total Side Yard Width	(feet)
Less than 76	15 feet	7
76 to 80	16 feet <del>or 25%, whichever is least</del>	8
81 to 85	17 feet or 25%, whichever is least	8
86 to 90	20 feet <del>or 25%, whichever is least</del>	8
91 to 95	23 feet or 25%, whichever is least	8
More than 95	25 feet <del>or 25%, whichever is least</del>	8

and to renumber subsequent sections as appropriate.

- **SECTION 2.** That Section 10-1-21C(1) of the Municipal Code shall hereby be amended as follows:
  - C. Side yards. There shall be a side yard on each side of a building.
    - (1) The sum of the widths of the required side yards shall be as follows:

		Minimum Side
Lot Width		Yard Width
(feet)	Total Side Yard Width	(feet)
Less than 67	15 feet <del>or 25%, whichever is less</del>	6
67 to 75	16 feet or 25% whichever is less	6
More than 75	20 feet 25% of lot width	6

- **SECTION 3.** That Section 10-1-22C(1) of the Municipal Code shall hereby be amended as follows:
  - C. Side yards. There shall be a side yard on each side of a building.
    - (1) The sum of the widths of the required side yards shall be as follows:

		Minimum Side
Lot Width		Yard Width
(feet)	Total Side Yard Width	(feet)
40 to 45	10 feet	5
46 to 70	15 feet	6
More than 70	20 feet 25% of the lot width	6

- **SECTION 4.** That Section 10-1-23C of the Municipal Code shall hereby be amended as follows:
  - C. Side yards. There shall be a side yard on each side of a building. The total side yard shall be 30% of the lot width for a one-story building with a minimum side yard requirement of 50% of the total side yard.

(1) The sum of the widths of the required side yards shall be as follows:

Lot Width (feet)	Total Side Yard Width	Minimum Side Yard Width (feet)
Less than 200	30 feet	15
200 to 400	50 feet	15
More than 400	70 feet	15

- (2) For any building over two stories there will be an increase in each side yard of five feet per story.
- **SECTION 5.** This ordinance shall take effect and be in force from and after its date of passage and publication of same.

# 9. CITY MANAGER'S REPORT

- A. Invited Guests
  - Two Rivers Business Association Central Park West Donation Representatives of the Two Rivers Business Association were in attendance to present a check for \$10,000 to the City for the Central Park West 365 project.
  - 2. Two Rivers School District Facility Assessment and Survey on Community Input From All Stakeholders

Diane Johnson, Two Rivers Public School District Superintendent, was present to provide a report on the Two Rivers School District facility assessment and survey on community input. Also present to assist in the presentation were Mary Kay Slattery, Finance Director, and Jaimie Salta, School Board President. The presentation included an overview of where the district gets their funding, how the dollars are spent, enrollment numbers, history of the school district mill rate, and a review of the facility study including the prominent needs at LB Clarke and proposed additions and renovations for that facility to help meet the needs of the district.

- B. Status Update/Reports
  - 1. Sale of 606 Parkway Boulevard, Former Paragon Property
    - Mr. Buckley reported that the sale of 606 Parkway Boulevard to Trivers, LLC, an entity controlled by Oshkosh developer Art Dumke, closed on March 17. The net proceeds to the City's Economic Development Fund were \$1,197,031 (\$1.2 million purchase price less the title insurance and closing costs).

The new owner plans to rehabilitate the facility for lease as manufacturing and warehouse space. The City has applied for a WEDC Idle Sites Grant of \$500,000 to assist the project with improvements as the estimated cost for planned work on the facility is over \$6,000,000.

2. Sandy Bay Highlands Home Construction

Mr. Buckley reported that plans for two new homes at the City-developed conservation subdivision were approved by the Architectural Review Committee on March 14. One basement is poured, and the other is being poured this week. At least two other homes are in the planning and cost quoting stages for construction this year.

- Pine Tree Lift Station Project Mr. Buckley reported that the construction of Pine Tree Lift Station on the east side is underway.
- 4. Winter Parking Ban Has Ended Mr. Buckley reported that due to a relatively snow-free winter, the overnight parking ban was enforced on only 6 of 103 total days, December 1 through March 15.
- 5. Personnel Updates:

Mr. Buckley reported on the following personnel updates:

- Heather Ihlenfeldt has accepted the position of Senior Center Supervisor and will begin on Monday, April 25th. Heather currently serves as Marketing and Activity Director at the Manitowoc Health and Rehab Center.
- Certified Water Operator and Water Distribution Foreman/Operator Vacancy– Interviews have been completed and an offer will be made to a candidate in the next few weeks
- Parks & Recreation Director Initial interviews were conducted on March 18 and March 21
- 6. Central Park West 365 Update

Mr. Buckley reported that since the last Council meeting, total donations committed to the Central Park West 365 Project have increased to just over \$450,000, 56.25% of the goal of \$800,000.

7. In Person Absentee Voting

Mr. Buckley reported that in person absentee voting for the April 5, 2022 Spring Election will begin March 22 and runs through April 1, Monday through Friday between the hours of 8:00 AM and 4:30 PM at City Hall

8. Upcoming Events:

Proceeds of this event will benefit the Skating Loop of the Central Park West 365 Project in downtown Two Rivers. A silent auction and social hour with cash bar starts at 5:00 PM. Dinner is catered by the Courthouse Pub and is served at 6:30 PM to be followed by a live auction.

Mr. Buckley reported that the Two Rivers Business Association and League of Women Voter's City Council candidate forums are available for viewing on the City's YouTube channel.

Final 2021 room tax collections were \$261,161, an increase of \$119,261, or 8 2020.

Two Rivers logowear is available for purchase at Schoeder's Department Store, Lighthouse Inn, Fatzo's, Woodland Dunes, and Renee's Chocolates.

- C. Legislative Update
  - 1. Law Enforcement Grants to Local Agencies Announced by Governor Evers Mr. Buckley reported that the Governor announced grants totaling \$19 million, to police department across the state. Distribution was reportedly predicated on population and violent crime statistics. Two Rivers will receive \$31,719.02.

While more details may be forthcoming, Chief Kohlmeier reports the funds can be used for training, recruitment bonuses, technology investments, and meeting community policing needs.

2. Conclusion of Recent Legislative Session in Madison Mr. Buckley reported that Senate Bill 692 has passed which makes various changes to the property assessed clean energy (PACE) program, including expanding the types of projects eligible for PACE financing and changes to the requirements for accessing that financing.

The League of Wisconsin Municipalities has also worked hard to halt the fast-tracking of AB 608/SB 840, imposing one-size fits all zoning for workforce housing, and AB 610/SB 630, related to prohibiting certain property tax assessment practices.

Also, what once was a good piece of legislation which the League supported, ended up with an amendment that excluded local government from participating in the EV infrastructure build out. It started as a bill that would allow the sale of power from EV charging infrastructure without categorizing the seller as a public utility in the state. Unfortunately, the end result had all three local government groups (the League, Counties, and Towns) in opposition.

3. Funding for Determination of Federal Interest in Two Rivers Harbor Study Mr. Buckley reported the Omnibus Appropriations Bill that passed the Congress earlier this month includes \$20,000 in funding for the Army Corps of Engineers to assess the Federal interest in a Design Deficiency Study of the Two Rivers Harbor.

This activity must precede the Corps seeking funding for the study, estimated to cost \$200,000. Such a study could in turn be the basis for Federal investment in structural modifications to the harbor entrance, to mitigate both storm surge and shoaling issues.

- 4. Confirmation of State Safe Drinking Water Funding for 2022 Lead Service Lateral Replacement Mr. Buckley reported Wisconsin's Safe Drinking Water Loan Program has confirmed 2022 funding for Two Rivers of \$207,500. This funding will cover principal forgiveness grant for 83 private side laterals at \$2,500 each, 33 laterals on 17th Street and 50 laterals at scattered locations.

Mr. Buckley reported the Wisconsin Department of Natural Resources has issued a permit to allow grooming of the "new beach" area, south of Neshotah Beach to the north pier. This permit, good for 5 years, allows the City to "dredge" the area below the ordinary high water mark to remove debris.

All persons will be considered at said hearing and thereafter the amounts of the assessments will be finally determined by the City Council.

# Chapter 8-3

# **Bicycles, E-Bikes, and Electric Personal Assistive Mobility Devices**

[HISTORY: Adopted by the City Council of the City of Two Rivers (Title 8, Ch. 3, of the 1981 Code). Amendments noted where applicable.] This chapter shall not apply to vehicles or devices used in accordance with the Americans with Disabilities Act or in regard to play vehicles as defined by Wisconsin Statute.

# § 8-3-1 **Definitions.**

As used in this chapter, the following terms shall have the meanings indicated:

# BICYCLE

Every device propelled by the feet or hands acting upon pedals or cranks and having wheels, any two of which are not less than 14 inches in diameter. A bicycle for purposes of this chapter may have any number of wheels two or more.

# **BICYCLE LANE**

That portion of a roadway set aside by the governing body of any city, town, village, or county for the exclusive use of bicycles, electric scooters, electric personal assistive mobility devices, or other modes of travel where permitted, absent gasoline power, and so designated by appropriate signs and pavement markings. That portion of a roadway set aside for exclusive use of bicycles and so designated byappropriate signs and markings by the responsible governing body.

# **BICYCLE PATROL OFFICER**

A police officer patrolling by use of bicycle, electric scooter, electric personal assistive mobility device.

# **BICYCLE WAY or PUBLIC RECREATION TRAIL**

Any path or sidewalk or portion thereof, off roadway, or property owned or leased by the City, and designated for use by pedestrians, bicycles, electric scooters, and electric personal assistive mobility devices, or any other human or electric powered recreation, absent gasoline power, by the governing body of any city, town, village, or county. Any path or sidewalk, or portion thereof, designated for theuse of bicycles by the responsible governing body.

# **BIKE ROUTE**

Any bicycle lane, bicycle way or highway which has been duly designated by the responsible governing body and identified by appropriate signs and markings.

# CARRIER

Any device attached to a bicycle, electric scooter, electric personal assistive mobility device designed for carrying articles.

### **E-BIKE or ELECTRIC BICYCLE**

Any bicycle that is equipped with fully operative pedals for propulsion by human power and an electric motor of 750 watts or less and that meets the requirements of any of the following classifications:

(a) Class 1 electric bicycle is an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour.

(b) Class 2 electric bicycle is an electric bicycle that may be powered solely by the motor and is not capable of providing assistance when the bicycle reaches the speed of 20 miles per hour. (c) Class 3 electric bicycle is an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 28 miles per hour.

# ELECTRIC PERSONAL ASSISTIVE MOBILITY DEVICE

A self-balancing, 2-nontandem-wheeled device that is designed to transport only one person and that has an electric propulsion system that limits the maximum speed of the device to 15 miles per hour or less. "Segway" is an example of an electric personal assistive mobility device for purposes of this chapter.

### **ELECTRIC SCOOTER**

A device weighing less than 100 pounds that has handlebars and an electric motor, is powered solely by the electric motor and human power, and has a maximum speed of not more that 20 miles per hour on a paved level surface when powered soley by the electric motor. "Electric scooter" does not include an electric personal assistive mobility device, motorcycle, motor bicycle, electric bicycle, or moped.

# **IDENTIFICATION TAG**

A metal plate or sticker indicating that a bicycle is registered.

# **OPERATOR**

Every person who drives or is in actual physical control of a device or vehicle as covered in this chapter.

# **OWNER**

A person, other than a lienholder, having the property in or title to a vehicle. The term includes a person entitled to the use and possession of a vehicle subject to a security interest in another person, but excludes a lessee under a lease not intended as security.

# PEDESTRIAN

Any person afoot or any person in a wheelchair, either manually or mechanically propelled, or other lowpowered, mechanically propelled vehicle designed specifically for use by a physically disabled person.

# **RENTAL AGENCY**

A city authorized business offering rental or hire of bicycles, electric scooters, or electric personal assistive mobility devices to a third party for a limited time.

# **RIGHT-OF-WAY**

The right of one vehicle or pedestrian to proceed in a lawful manner in preference to another vehicle or pedestrian approaching under such circumstances of direction, speed and proximity as to give rise to danger of collision unless one grants precedence to the other.

# ROADWAY

That portion of a highway between the regularly established curb lines or that portion which is improved, designed, or ordinarily used for vehicular travel, excluding the berm or shoulder.

# SIDEWALK

That portion of a street between the curblines, or the lateral lines of a roadway, and the adjacent property lines, intended for use by pedestrians.

# VEHICLE

Every device in, upon or by which any person or property is or may be transported or drawn upon a highway.

# § 8-3-2 Registration of bicycles, e-bikes, electric scooters, and electric personal assistive mobility devices.

- A. Registration of bicycles required. No person who resides within the City of Two Rivers shall operate or propel a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon any public highway, public recreation trail, bicycle way or bicycle path within the City, or on property owned or leased by the City, which has not been duly registered and licensed as provided in this chapter. The owner shall apply for registration within 10 days of purchase and delivery of the bicycle, e-bike, electric scooter or electric personal assistive mobility device. A rental agency shall not rent or offer any bicycle, e-bike, electric scooter or electric personal assistive mobility device, for rent unless registered and an identification tag is attached thereto as provided herein and such bicycle, e-bike, electric scooter or electric personal assistive mobility device from the original manufacturer in such a way as to make said device unsafe.
- B. How made. Registration shall be made by filing with the Police Department on forms provided by the City, giving the name, address and date of birth of the owner and a complete description of the bicycle, e-bike, electric scooter or electric personal assistive mobility device, including the name of the manufacturer, style, model, serial number, and color. If the bicycle, e-bike, electric scooter or electric personal assistive mobility device, bike, electric scooter or electric personal assistive mobility device, e-bike, electric scooter or electric personal assistive mobility device, e-bike, electric scooter or electric personal assistive mobility device, e-bike, electric scooter or electric personal assistive mobility device has no serial number, the Police Department shall assign one.
- C. Registration fee. The fee for registration and license of a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall be as provided for in Chapter 1-2, Fees, of this Code. Police patrol bicycles and other city owned vehicles or devices are exempt from this provision.
- D. Identification tag. The registering employee or officer shall issue to the registrant an identification tag. The identification tag shall be immediately affixed to the registered bicycle, e-bike, electric scooter or electric personal assistive mobility device, and shall be firmly attached to the bicycle, e-bike, electric scooter or electric personal assistive mobility device for which issued and kept visible and clean at all times. The identification tag shall permit the bicycle, e-bike, electric personal assistive mobility device to be operated upon the City streets, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City.

- E. Unsafe bicycles, e-bikes, electric scooters or electric personal assistive mobility devices Section 11, ItemB. registered. No bicycle, e-bike, electric scooter or electric personal assistive mobility device snall be registered which is in an unsafe mechanical condition.
- F. Owner to register. The licensing authority shall not register any bicycle, e-bike, electric scooter or electric personal assistive mobility device which it knows or has reasonable grounds to believe is not owned by or lawfully in the possession of the applicant.
- G. Change of ownership.
- (1) Within 10 days after any bicycle, e-bike, electric scooter or electric personal assistive mobility device registered as provided herein is sold or transferred to a new owner, the new owner shall report such information to the Police Department and shall apply for and obtain the transfer of the registration through the Police Department. Within 10 days after any bicycle, e-bike, electric scooter or electric personal assistive mobility device is dismantled or taken out of operation, the person in whose name the bicycle, e-bike, electric scooter or electric personal assistive mobility device is registered shall report such information to the Police Department. The Police Department shall thereupon cancel the registration of the bicycle, e-bike, electric scooter or electric personal assistive mobility device.
- (2) Every person who transfers the title of any bicycle, e-bike, electric scooter or electric personal assistive mobility device shall endorse upon the form provided by the City the name, address, and date of birth of the transferee, the date of the transfer and the identification tag number affixed to the bicycle, e-bike, electric scooter or electric personal assistive mobility device. The transferee, upon registration, shall pay a transfer fee as provided for in Chapter 1-2, Fees, of this Code. The bicycle, e-bike, electric scooter or electric personal assistive mobility device identification tag remains with the bicycle, e-bike, electric scooter or electric personal assistive mobility device and is not transferable to a different bicycle, e-bike, electric scooter or electric personal assistive mobility device.

# § 8-3-3 Responsibility of parent or , guardian, or rental agency.

No parent or guardian of any child, or rental agency shall authorize or knowingly permit a child to violate any of the provisions of this chapter or of any ordinance or state law applicable to the registration or operation of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices, and shall be responsible for the safety and maintenance of said device. Any person, who owns, operates or rides upon a bicycle, e-bike, electric scooter or electric personal assistive mobility device on a City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, does so at that person's own risk and peril and assumes all liability resulting from the operation of the device. The City in no way shall be liable for accidents, injuries or death involving the operation of the device.

# § 8-3-4 Display of registration.

The identification tag issued under this chapter shall be affixed to the registered bicycle, e-bike, electric scooter or electric personal assistive mobility device so as to be plainly seen and read and shall remain so affixed until ordered removed by the Police Department for cause or until expiration of the registration. In the case of theft or loss of the identification tag, a replacement tag shall be issued upon payment of a fee as provided for in Chapter 1-2, Fees, of this Code.

# § 8-3-5 Exemption from registration.

Any nonresident of the City who has duly registered his/her bicycle, e-bike, electric scooter of electric personal assistive mobility device in another jurisdiction, or who resides in another jurisdiction which has no registration requirements, may operate his/her bicycle, e-bike, electric scooter or electric personal assistive mobility device in the City without obtaining local registration.

# § 8-3-6 Removal and alteration of identification tags.

- A. Removal prohibited. No person shall remove an identification tag from a bicycle, e-bike, electric scooter or electric personal assistive mobility device during the period for which it is issued.
- B. Alteration prohibited. No person shall alter or counterfeit any identification tag.

# § 8-3-7 Unclaimed or unidentified bicycles, e-bikes, electric scooters or electric personal assistive mobility devices.

All abandoned or unidentified bicycles, e-bikes, electric scooters or electric personal assistive mobility devices shall be delivered to the Police Department for storage, and all such bicycles, e-bikes, electric scooters or electric personal assistive mobility devices remaining in the hands of the Police Department after 60 days shall be sold at the next scheduled police auction.

# § 8-3-8 Operating rules.

No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon any City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, shall fail to observe any applicable traffic regulations of the municipality and state or to comply with the following regulations:

- A. Operator and Carrying extra passenger. The manufacturer's recommended operator and seating capacity shall not be exceeded. Bicycle operators shall not use a bicycle to carry another person; however, a bicycle operator may carry or transport a child seated in an auxiliary child's seat or trailer designed for attachment to a bicycle if the seat or trailer is securely attached to the bicycle according to the directions of the manufacturer of the seat or trailer. No child under age 16 may operate a class 3 electrical bicycle and no class 3 electrical bicycle may be operated on any public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, except upon any City street.
- B. Stunt or trick riding. No person operating or pedaling a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall participate in any trick or stunt riding or racing on any City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, unless such race or contest is held pursuant to permission granted by the authority having jurisdiction over the highway, or with the express written consent of the City Council.
- C. Towing with bicycle. No person riding or operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall tow, drag or cause to be drawn behind the bicycle, e-bike, electric scooter or electric personal assistive mobility device, any person on roller skates, coaster sled, or any other type of conveyance not designed to be towed by a bicycle, e-bike, electric scooter or electric personal assistive mobility device.

- Obedience to traffic control devices. Any person operating a bicycle, e-bike, electric sco D. Section 11, ItemB. personal assistive mobility device shall obey the instructions of official traffic control devices applicable to vehicles unless otherwise directed by a law enforcement officer.
- E. Stopping, turning and signaling.
- Signal required. No bicycle, e-bike, electric scooter or electric personal assistive mobility device (1)operator shall suddenly stop, slow down, or turn without giving proper signal, or when the vehicle or device is not equipped with traffic signals by the manufacturer, an arm signal is required by state law for the operation of motor vehicles or devices on roadways. No person shall turn a bicycle, e-bike, electric scooter or electric personal assistive mobility device into an intersection unless the bicycle, e-bike, electric scooter or electric personal assistive mobility device is in proper position upon the roadway or turn to enter a private roadway or driveway unless the bicycle, e-bike, electric scooter or electric personal assistive mobility device is in proper position on the roadway as required or suddenly turn a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon a roadway unless and until such movement can be made with reasonable safety. If other traffic may be affected by such movement, no person shall so turn any bicycle, e-bike, electric scooter or electric personal assistive mobility device without giving an appropriate signal in the manner provided. Such signal shall be given continually during not less than 50 feet before turning. When given by arm and hand signals, such signals shall be given from left side of bicycle, e-bike, electric scooter or electric personal assistive mobility device in the following manner and shall indicate as follows:
- (a) Left turn: hand and arm extended horizontally.
- (b) Right turn: hand and arm extended upward.
- (c) Stop or decrease speed: hand and arm extended downward.
- (2) Prohibited turns. Whenever a uniform traffic control device indicates that no right or left turn or U-turn is permitted, no person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall disobey the direction of such device, except after dismounting from the bicycle, e-bike, electric scooter or electric personal assistive mobility device to make such turn, in which event said person shall then obey the regulations, ordinances and laws applicable to pedestrians.
- (3) Right turns. Every person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device intending to turn to the right at an intersection, alley, or driveway shall approach the turning point in the line of traffic nearest the right-hand curb of the street.
- (4) Left turns. Every person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device intending to turn left at an intersection or to enter an alley or driveway shall approach the point of turning in that lane farthest to the left which is lawfully available to traffic moving in the direction of travel of the bicycle, e-bike, electric scooter or electric personal assistive mobility device about to turn left, unless otherwise directed by official traffic control devices. At intersections where traffic is moving in the opposite direction, if it is not safe for the operator to make a left turn as abovedescribed, he or she shall stay in the right-hand lane and drive to the opposite corner, dismount and walk the bicycle, e-bike, electric scooter or electric personal assistive mobility device to the left-hand corner and proceed. A bicycle, e-bike, electric scooter or electric personal assistive mobility device operato 33

may also make a left turn by driving to the opposite corner and then turning left and driv Section 11, ItemB. driving position.

- (5) Use of crosswalks. Crosswalks shall be used when walking a bicycle, e-bike, electric scooter or electric personal assistive mobility device through an intersection.
- F. Speed. No person shall operate a bicycle, e-bike, electric scooter or electric personal assistive mobility device at a speed greater than is reasonable and prudent under existing conditions or in excess of any posted speed limit. No person may operate a bicycle, e-bike, electric scooter, electric personal assistive mobility device, or other vehicle off roadway but on property owned by the city, including but not limited to City parks and public recreation trails, in excess of 15 mph.
- G. Clinging to moving vehicles. It shall be unlawful for any person riding upon a bicycle, e-bike, electric scooter or electric personal assistive mobility device to cling or attach himself or his themselves to a bicycle, e-bike, electric scooter or electric personal assistive mobility device to any moving vehicle.
- H. Single file riding. Every person when operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device on a public highway shall ride such bicycle, e-bike, electric scooter or electric personal assistive mobility device in a single file and at no time shall ride two or more abreast.
- I. Racing. No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall participate in any race, speed or endurance contest with another bicycle, e-bike, electric scooter or electric personal assistive mobility device or with any motor other vehicle on a City street, public recreation trail, or on property owned or leased by the City, except in connection with a special event upon permission granted by the City Council after a report by the Chief of Police.
- J. Removal of hands from handlebars. No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall remove both hands from handlebars or feet from pedals nor practice any fancy or acrobatic riding or stunts in the operation of said bicycles, e-bikes, electric scooters or electric personal assistive mobility devices.
- K. Lights; reflectors. No person may operate a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon a highway, bicycle lane or bicycle way during hours of darkness unless such bicycle, e-bike, electric scooter or electric personal assistive mobility device is equipped with or the operator is wearing a lamp emitting a white light visible from a distance of at least 500 feet to the front of such bicycle, e-bike, electric scooter or electric personal assistive mobility device. Such bicycle, e-bike, electric scooter or electric personal assistive mobility device. Such bicycle, e-bike, electric personal assistive mobility device shall also be equipped with a red reflector that has a diameter of at least two inches of surface area on the rear, so mounted and maintained as to be visible from all distances from 50 to 500 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle. A lamp emitting a red light visible from a distance of 500 feet to the rear may be used in addition to, but not in lieu of, the red reflector.
- L. Operation on roadway edge. The rider of a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall ride as near as practicable to within five feet of the right-hand curb or edge of the roadway, except when passing another vehicle or in making a left-hand turn in an intersection.

# § 8-3-9 Parking.

No person shall park any bicycle, e-bike, electric scooter or electric personal assistive mobility device against windows or in the main traveled portion of any sidewalk or highway nor in such manner as to constitute a hazard to pedestrians, traffic or property. If there is no bicycle rack or other facility intended to be used for the parking of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices in the vicinity, the operator may park a bicycle, e-bike, electric scooter or electric personal assistive mobility device on the sidewalk in the upright position parallel to and within 24 inches of the curb.

# § 8-3-10 Operation on sidewalks.

- A. No person shall run or propel operate any bicycle, e-bike, electric scooter or electric personal assistive mobility device on any sidewalk within the City, except bicycles with wheels 20 inches in diameter or less in residential areas for the purpose of learning, or bicycles being operated by a Police Bicycle Patrol Officer or other city vehicle operating within the performance of his city duties.
- B. Bicycles, e-bikes, electric scooters or electric personal assistive mobility devices of all sizes may be operated on bridge sidewalks, but shall maintain the right-of-way to pedestrians.
- C. Notwithstanding Subsection A hereof, the City Council may, by motion or resolution, permit the operation of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices on designated sidewalks of the City, in its discretion, when it believes permitting such operation is appropriate and consistent with the public health and safety. Copies of any such resolution or motion shall be maintained at the office of the City Clerk and shall be available for public inspection during normal office hours. Such permission shall be subject to signage or other requirements imposed by applicable law.

# § 8-3-11 Violations and penalties. [Amended at time of adoption of Code (see Title 1, General Provisions, Ch. 1-1, Art. III)]

Any person who shall violate any of the provisions of this chapter shall be punished by any of the following methods, subject to the requirements of state law:

- A. Any person over the age of 12 who violates any provision of this chapter shall be subject to the following penalties:
- (1) First offense penalty. Any person over the age of 12 who shall violate any provisions of this chaptershall forfeit not less than \$5 nor more than \$1,500.
- (2) Second offense penalty. Any person over the age of 12 who shall violate any provisions of this chapterfor the second time within a one-year period shall forfeit not less than \$10 nor more than \$1,500.
- (3) Third offense penalty. Any person over the age of 12 who shall violate any provisions of this chapter for the third or subsequent time within a one-year period shall forfeit not less than \$20 nor more than \$1,500.

### ORDINANCE

**AN ORDINANCE** to amend Municipal Code 8-3 entitled "Bicycles, E-Bikes, and Electric Personal Assistive Mobility Devices".

The Council of the City of Two Rivers ordains as follows:

Amendments noted where applicable.] This chapter shall not apply to vehicles or devices used in accordance with the Americans with Disabilities Act or in regard to play vehicles as defined by Wisconsin Statute.

**SECTION 1.** That Section 8-3-1 of the Municipal Code shall hereby be amended as follows:

#### BICYCLE

Every device propelled by the feet or hands acting upon pedals or cranks and having wheels, any two of which are not less than 14 inches in diameter. A bicycle for purposes of this chapter may have any number of wheels two or more.

#### **BICYCLE LANE**

That portion of a roadway set aside by the governing body of any city, town, village, or county for the exclusive use of bicycles, electric scooters, electric personal assistive mobility devices, or other modes of travel where permitted, absent gasoline power, and so designated by appropriate signs and pavement markings.

#### **BICYCLE PATROL OFFICER**

A police officer patrolling by use of bicycle, electric scooter, electric personal assistive mobility device.

#### **BICYCLE WAY or PUBLIC RECREATION TRAIL**

Any path or sidewalk or portion thereof where permitted, off roadway, or property owned or leased by the City where permitted, and designated for use by pedestrians, bicycles, electric scooters, and electric personal assistive mobility devices, or any other human or electric powered recreation, absent gasoline power, by the governing body of any city, town, village, or county.

#### **BIKE ROUTE**

Any bicycle lane, bicycle way or highway which has been duly designated by the responsible governing body and identified by appropriate signs and markings.

#### CARRIER

Any device attached to a bicycle, electric scooter, electric personal assistive mobility device designed for carrying articles.

#### E-BIKE or ELECTRIC BICYCLE

Any bicycle that is equipped with fully operative pedals for propulsion by human power and an electric motor of 750 watts or less and that meets the requirements of any of the following classifications:

(a) Class 1 electric bicycle is an electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 20 miles per hour.

(b) Class 2 electric bicycle is an electric bicycle that may be powered solely by the motor and is not capable of providing assistance when the bicycle reaches the speed of 20 miles per hour.

(c) Class 3 electric bicycle is an electric bicycle equipped with a motor that provides assistance

only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches the speed of 28 miles per hour.

### ELECTRIC PERSONAL ASSISTIVE MOBILITY DEVICE

A self-balancing, 2-nontandem-wheeled device that is designed to transport only one person and that has an electric propulsion system that limits the maximum speed of the device to 15 miles per hour or less. "Segway" is an example of an electric personal assistive mobility device for purposes of this chapter.

### **ELECTRIC SCOOTER**

A device weighing less than 100 pounds that has handlebars and an electric motor, is powered solely by the electric motor and human power, and has a maximum speed of not more that 20 miles per hour on a paved level surface when powered soley by the electric motor. "Electric scooter" does not include an electric personal assistive mobility device, motorcycle, motor bicycle, electric bicycle, or moped.

### **IDENTIFICATION TAG**

A metal plate or sticker indicating that a bicycle is registered.

### OPERATOR

Every person who drives or is in actual physical control of a device or vehicle as covered in this chapter.

### OWNER

A person, other than a lienholder, having the property in or title to a vehicle. The term includes a person entitled to the use and possession of a vehicle subject to a security interest in another person, but excludes a lessee under a lease not intended as security.

### PEDESTRIAN

Any person afoot or any person in a wheelchair, either manually or mechanically propelled, or other lowpowered, mechanically propelled vehicle designed specifically for use by a physically disabled person.

### **RENTAL AGENCY**

A city authorized business offering rental or hire of bicycles, electric scooters, or electric personal assistive mobility devices to a third party for a limited time.

### **RIGHT-OF-WAY**

The right of one vehicle or pedestrian to proceed in a lawful manner in preference to another vehicle or pedestrian approaching under such circumstances of direction, speed and proximity as to give rise to danger of collision unless one grants precedence to the other.

### ROADWAY

That portion of a highway between the regularly established curb lines or that portion which is improved, designed, or ordinarily used for vehicular travel, excluding the berm or shoulder.

### SIDEWALK

That portion of a street between the curblines, or the lateral lines of a roadway, and the adjacent property lines, intended for use by pedestrians.

### VEHICLE

Every device in, upon or by which any person or property is or may be transported or drawn upon a highway.

**SECTION 2.** That Section 8-3-2 of the Municipal Code shall hereby be amended as follows:

### Registration of bicycles, e-bikes, electric scooters, and electric personal assistive mobility devices.

A. Registration required. No person who resides within the City of Two Rivers shall operate or propel a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon any public highway, public recreation trail, bicycle way or bicycle path within the City, or on property owned or leased by the City, which has not been duly registered and licensed as provided in this chapter. The owner shall apply for registration within 10 days of purchase and delivery of the bicycle, e-bike, electric scooter or electric personal assistive mobility device. A rental agency shall not rent or offer any bicycle, e-bike, electric scooter or electric personal assistive mobility device, for rent unless registered and an identification tag is attached thereto as provided herein and such bicycle, e-bike, electric scooter or electric personal assistive mobility device has not been modified from the original manufacturer in such a way as to make said device unsafe.

- B How made. Registration shall be made by filing with the Police Department on forms provided by the City, giving the name, address and date of birth of the owner and a complete description of the bicycle, e-bike, electric scooter or electric personal assistive mobility device, including the name of the manufacturer, style, model, serial number, and color. If the bicycle, e-bike, electric scooter or electric personal assistive mobility device has no serial number, the Police Department shall assign one.
- C. Registration fee. The fee for registration and license of a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall be as provided for in Chapter 1-2, Fees, of this Code. Police patrol bicycles and other city owned vehicles or devices are exempt from this provision.
- D. Identification tag. The registering employee or officer shall issue to the registrant an identification tag. The identification tag shall be immediately affixed to the registered bicycle, e-bike, electric scooter or electric personal assistive mobility device, and shall be firmly attached to the bicycle, e-bike, electric scooter or electric personal assistive mobility device for which issued and kept visible and clean at all times. The identification tag shall permit the bicycle, e-bike, electric scooter or electric personal assistive mobility device to be operated upon the City streets, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City.
- E. Unsafe bicycles, e-bikes, electric scooters or electric personal assistive mobility devices not to be registered. No bicycle, e-bike, electric scooter or electric personal assistive mobility device shall be registered which is in an unsafe mechanical condition.
- F. Owner to register. The licensing authority shall not register any bicycle, e-bike, electric scooter or electric personal assistive mobility device which it knows or has reasonable grounds to believe is not owned by or lawfully in the possession of the applicant.
- G. Change of ownership.
  - (1) Within 10 days after any bicycle, e-bike, electric scooter or electric personal assistive mobility device registered as provided herein is sold or transferred to a new owner, the new owner shall report such information to the Police Department and shall apply for and obtain the transfer of the registration through the Police Department. Within 10 days after any bicycle, e-bike, electric scooter or electric personal assistive mobility device is dismantled or taken out of operation, the person in whose name the bicycle, e-bike, electric scooter or electric personal assistive mobility device is registered shall report such information to the Police Department. The Police Department shall thereupon cancel the registration of the bicycle, e-bike, electric scooter or electric personal assistive mobility device.
  - (2) Every person who transfers the title of any bicycle, e-bike, electric scooter or electric personal assistive mobility device shall endorse upon the form provided by the City the name, address, and date of birth of the transferee, the date of the transfer and the identification tag number affixed to the bicycle, e-bike, electric scooter or electric personal assistive mobility device. The transferee, upon registration, shall pay a transfer fee as provided for in Chapter 1-2, Fees, of this

Code. The bicycle, e-bike, electric scooter or electric personal assistive mobility device identification tag remains with the bicycle, e-bike, electric scooter or electric personal assistive mobility device and is not transferable to a different bicycle, e-bike, electric scooter or electric personal assistive mobility device.

**SECTION 3.** That Section 8-3-3 of the Municipal Code shall hereby be amended as follows:

#### Responsibility of parent, guardian, or rental agency.

No parent or guardian of any child, or rental agency shall authorize or knowingly permit a child to violate any of the provisions of this chapter or of any ordinance or state law applicable to the registration or operation of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices, and shall be responsible for the safety and maintenance of said device. Any person, who owns, operates or rides upon a bicycle, e-bike, electric scooter or electric personal assistive mobility device on a City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, does so at that person's own risk and peril and assumes all liability resulting from the operation of the device. The City in no way shall be liable for accidents, injuries or death involving the operation of the device.

**SECTION 4.** That Section 8-3-4 of the Municipal Code shall hereby be amended as follows:

### Display of registration.

The identification tag issued under this chapter shall be affixed to the registered bicycle, e-bike, electric scooter or electric personal assistive mobility device so as to be plainly seen and read and shall remain so affixed until ordered removed by the Police Department for cause or until expiration of the registration. In the case of theft or loss of the identification tag, a replacement tag shall be issued upon payment of a fee as provided for in Chapter 1-2, Fees, of this Code.

**SECTION 5.** That Section 8-3-5 of the Municipal Code shall hereby be amended as follows:

### Exemption from registration.

Any nonresident of the City who has duly registered his/her bicycle, e-bike, electric scooter or electric personal assistive mobility device in another jurisdiction, or who resides in another jurisdiction which has no registration requirements, may operate his/her bicycle, e-bike, electric scooter or electric personal assistive mobility device in the City without obtaining local registration.

**SECTION 6.** That Section 8-3-6 of the Municipal Code shall hereby be amended as follows:

### Removal and alteration of identification tags.

- A. Removal prohibited. No person shall remove an identification tag from a bicycle, e-bike, electric scooter or electric personal assistive mobility device during the period for which it is issued.
- B. Alteration prohibited. No person shall alter or counterfeit any identification tag.
- **SECTION 7.** That Section 8-3-7 of the Municipal Code shall hereby be amended as follows:

## Unclaimed or unidentified bicycles, e-bikes, electric scooters or electric personal assistive mobility devices.

All abandoned or unidentified bicycles, e-bikes, electric scooters or electric personal assistive mobility devices shall be delivered to the Police Department for storage, and all such bicycles, e-bikes, electric scooters or electric personal assistive mobility devices remaining in the hands of the Police Department after 60 days shall be sold at the next scheduled police auction.

**SECTION 8.** That Section 8-3-8 of the Municipal Code shall hereby be amended as follows:

### Operating rules.

No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon

any City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, shall fail to observe any applicable traffic regulations of the municipality and state or to comply with the following regulations:

- A. Operator and passenger. The manufacturer's recommended operator and seating capacity shall not be exceeded. Bicycle operators shall not use a bicycle to carry another person in excess of manufacturer's recommended capacity; however, a bicycle operator may carry or transport a child seated in an auxiliary child's seat or trailer designed for attachment to a bicycle if the seat or trailer is securely attached to the bicycle according to the directions of the manufacturer of the seat or trailer. No child under age 16 may operate a class 3 electrical bicycle and no class 3 electrical bicycle may be operated on any public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, except upon any City street.
- B. Stunt or trick riding. No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall participate in any trick or stunt riding or racing on any City street, public recreation trail, bicycle path or bicycle way within the City, or on property owned or leased by the City, unless such race or contest is held pursuant to permission granted by the authority having jurisdiction over the highway, or with the express written consent of the City Council.
- C. Towing. No person riding or operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall tow, drag or cause to be drawn behind the bicycle, e-bike, electric scooter or electric personal assistive mobility device, any person on roller skates, coaster sled, or any other type of conveyance not designed to be towed by a bicycle, e-bike, electric scooter or electric personal assistive mobility device.
- D. Obedience to traffic control devices. Any person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall obey the instructions of all official traffic control devices unless otherwise directed by a law enforcement officer.
- E. Stopping, turning and signaling.
  - (1) Signal required. No bicycle, e-bike, electric scooter or electric personal assistive mobility device operator shall suddenly stop, slow down, or turn without giving proper signal, or when the vehicle or device is not equipped with traffic signals by the manufacturer, an arm signal is required by state law for the operation of vehicles or devices on roadways. No person shall turn a bicycle, e-bike, electric scooter or electric personal assistive mobility device into an intersection unless the bicycle, ebike, electric scooter or electric personal assistive mobility device is in proper position upon the roadway or turn to enter a private roadway or driveway unless the bicycle, e-bike, electric scooter or electric personal assistive mobility device is in proper position on the roadway as required or suddenly turn a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon a roadway unless and until such movement can be made with reasonable safety. If other traffic may be affected by such movement, no person shall so turn any bicycle, e-bike, electric scooter or electric personal assistive mobility device without giving an appropriate signal in the manner provided. Such signal shall be given continually during not less than 50 feet before turning. When given by arm and hand signals, such signals shall be given from left side of bicycle, e-bike, electric scooter or electric personal assistive mobility device in the following manner and shall indicate as follows:
    - (a) Left turn: hand and arm extended horizontally.
    - (b) Right turn: hand and arm extended upward.

- (c) Stop or decrease speed: hand and arm extended downward.
- (2) Prohibited turns. Whenever a uniform traffic control device indicates that no right or left turn or U-turn is permitted, no person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall disobey the direction of such device, except after dismounting from the bicycle, e-bike, electric scooter or electric personal assistive mobility device to make such turn, in which event said person shall then obey the regulations, ordinances and laws applicable to pedestrians.
- (3) Right turns. Every person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device intending to turn to the right at an intersection, alley, or driveway shall approach the turning point in the line of traffic nearest the right-hand curb of the street.
- (4) Left turns. Every person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device intending to turn left at an intersection or to enter an alley or driveway shall approach the point of turning in that lane farthest to the left which is lawfully available to traffic moving in the direction of travel of the bicycle, e-bike, electric scooter or electric personal assistive mobility device about to turn left, unless otherwise directed by official traffic control devices. At intersections where traffic is moving in the opposite direction, if it is not safe for the operator to make a left turn as above-described, he or she shall stay in the right-hand lane and drive to the opposite corner, dismount and walk the bicycle, e-bike, electric scooter or electric personal assistive mobility device operator may also make a left turn by driving to the opposite corner and then turning left and driving in a normal driving position.
- (5) Use of crosswalks. Crosswalks shall be used when walking a bicycle, e-bike, electric scooter or electric personal assistive mobility device through an intersection.
- F. Speed. No person shall operate a bicycle, e-bike, electric scooter or electric personal assistive mobility device at a speed greater than is reasonable and prudent under existing conditions or in excess of any posted speed limit. No person may operate a bicycle, e-bike, electric scooter, electric personal assistive mobility device, or other vehicle off roadway but on property owned by the city, including but not limited to City parks and public recreation trails, in excess of 15 mph.
- G. Clinging to moving vehicles. It shall be unlawful for any person riding upon a bicycle, ebike, electric scooter or electric personal assistive mobility device to cling or attach themselves to a bicycle, e-bike, electric scooter or electric personal assistive mobility device to any moving vehicle.
- H. Single file riding. Every person when operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device on a public highway shall ride such bicycle, e-bike, electric scooter or electric personal assistive mobility device in a single file and at no time shall ride two or more abreast.
- I. Racing. No person operating a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall participate in any race, speed or endurance contest with another bicycle, e-bike, electric scooter or electric personal assistive mobility device or with any other vehicle on a City street, public recreation trail, or on property owned or leased by the City, except in connection with a special event upon permission granted by the City Council after a report by the Chief of Police.
- J. Removal of hands from handlebars. No person operating a bicycle, e-bike, electric scooter

or electric personal assistive mobility device shall remove both hands from handlebars or feet from pedals nor practice any fancy or acrobatic riding or stunts in the operation of said bicycles, e-bikes, electric scooters or electric personal assistive mobility devices.

- K. Lights; reflectors. No person may operate a bicycle, e-bike, electric scooter or electric personal assistive mobility device upon a highway, bicycle lane or bicycle way during hours of darkness unless such bicycle, e-bike, electric scooter or electric personal assistive mobility device is equipped with or the operator is wearing a lamp emitting a white light visible from a distance of at least 500 feet to the front of such bicycle, e-bike, electric scooter or electric personal assistive mobility device. Such bicycle, e-bike, electric scooter or electric personal assistive mobility device shall also be equipped with a red reflector that has a diameter of at least two inches of surface area on the rear, so mounted and maintained as to be visible from all distances from 50 to 500 feet to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle. A lamp emitting a red light visible from a distance of 500 feet to the rear may be used in addition to, but not in lieu of, the red reflector.
- L. Operation on roadway edge. The rider of a bicycle, e-bike, electric scooter or electric personal assistive mobility device shall ride as near as practicable to within five feet of the right-hand curb or edge of the roadway, except when passing another vehicle or in making a left-hand turn in an intersection.
- **SECTION 9.** That Section 8-3-9 of the Municipal Code shall hereby be amended as follows:

### Parking.

No person shall park any bicycle, e-bike, electric scooter or electric personal assistive mobility device against windows or in the main traveled portion of any sidewalk or highway nor in such manner as to constitute a hazard to pedestrians, traffic or property. If there is no bicycle rack or other facility intended to be used for the parking of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices in the vicinity, the operator may park a bicycle, e-bike, electric scooter or electric personal assistive mobility devices device on the sidewalk in the upright position parallel to and within 24 inches of the curb.

**SECTION 10.** That Section 8-3-10 of the Municipal Code shall hereby be amended as follows:

### Operation on sidewalks.

- A. No person shall operate any bicycle, e-bike, electric scooter or electric personal assistive mobility device on any sidewalk within the City, except bicycles with wheels 20 inches in diameter or less in residential areas for the purpose of learning, or bicycles being operated by a Police Bicycle Patrol Officer or other city vehicle operating within the performance of his city duties.
- B. Bicycles, e-bikes, electric scooters or electric personal assistive mobility devices may be operated on bridge sidewalks, but shall maintain the right-of-way to pedestrians.
- C. Notwithstanding Subsection A hereof, the City Council may, by motion or resolution, permit the operation of bicycles, e-bikes, electric scooters or electric personal assistive mobility devices on designated sidewalks of the City, in its discretion, when it believes permitting such operation is appropriate and consistent with public health and safety. Copies of any such resolution or motion shall be maintained at the office of the City Clerk and shall be available for public inspection during normal office hours. Such permission shall be subject to signage or other requirements imposed by applicable law.

**SECTION 11.** That Section 8-3-11 of the Municipal Code shall hereby be amended as follows:

### Violations and penalties.

Any person who shall violate any of the provisions of this chapter shall be punished by any of the following

methods, subject to the requirements of state law:

A. Any person over the age of 12 who violates any provision of this chapter shall be subject to the following penalties:

- (1) First offense penalty shall forfeit not less than \$5 nor more than \$1,500.
- (2) Second offense penalty shall forfeit not less than \$10 nor more than \$1,500.
- (3) Third offense penalty shall forfeit not less than \$20 nor more than \$1,500.

Two Rivers Municipal Ordinance 9-9: Sexual Offender Residency Restrictions was adopted on December 7<sup>th</sup>, 2015. This ordinance was modified on August 16, 2021, creating and expanding various provisions. Recent events identified that 9-9-3 A. related to "Domicile Restrictions" could be interpreted and therefore applied in a manner inconsistent with the original intent of that provision.

The following items are suggested to be included in an ordinance amendment:

- 9-9-2 Definitions, Section D. "Permanent Residence" Amend the definition to read: "The place where a person sleeps, abides, lodges or resides for 14 or more consecutive days and which qualifies as a residence under the laws of the State of Wisconsin, and the ordinances of the City of Two Rivers."
- 9-9-3 Domicile Restrictions, Section A. Amend to read: "Residency prohibited. No offender shall be permitted to reside in the City, and no supervised release of such offender shall be established in the City, unless the offender was domiciled as a permanent residence as defined above in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five (5) years and that such residency has not lapsed for 10 or more years."

The proposed amendments address the potential circumstance of a person simply visiting or passing through the City, committing a sex offense and subsequently having the ability, as a convicted sex offender, to establish residency in the City of Two Rivers. The aforementioned recommendations have been added to a draft revised ordinance for presentation to the City Council.

## Chapter 9-9

# **Sexual Offender Residency Restrictions**

## § 9-9-1 Findings and Purpose.

- A. The Wisconsin Statutes provide for the punishment, treatment and supervision of persons convicted or otherwise responsible for sex crimes, including their release into the community.
- B. Chapter 980, Wis. Stats., provides for the civil commitment of sexually violent persons, a more dangerous type of sex offender due to their likelihood to reoffend, and specifically, § 980.08, Wis. Stats., provides for the supervised release of such persons into the community.
- C. The City of Two Rivers places a high priority on maintaining public safety through highly skilled and trained law enforcement and laws that deter and punish criminal behavior.
- D. The City finds that sex offenders, who prey upon others, particularly children, are a serious threat to public safety and it is necessary for the City to enact reasonable measures to minimize the risk of the public in the City falling prey to sexual offenders.
- E. Further, this chapter is a non-punitive, regulatory measure aimed at protecting the health and safety of those in the City from the risk that convicted sex offenders may reoffend. It is the intent of this chapter not to impose a criminal penalty but rather to serve the City's compelling interest in promoting, protecting and improving the health, safety and welfare of the citizens and visitors of the City.

### § 9-9-2 Definitions.

As used in this chapter, and unless the context requires otherwise:

### A. "Crime Against Children"

Any of the following offenses set forth within the Wisconsin Statutes, as amended, or the laws of this or any other state or the federal government having like elements necessary for conviction, where the victim is under the age of 18, respectively:

## B. "Facility for Children"

A public or private primary or secondary school; a church, synagogue, or house of worship as zoned by the City; a group home, as defined in § 48.02(7), Wis. Stats.; a residential care center for children or youth, as defined in § 48.02(15d), Wis. Stats.; a shelter care facility, as defined in § 48.02(17), Wis. Stats.; a day-care center licensed under § 48.65, Wis. Stats.; a day-care program established under § 120.13(14), Wis. Stats.; or a day-care provider certified under § 48.651, Wis. Stats.

## C. "Offender"

A person who has been convicted of or who has been found not guilty by reason of disease or mental defect of a "sex offense" as defined § 301.45 (b) Wis. Stats. and/or crime against children, and required to be registered with the Wisconsin Sex Offender Registry under § 301.45 (1g) Wis. Stats, who was tried as an adult; or who was deemed an offender under Ch. 980, Wis. Stats.

## D. "Permanent Residence"

The place where a person sleeps, abides, lodges or resides for 14 or more consecutive days or and which qualifies as a residence under the laws of the State of Wisconsin, and may be mobile or transitory and the ordinances of the City of Two Rivers.

## E. "Property Owner"

The owner of rental property, camp grounds, hotel/motels, apartment complexes, or any temporary lodging facility or space.

## F. "Sexually Violent Offense"

Shall have the meaning as set forth in § 980.01(6), Wis. Stats., as amended from time to time.

## G. "Temporary Residence"

Residence or premises meeting any of the following criteria:

(1) A place where the person sleeps, abides, lodges or resides for a period of 14 or more days in t

aggregate during any calendar year, and which is not that person's permanent resi defined in this section;

- (2) A place where the person routinely sleeps, abides, lodges or resides for a period of four or more consecutive or nonconsecutive days in any month, and which is not that person's permanent residence as defined in this section; or
- (3) A place where a person sleeps, or which qualifies as a temporary residence under the holdings of the Wisconsin Supreme Court, and which may include more than one location, and may be mobile or transitory.

## § 9-9-3 Domicile Restrictions.

- Residency prohibited. No offender shall be permitted to reside in the City, and no supervised release of A. such offender shall be established in the City, unless the offender was domiciled as in a permanent residence as defined above in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five (5) years and that such residency has not lapsed for 10 or more years.
- Exemptions. An offender does not commit a violation of this chapter if any of the following apply: B.
  - (1) The offender is required to serve a sentence or is otherwise involuntarily required to reside in a jail, prison, juvenile facility, or other correctional institution or mental facility located in the City of Two Rivers.
  - (2) The offender has established a residence prior to the effective date of the ordinance codified in this section.
  - (3) The offender is a minor or ward under guardianship.
  - (4) The residence is also the primary residence of the person's parents, grandparents, siblings, spouse, or child, provided that such parent, grandparent, sibling, spouse, or child established the residence at least five (5) years before the designated offender intends to establish residence at the location.
- C. It is unlawful for a property owner to let, rent, or lease any place, structure, or part thereof, trailer, other conveyance, if the property owner knows or should have known that it will be used as a permanent or temporary residence by any offender prohibited from establishing residency in the City under the provisions of this ordinance. Factors in considering whether a property owner knows or should have known an offenders status is the presence of the offender's name listed on the State of Wisconsin's Sex Offender Registry which is readily available to public inspection on the State's web-site.

## § 9-9-4 Notification.

Offenders subject to this ordinance shall notify property owners of their offender status prior to entering A. into any room rental, apartment rental, lease, or property purchase for the purpose of establishing residency whether temporary or otherwise.

B. Property owners who become aware that there property is being occupied by an offende Section 11, ItemD. this ordinance shall notify the Chief of Police of such residence on their property, either temporary or permanent. Such notice shall be verbally or in writing.

## § 9-9-5 Public Places

A. It is unlawful for an offender, as defined by § 9-9-2, to loiter or prowl, as said words are used in § 9-2-4 of this Code or to be, in a manner or in circumstances manifesting an intent to commit a "sex offense" as defined in Wis. Stat. Section 301.45(b) and/or a crime against children, under the following circumstances:

Within 500 feet of real property that supports or upon which there exists a facility for children, a public park/beach, a public swimming pool, a public library, or a public recreational trail; or

B. Attend public events that are children focused, engage in trick or treating festivities, or engage in the wearing of costumes in public where the wearing of such costume is likely to attract children.

## § 9-9-6 Appeal.

The residency restrictions of this chapter may be waived upon approval of the City Council through an appeal by the affected offender. Such appeal shall be made, in writing, to the City Clerk, who shall forward the request to the City Manager and the Chief of Police. The Chief of Police shall forward a report on the appeal request to the City Council. The City Council will convene within 30 days of the appeal being filed with the Clerk to hear from the Chief of Police and the affected offender or their counsel. After deliberation, the City Council shall act on the recommendation. A written copy of the decision shall be provided to the affected offender by the City Clerk. The City Council may reject a waiver request when the request is filed with the City Clerk within 90 days of denial by the committee of a prior identical waiver request of the requester, absent a change in circumstances.

## § 9-9-7 Violations and penalties.

Any person found guilty of violating this chapter shall be penalized by forfeiture not less than \$100 and not to exceed \$1,000 plus court costs. Each day an offender maintains a residence in violation of this chapter constitutes a separate violation. The City may also seek equitable relief.

## § 9-9-8 Severability.

Should any portion of this chapter be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this chapter shall not be affected.

## ORDINANCE

**AN ORDINANCE** to amend Municipal Code Section 9-9-2(D) entitled "Permanent Residence"; and 9-9-3 (A) entitled "Domicile Restrictions".

The Council of the City of Two Rivers ordains as follows:

- **SECTION 1.** That Section 9-9-2(D) of the Municipal Code shall hereby be amended as follows:
  - (D) The place where a person sleeps, abides, lodges or resides for 14 or more consecutive days and which qualifies as a residence under the laws of the State of Wisconsin, and the ordinances of the City of Two Rivers.
- **SECTION 2.** That Section 9-9-3(A) of the Municipal Code shall hereby be amended as follows:
  - (A) Residency prohibited. No offender shall be permitted to reside in the City, and no supervised release of such offender shall be established in the City, unless the offender was domiciled as a permanent residence as defined above in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five (5) years and that such residency has not lapsed for 10 or more years.
- **SECTION 3.** This ordinance shall take effect and be in force from and after its date of passage and publication of same.

## SUBJECT: PROPOSED TERMS FOR COOPERATIVE AGREEMENT BETWEEN THE CITY AND COOL CITY BREWING COMPANY

Attached is an updated version of the proposed terms for a cooperative agreement between the City and Cool City Brewing Company (CCB). As you are aware, the intent of such an agreement is to present a "win-win" arrangement as it relates to off-street parking lots owned by the two parties. (City's Community House lot at the SE corner of Adams and 18<sup>th</sup> and CCB's parking lot on the west side of Adams Street, south of 18<sup>th</sup>.)

This summary of terms has been revised to reflect feedback received from the City Council at the work session on March 28. Specifically:

- Language has been added to require that servicing of a CCB dumpster to be located on City property near the City dumpster be done before 7:00 AM, as is the case with the City's dumpster.
- Parking spaces now reserved for City vehicle parking in the City lot would be signed for "Public Parking" versus CCB customer parking, as had been requested by CCB. These spaces would, however, be posted as public parking with a two-hour limit, so they are not used for all-day parking.
- The balance of the City parking lot will be signed for Community House and Senior Center parking, weekdays 8:00 AM to 4:30 PM (hours were left blank in earlier draft).
- Commitment for City to place protective bollards around the City's ground-mounted transformer, located adjacent to City lot) have been added.

The proposed terms do not reflect a provision for the City to bill CCB for its share of the cost of plowing the CCB-owned lot on the west side of Adams Street, which is something the Council expressed a preference for. CCB had concerns about that proposal and—honestly—it will only take 3-4 trips across the parking lot with a pickup truck and plow to keep it cleared. In the interest of compromise, I have left snowplowing a City responsibility, but added a provision that CCB will be responsible for all other maintenance on that parking lot.

The development project planned by CCB is a major investment, one that has the potential to be hugely beneficial to our downtown—including the potential for increased rentals and events at the Community House, with a large eating and drinking venue right next door. The terms presented in the attached sheets are reasonable, and represent a good faith effort by neighboring property owners to work together. If something doesn't work out, the two parties can try to work it out, or the proposed agreement can be cancelled, with appropriate notice.

I recommend approval of the terms as stated.

--For City Council at March Work Session

- Allow CCB to place a 6-yard dumpster near the City's current dumpster location in Community House parking lot.
- Determine frequency of pickups, based on volume, frequency of pickups (Manitowoe Disposal); pickups must be before 7:00 AM, as with City's pickup
- City dumpster will be locked; all CCB refuse to go in CCB dumpster.
- City to relocate shed to accommodate dumpster; shed to be placed in southwest corner of the CCB-owned parking lot on Adams Street.
- CCB to allow City to park vehicles in 10 designated spaces in CCB's Adams Street lot.
- City to <u>designate as "Public Parking, Two Hour Limit" allow CCB dedicated the 10 parking spaces</u> along east wall in Community House parking lot, currently occupied by City vehicles (10 spaces).
- OtherBalance of Community House parking lot to be signed as public parking on evenings (after 4:30 PM) and on weekends
- CCB and City to cooperate in working with contractor to stripe lots (each to pay the cost for striping their own lots)
- Signage designating CCB and Public parking, Community House and Adams Street lots signs to be fabricated and installed by City, with cost of signs and installation split 50/50 with CCB.
- <u>City to install protective bollards to protect ground-mounted electrical transformer</u> located near dumpsters, at City cost.
- <u>CCB to Ww</u>ork with City when Senior Center trips require long term parking)
- CCB plans to add signs to lot at NE corner of 18<sup>th</sup>/Adams lot, designating Employee only parking (City has no responsibilities relative to this lot).
- City to take care of all snow maintenance on Community House and <u>CCB</u>
- Adams Street lots: CCB will ber responsible for all other maintenance work (such as patching, striping, etc.) on the Adams Street lot.
- Put in the form of a 5-year letter of agreement, with either party able to terminate the
  agreement at its sole discretion on 12 months notice.


