- 2. Roosevelt Avenue Construction Update

Mr. Buckley reported the pavement removal between Lowell Street and 9th Street has been completed. Sanitary laterals and water services between 10th Street and 12th Street have been completed. The contractor will be resuming sanitary sewer construction between Lowell Street and 10th Street and storm sewer construction between 10th Street and 12th Street.

3. 2024 Scattered Lead Service Lateral Replacements Project Update Mr. Buckley reported notification letters were sent out Friday, June 7, 2024, notifying affected residents. Contractor Mammoth Construction is expected to begin work mid-Summer 2024 and complete the contract in Summer 2025. Residents will be contacted to set up appointments to check existing service materials and determine estimated costs for replacement, if needed. Approximately 300 services are to be replaced under this contract.

4. Room Tax Update

Mr. Buckley reported the Wisconsin Department of Tourism recently released 2023 economic impact data, showing that Wisconsin and Manitowoc County tourism experienced a recordbreaking 2023. Tourism's economic impact topped \$25 billion statewide (5.4% from 2022), and \$226 million in Manitowoc County (up 4.2% from 2022). Explore Two Rivers is dedicated to the promotion of tourism and playing a significant role in growing our local economy.

5. Downtown Yarn Bombing

Mr. Buckley reported the Downtown Yarn Bombing will be installed on Wednesday, June 26. There is an increased number of participants in 2024 compared to 2023.

6. Summer Reading Program at Lester Public Library

- 7. New Play Equipment and Site Furnishings at Washington Park
- Mr. Buckley reported the new play equipment at Washington Park is open and ready for you to come and play.
- 8. New SwimSmart System at Neshotah Beach
- Mr. Buckley reported the new SwimSmart Beach Alert System has been installed at Neshotah Beach. Three alert displays provide real-time information, direct from the National Weather Service: one at the intersection of Pierce Street and Zlatnik Drive; one along Neshotah Beach, and another at the beach next to the North Pier and Coast Guard Station. \$30,000 funding for the system was provided by the City's Room Tax Commission, which recognizes Neshotah Beach as one of Two Rivers' primary visitor attractions.
- 9. Plans and Bid Letting for Infrastructure for Sandy Bay Highlands Subdivision Phase 3 Mr. Buckley reported the project has seen roadblocks, obstacles and delays but it has now gained traction and is moving forward. McMahon is finalizing stormwater aspect of the project and will submit for WDNR permitting by June 14. Engineering is wrapping up the utility and roadway design and preparing bid/contract documents. The City will be submitting utility plans for WDNR approval by June 21. Advertisements for bids will be on June 26 & July 3 with bid opening on July 10 and planning to award the contract at the Council meeting on July 15. The best case scenario would be construction starting around September 1, but the home at the corner of Lake Breeze Way and Orchard Lane is in the Manitowoc County Parade of Homes which is September 12-14 and Engineering feels that is would be best to hold off construction until after this event. Therefore, looking at the start of construction to occur September 16, 2024. The goal is to have a graveled surface by Thanksgiving.

Call to Order

In the absence of Chair Greg Coenen, The meeting was called to order by Vice Chair Keith Lyons at 5:17 PM.

Roll Call

BIDC members present were Betty Bittner, Tom Christensen, David Kalista, Tracey Koach, Keith Lyons, Shannon Derby and Scott Stechmesser. BIDC members absent and excused: Dan Wettstein. One vacancy at this time.

CDA members present were Betty Bittner, David Kalista, Tracey Koach, Keith Lyons, Shannon Derby and Scott Stechmesser. CDA members absent: Gerg Coenen.

Others present were Greg Buckley, City Manager and Matt Heckenlaible, Public Works Director/City Engineer.

Updates on Various Community Development Projects

The City Manager presented an informational update on several community development projects and activities. He noted that not all of these projects/activities directly involve the BIDC and/or CDA, but all are related to community development and redevelopment.

The report, presented as a Powerpoint presentation by the City Manager, included:

- A progress report on the Braun truss plant at the Woodland Industrial Park, a \$1.2 million project being assisted with a developer grant from TID 15. Buckley noted that this project was approved for a \$500,000 City loan by the CDA, but the company now indicates that it will not be using that loan financing. Grading work on the Browns Drive site was completed in April, and building construction is expected to start in July.
- An update on the proposed Hawk Battery Energy Storage project at the Woodland Industrial Park. The Plan Commission and City Council approved a conditional use permit for the project in March 2024; Buckley noted that site plan review and consideration of variances from the Woodland Industrial Park covenants will be on the BIDC's agenda for July or August 2024.
- Other recent interests in the Woodland Industrial Park, including the right of first refusal on a 2 acre expansion site that is held by WG&R Bedding, and a recent inquiry from an area firm looking at a new 8-10,000 SF facility.
- Violet Inn, a proposed \$1.2 million redevelopment of the former Elks Club building on 16th Street. The City Manager noted that this project was previously approved for a \$200,000 City loan by the BIDC. In May, the City Council and TIF Joint Review Board approved an amendment to the TID 12 project plan and boundaries that would allow for a \$130,000 developer grant to this project; the developer is also expected to apply for a façade grant. Construction is expected to start later this year.
- Sauve's Auto Service expansion project. This project will involve construction of three additional service bays and office space at Sauve's, a project estimated at \$700,000. The

- recently-approved amendment to the TID 12 Project Plan allows for a possible developer grant of \$150,000 to assist this project. Mr. Buckley noted that BIDC member Tom Christensen is the owner of Sauve's Auto Service, but no assistance to the project is being sought through the BIDC, nor the CDA.
- City and Main Street Grants for Business Façade Projects. The City Manager reported on recent façade grants to assist projects at Meridian Wellness on Lincoln Avenue, the Hook Lanes and Games on Washington Street and the Kouba building at 1606 Washington Street (location of Crafty Cravings and The Chop Shop).
- Other. The City Manager also gave updates on two proposed apartment developments that have seen delays but continue to be pursued: the 54-unit affordable housing project West River Lofts and 71-unit market rate project The Confluence.

Status of Economic Development Revolving Loan Fund

Buckley reported that the three current active loans are each current on payments, with outstanding principal balances as follows:

Lambo Properties \$ 24,112
 Sleger Holdings, LLC \$157,525
 TA Properties \$ 96,853

He further reported that the cash balance in the Loan Fund is \$1,174,726. Of that amount, \$200,000 is reserved for a loan to the Violet Inn project.

Status of Sandy Bay Highlands Subdivision Phase 3 Project

The City Manager and Mr. Heckenlaible gave an update on plans for the next phase of the subdivision, for which \$1 million is budgeted in the City's 2024 Budget. Plans are out for bid, with bid opening scheduled for July 10 and possible City Council action on award of contract on July 15.

<u>Discussion With Public Works Director Matt Heckenlaible Regarding Possible Location for Public Works Material Storage and Processing on City-Owned Lot at 2701 18th Street in Columbus Industrial Park (Cell Tower Site)</u>

Mr. Heckenlaible presented a proposed site plan for use of the lot for storage of various materials at this site. He also distributed and reviewed a memo prepared by City Planner Elizabeth Runge, addressing zoning and industrial park covenants related to the proposed use.

He noted that relocating this storage and processing activity to the industrial park site would allow the City to move such activities off the downtown lakefront adjacent to the public works garage, consistent with the City's plans to upgrade that area for public access, recreational use and habitat restoration. The referenced material processing is crushing of concrete from street projects for re-use as gravel; this normally takes 2-3 days, once a year. He also addressed plans for fencing and screening at the industrial park site.

Mr. Buckley noted that this proposal would not interfere with the site's continued use as a cell tower location—U.S. Cellular pays the City an annual lease fee for its use of that portion of the site that is devoted to its tower and facilities.

He also stated that the presentation at this meeting is for information only and that he would like to schedule formal action by the BIDC at the July or August meeting. The proposed action would be to waive certain industrial park covenants pertaining to construction of buildings on industrial park sites, as no building is proposed in conjunction with this municipal use. He added that he would want to inform

the owners of the adjacent industrial park properties of this matter and invite them to such a meeting.

Adjournment of the Business and Industrial Development Committee

Betty Bittner moved, supported by Scott Stechmesser, to adjourn the BIDC meeting at 6:10 PM The motion was approved by voice vote, without dissent. Mr. Christensen left the meeting at this time.

Closed Executive Session of the Community Development Authority

Betty Bittner moved, supported by Scott Stechmesser, to enter closed session at 6:11 PM.

The meeting chair, Mr. Lyons, noted that, as stated on the agenda, the purpose of the closed session was to consider an offer received for the purchase of Block 3, Lot 11 in the Sandy Bay Highlands Subdivision. Mr. Buckley noted that the offer is for an amount less than the CDA's asking price for the lot, which is significantly impacted by a wetland located within its boundaries; thus, the need for closed session discussion.

The motion was approved by a roll call vote. Voting yes: Betty Bittner, Tom Christensen, David Kalista, Tracey Koach, Keith Lyons, Shannon Derby and Scott Stechmesser. Voting no: none.

Reconvene in Open Session; Consider Possible Action by the CDA in follow-up to closed session discussions

Scott Stechmesser moved, supported by Shannon Derby, to adjourn the closed session and reconvene in open session at 6:22 PM.

The motion was approved by voice vote, without dissent.

Tracey Koach moved, supported by Betty Bittner, to accept the offer to purchase the parcel in question, at a purchase price of \$35,000 (lower than the list price of \$42,000 for this parcel), with the Buyers' additional condition that the Buyers have up to 90 days to close, with closing contingent upon the Buyers being able to work out a home design with their contractor that they deem satisfactory. Further, with acceptance of the Buyer's condition that the City mow the wetland buffer area located on the property, within 30 days following the CDA's acceptance of the offer.



RESOLUTION PROCLAIMING JULY 13, 2024 AS BRYAN LEE DAY IN THE CITY OF TWO RIVERS

WHEREAS, Bryan Lee, a.k.a. the Braille Blues Daddy, Blind Giant of the Blues, a New Orleans Blues Institution, was born March 16, 1943 in the City of Two Rivers, Wisconsin and passed away at the age of 77 on August 21, 2020 in Sarasota, Florida; and

WHEREAS, Bryan Lee made the world a better place by dedicating his life to, and sharing, his God-given musical talent and love of early rock and blues, living by the creed that "A gift is not a gift unless you share it;" and

WHEREAS, Bryan Lee began performing professionally at the age of 13 in his hometown of Two Rivers, and continued playing all over the world, touring in the Midwest, Eastern Seaboard, Rocky Mountain States, Canada, Europe and Brazil until the year 2020; and

WHEREAS, Bryan Lee recorded 18 albums over 4 decades, bookended by 1979's *Beauty Isn't Always Visual* and 2018's *Sanctuary*, appearing on various labels that included Justin Time, Severn Records and Earrelevant Records; and

WHEREAS, Bryan Lee's achievements included a 2011 Grammy nomination with Kenny Wayne Shepherd, 2008 German Critics Award for Outstanding Blues for "Katrina Was Her Name," 2011 BMA Blues Rock Album of the Year, 2015 Big City Rhythm and Blues Lifetime Achievement Award, 2016 Legendary Blues Artist - Blues Hall of Fame, 2016 Legendary Blues Artist - Florida Blues Hall of Fame, 2017 WAMI Lifetime Achievement Award, 2018 Phoenix Radio Lifetime Achievement Award, and numerous Blues Societies Awards; and

WHEREAS, Bryan Lee was a remarkable soul who greeted each day with gratitude, optimism, and humble joy for all his blessings and gave immeasurable musical enjoyment to his legion of worldwide fans:

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Two Rivers, declares July 13, 2024, the date of the fourth annual Bryan Lee Memorial Blues Festival, as:

RESOLUTION REGARDING AD HOC AQUATICS COMMITTEE REPORT AND SETTING CONDITIONS FOR POSSIBLE PLACEMENT OF A REFERENDUM QUESTION SEEKING VOTER APPROVAL TO EXCEED THE CITY'S LEVY LIMIT TO HELP FUND OPERATION OF A COMMUNITY POOL

WHEREAS, in response to community concerns about the closing of the private, not-for-profit Two Rivers Family Swim Center, the City Council by resolution adopted in February 2024 authorized creation of an *ad hoc* citizen committee to address community aquatics needs and options to help fill the void created by the closure of that nearly sixty year-old facility; and

WHEREAS, that resolution identified several topics to be researched by that ad hoc committee, working with Parks and Recreation staff, with deliverables intended to assist the City Council and the community in making decisions on meeting community aquatics needs; and

WHEREAS, appointments to a ten-member citizen committee were proposed by the Parks and Recreation Director and the City Manager and were approved by the City Council in March 2024; and

WHEREAS, the *ad hoc* committee began its work in April 2024, completed that work expeditiously, and presented a report to the City Council on June 24, 2024; and

WHEREAS, that report supports the concept of building a new community pool, as a major quality of life asset for Two Rivers that will benefit residents of all ages and be especially beneficial in attracting and retaining young families in the community; and

WHEREAS, while the committee's recommendations include relying on private fund-raising and grants to provide capital funding for a community pool, a key issue to be addressed in advance of any capital drive is whether the residents of the City of Two Rivers support paying additional property taxes to help fund the ongoing operation and maintenance of such a facility; this is because research shows that community pools almost without exception require significant taxpayer support for operations and maintenance costs; and

WHEREAS, the committee's report also includes a recommendation that the City Council "direct a professional feasibility study to be completed to provide certain key information prior to going to referendum," with the cost of such study to be funded by a local 501(c)3 organization: a friends group. Some members of the ad hoc committee, along with area residents associated with the Family Swim Center, have expressed willingness to create such an organization and pursue the funding needed for such a study;

NOW, THEREFORE, in the interest of providing more complete information to the community to aid in its decision-making, the City Council hereby states its concurrence with the ad hoc committee

recommendation that a local not-for profit organization be encouraged to pursue such funding, estimated at \$20,000 to \$40,000, to undertake a professional feasibility study regarding a community pool; and

BE IT FURTHER RESOLVED, that the City Council hereby states its intent to cooperate with any such community organization in determining the scope of services for such a feasibility study, and in reviewing the results of that study, with the intent to determine whether it is appropriate to place on the Spring 2025 Election ballot a measure seeking voter approval to exceed the City's statutory tax levy limit, as provided in Section 66.0602(4) Wis. Statutes, to provide a specified amount of property tax support (estimated at up to \$100,000) for a community pool operating budget; and

BE IT FURTHER RESOLVED that, in order for the City Council to consider action placing such a measure on the Spring 2025 ballot, the scope of services for said feasibility study must be agreed upon by July 31, 2024, a consultant must be selected and under contract by August 31, 2024, and the study completed and presented to the City not later than October 15, 2024; otherwise, the target date for such ballot measure must be postponed to a later date; and

BE IT FURTHER RESOLVED, that this action in no way represents a commitment by the City Council to use taxpayer funds for the construction of a community pool, nor to ask the voters to support such a commitment; rather, it represents a further commitment to engaging with advocates for a community pool to gauge the financial feasibility and community support for what would be a major investment by the Two Rivers community; and

BE IT FURTHER RESOLVED, that the City Council expresses its thanks to the members of the ad hoc Citizen Committee on Community Aquatics and to City staff who have assisted that committee in advancing this issue to date.


Priorities


- 1. Revitalize the riverfront with access for fishing, paddling, wildlife viewing, walking, and other leisure activities.
- 2. Renovate and reopen the park restrooms and add a picnic shelter facility.
- 3. Create a concrete skate park with a pump track that is closer 14th St.
- 4. Remove impermeable surfaces, especially those near the riverfront, plant trees and native plants to beautify the park, and improve habitat and stormwater management.
- 5. Relocate parking alongside River Place and School St. to improve visibility and to make the park feel more welcoming.
- 6. Improve safety and make the park more welcoming with improved lighting, security cameras, and better site lines.
- 7. Expand the playground equipment.

Funding Strategies

- 1. Wisconsin DNR annually has grants available through their Knowles-Nelson Stewardship Program for park improvement projects. These grants are highly competitive, and they often require a 50/50 funding match. The park's design and priorities align well with the stated goals for the grant program.
- 2. The State of Wisconsin Department of Administration manages the Wisconsin Coastal Management grant program. These grants support improvements along Lake Michigan and its connecting tributaries. The grants are highly competitive and require matching funds. The park's design and priorities align well with the stated goals for the grant program.
- 3. Fundraising from community organizations, individuals, businesses, and foundations will be an important strategy for developing the park, especially the skating facilities.
- 4. On an annual basis the City of Two Rivers borrows money to support capital improvements. The Parks and Recreation Department also plans for smaller improvement projects within the annual operating budget. Stewarding these resources in a responsible manner is important.

Q1 Are you a resident of the City of Two Rivers?



Q2 What is your age?



Q3 Do you have children living in your household? (Select all age ranges that apply.)


