7. COUNCIL COMMUNICATIONS

Letters and other communications from citizens

Councilmember Dahlke communicated several complaints he received since the last meeting:

- The traffic speed on Adams Street south of 27th Street is excessive.
- A pothole on Adams Street where there was water work done is getting worse. Mr. Buckley suggested calling or emailing his office about such matters, for a more timely response.
- There was trash at a property on Monroe Street for 26 days without any follow-up and questioned why the City is not following its ordinances.
- The restrooms at Walsh Field were not open when there was a ballgame. Mr. Buckley indicated that there was a communication shortfall between the School District and the Rec Department, and the issue has been resolved going forward.
- The Council meetings have not been live on Spectrum recently. Mr. Buckley indicated that
 the Spectrum situation is a known issue and the City's IT department is working to resolve
 the situation. In the meantime, residents are encouraged to watch the Council meetings live
 on YouTube.
- A request for the City Manager's Report to be moved to the end of the Council meetings.

Councilmember Shimulunas questioned whether public hearing notices on zoning matters are being sent to property owners within a 200 feet radius if the property falls outside of the City limits. There is a concern from a resident of the Town regarding the construction of the wind tower in the industrial park. Both City Manager Buckley and Community Development Runge indicated that they are aware of the property owner's concern and are researching the situation. At this time, it appears that the height of the wind tower is below the FAA's regulatory height maximum and within City ordinance height restrictions. Ms. Runge acknowledged that the hearing notices in question were not mailed to property owners in the town, only those in the city.

1. 3000 Forest Avenue Project

Mr. Buckley reported that the City is awaiting final word from the developer of 3000 Forest Avenue on two matters requiring resolution and expects that the May 2 Council agenda will include action on the Development Agreement and related City borrowing from the State Trust Fund.

3. Canine Officer Xanti Plush Toys Available

Mr. Buckley reported that Canine Officer Xanti plush toys are available for purchase at the Two Rivers Police Department for \$20 each. All proceeds benefit the Two Rivers Police Department's canine program.

4. Department of Public Works Crack Sealing Program

Mr. Buckley reported that the Public Works Department has been busy sealing cracks on the City's concrete streets. This process is vitally important to maintain our streets from damage associated with multiple freeze and thaw cycles each Wisconsin winter.

He also reported on other Public Works activities including clearing sand from the landscaped islands on Memorial Drive between Madison and 12th Streets and receiving a supply of 500 tons of road salt for next winter.

5. Staffing Updates

Mr. Buckley reported on upcoming new hires and department transfers. Heather Ihlenfeldt will start as the new Senior Center Supervisor on Monday, April 25. Dalton Schmidt has transferred from Public Works to the Water Department as a Certified Water Operator effective Monday, April 18. Another Certified Water Operator, Tim Elchlepp, will begin on Monday, May 2. A top candidate has been identified for the Parks & Recreation Director position. Other new recruitments include a full-time Public Works Maintenance Worker to fill the position vacated by Dalton Schmidt and part-time Senior Center Volunteer and Nutrition Coordinator.

6. Central Park West Fund-Raising Update

Mr. Buckley reported that the City has received a \$25,000 commitment from Fox Communities Credit Union for a naming gift for the Picnic Island at the Central Park West 365 Project. Since the last Council meeting, total donations committed to the project have increased to just over \$510,000, over 64% of the \$800,000 fundraising goal.

Mr. Buckley reported that based on a pre-application submitted in February, the City was invited to apply for a Save our Great Lakes grant to address City-owned Lake Michigan shoreline along Memorial Drive. The application was submitted on April 15 and proposed activities include plantings for shoreline stabilization, pollinator-friendly plantings, invasive species abatement and control, green infrastructure, and environmental restoration.

Mr. Buckley reported that an application for \$250,000 to assist Trivers, LLC with planned

1. CALL TO ORDER BY CITY MANAGER

The meeting was called to order by City Manager Greg Buckley at 6:01 PM.

2. SWEARING IN NEWLY ELECTED OR RE-ELECTED COUNCILMEMBERS

This Project Plan has been amended in 2003 and 2012 to fund infrastructure projects. The City is proposing a final amendment to fund costs within the district and within one-half mile of the Project Plan boundary.

The proposed Amendment No.3 to TID No. 7 will be used to help finance a share of several construction projects:

- The reconstruction of 17th Street including the replacement of sewer and water utilities to cost \$1,412,134;
- The repaying of Zlatnik Drive estimated to cost \$188,000;
- The resurfacing and replacement of aging sewer and water facilities in Lincoln Street from 17th Street to 22nd Street estimated to cost \$1,388,500;
- Facade improvements for retail and commercial buildings at \$25,000; and
- Administrative, planning, and legal costs estimated at \$10,000.

The total project costs are estimated to be \$3,023,634. It is anticipated that other funding sources, such as WDNR Environmental Loan Funds, will contribute to the costs of the projects listed above.

A new ladder truck is on order and should be ready for delivery in the summer. Year-to-date statistics as of March 2022 were reviewed.

Chief Kohlmeier provided an update on police department operations and indicated the Police Department also has a monthly report that he will distribute via email to Police and Fire Commission members as they become available. The department also plans to do a study on staffing levels and department needs to determine if there is a need to create additional positions. Currently there are five full-time patrol positions open. Candidates have been selected to fill those positions and the positions will be filled with four candidates that are currently completing the recruit academy and one lateral transfer from another department. Briana Propson has been selected to fill the vacant School Resource Officer position at the elementary school. Once the vacant patrol positions are filled and the officers are trained, the department will transfer officers into the vacant sergeant, detective and investigator positions.

PROCLAMATION OF ARBOR DAY APRIL 29, 2022

WHEREAS, in 1872, J. Sterling Morton proposed to the Nebraska Board of Agriculture that a special day be set aside for the planting of trees; and

WHEREAS, this holiday, called Arbor Day, was first observed with the planting of more than a million trees in Nebraska; and

WHEREAS, Arbor Day is now observed throughout the nation and the world; and

WHEREAS, trees can reduce the erosion of our precious topsoil by wind and water, cut heating and cooling costs, moderate the temperature, clean the air, produce oxygen and provide habitat for wildlife; and

Continue the current practice, at regular meetings, of ending the streaming and televising of the meeting when the Council enters into closed session, even if the agenda provides for possible action on matters discussed in closed session upon reconvening in open session (so long as no other action items are listed following the closed session).

Ref: Sex Offender Ordinance Amendments

Two Rivers Municipal Ordinance 9-9: **Sexual Offender Residency Restrictions** was adopted on December 7^{th} , 2015. This ordinance was modified on August 16, 2021, and on April 4, 2022. creating and expanding various provisions. City Council discussion at the April 4 meeting recognized the need to further define what is considered a permanent residence. The following recommendation addresses that issue.

The following items are suggested to be included in an ordinance amendment:

- 9-9-2 (D) Definitions, Section D. "Permanent Residence" Amend the definition to read:
 "The place where the person's habitation is fixed, without any present intent to move, and to
 which, when absent, the person intends to return. A permanent residence does not include
 lodging or other locations where the intended purpose is to temporarily stay. No person gains a
 residence in the city regardless of length of stay while there for temporary purposes only."
- 9-9-2 (G)(1) Temporary Residence Amend to: <u>Temporarily Reside</u> and amend to read:
 "A condition where the person sleeps, abides, lodges or resides for a period of not more than 14 days in the aggregate during any calendar year, and which may include more than one location, and may be mobile or transitory."
- 9-9-3 (A) "Domicile Restrictions" Amend to read:
 "No offender shall be permitted to reside in the City, and no supervised release of such offender shall be established in the City, for more than 14 days in the aggregate during any calendar year unless the offender was domiciled as a permanent resident in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five (5) years and that such residency has not lapsed for 10 or more years.

- 9-9-3 (B) "Exemptions" Add a subsection (5) to read: "(5) Temporarily reside as defined by this section."
- 9-9-3 (C) "Domicile Restrictions" Amend to read:

 "It is unlawful for a property owner to let, rent, or lease any place, structure, or part thereof, trailer, other conveyance, to any person other than to allow such person to temporarily reside in the City as defined in this section, if the property owner knows or should have known that it will be used as a temporary or permanent residence by any offender prohibited from establishing residency in the City under the provisions of this ordinance. Factors in considering whether a property owner knows or should have known an offender's status is the presence of the offender's name listed on the State of Wisconsin's Sex Offender Registry which is readily available to public inspection on the State's web-site.

The aforementioned recommendations have been added to a draft revised ordinance for presentation to the City Council.

Chapter 9-9

Sexual Offender Residency Restrictions

[HISTORY: Adopted by the City Council of the City of Two Rivers (Title 9, Ch. 9, of the 1981 Code). Amendments noted where applicable.]

§ 9-9-1 Findings and purpose.

- A. The Wisconsin Statutes provide for the punishment, treatment and supervision of persons convicted or otherwise responsible for sex crimes, including their release into the community. [Amended 8-16-2021]
- Chapter 980, Wis. Stats., provides for the civil commitment of sexually violent persons, a more dangerous type of sex offender due to their likelihood to reoffend, and specifically, § 980.08, Wis. Stats., provides for the supervised release of such persons into the community. [Amended 8-16-2021]
- The City of Two Rivers places a high priority on maintaining public safety through highly skilled and trained law enforcement and laws that deter and punish criminal behavior.
- The City finds that sex offenders, who prey upon others, particularly children, are a serious threat to public safety and it is necessary for the City to enact reasonable measures to minimize the risk of the public in the City falling prey to sexual offenders. [Amended 8-16-2021]
- Further, this chapter is a non-punitive, regulatory measure aimed at protecting the health and safety of those in the City from the risk that convicted sex offenders may reoffend. It is the intent of this chapter not to impose a criminal penalty but rather to serve the City's compelling interest in promoting, protecting and improving the health, safety and welfare of the citizens and visitors of the City. [Amended 8-16-2021]

§ 9-9-2 **Definitions.**

As used in this chapter, and unless the context requires otherwise:

Stats.; a day-care program established under § 120.13(14), Wis. Stats.; or a day-care provider certified under § 48.651, Wis. Stats.

OFFENDER

A person who has been convicted of or who has been found not guilty by reason of disease or mental defect of a sex offense as defined § 301.45(b), Wis. Stats., and/or crime against children, and required to be registered with the Wisconsin Sex Offender Registry under § 301.45(1g), Wis. Stats, who was tried as an adult; or who was deemed an offender under Ch. 980, Wis. Stats.

[Amended 8-16-2021]

PERMANENT RESIDENCE

The place where a person sleeps, abides, lodges or resides for 14 or more consecutive days or which qualifies as a residence under the laws of the State of Wisconsin, and may be mobile or transitory. The place where the person's habitation is fixed, without any present intent to move, and to which, when absent, the person intends to return. A permanent residence does not include lodging or other locations where the intended purpose is to temporarily stay. No person gains a residence in the City regardless of length of stay while there for temporary purposes only.

PROPERTY OWNER

The owner of rental property, campgrounds, hotel/motels, apartment complexes, or any temporary lodging facility or space.

[Added 8-16-2021]

TEMPORARY RESIDENCE TEMPORARILY RESIDE

Residence or premises meeting any of the following criteria:

- A. A <u>condition</u> place where the person sleeps, abides, lodges or resides for a period of <u>not more than</u> 14 or more days in the aggregate during any calendar year, and which is not that person's permanent residence as defined in this section:
- B. A place where the person routinely sleeps, abides, lodges or resides for a period of four or more consecutive or nonconsecutive days in any month, and which is not that person's permanent residence as defined in this section; or
- C. A place where a person sleeps, or which qualifies as a temporary residence under the holdings of the Wisconsin Supreme Court, and which may include more than one location, and may be mobile or transitory.

§ 9-9-3 **Domicile restrictions.** [Amended 8-16-2021]

- A. Residency prohibited. No offender shall be permitted to reside in the City, and no supervised release of such offender shall be established in the City, for more than 14 days in the aggregate during any calendar year unless the offender was domiciled as a permanent resident in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five years and that such residency has not lapsed for 10 or more years.
- B. Exemptions. An offender does not commit a violation of this chapter if any of the following apply:
- (1) The offender is required to serve a sentence or is otherwise involuntarily required to reside in a jail, prison, juvenile facility, or other correctional institution or mental facility located in the City of Two Rivers.
- (2) The offender has established a residence prior to the effective date of the ordinance codified in this section.
- (3) The offender is a minor or ward under guardianship.
- (4) The residence is also the primary residence of the person's parents, grandparents, siblings, spouse, or child, provided that such parent, grandparent, sibling, spouse, or child established the residence at least five years before the designated offender intends to established residence at the location.

(5) Temporarily reside as defined in this section.

C. It is unlawful for a property owner to let, rent, or lease any place, structure, or part thereof, trailer, other conveyance, to any person other than to allow such person to temporarily reside in the City as defined in this section, if the property owner knows or should have known that it will be used as a permanent or temporary residence by any offender prohibited from establishing residency in the City under the provisions of this chapter. Factors in considering whether a property owner knows or should have

known an offender's status is the presence of the offender's name listed on the State of W Offender Registry which is readily available to public inspection on the state's website.

Section 11, ItemJ.

§ 9-9-4 **Notification.** [Added 8-16-2021]

- A. Offenders subject to this chapter shall notify property owners of their offender status prior to entering into any room rental, apartment rental, lease, or property purchase for the purpose of establishing residency whether temporary or otherwise.
- B. Property owners who become aware that their property is being occupied by an offender in violation of this chapter shall notify the Chief of Police of such residence on their property, either temporary or permanent. Such notice shall be verbally or in writing.

§ 9-9-5 **Public places.** [Amended 8-16-2021]

It is unlawful for an offender, as defined by § 9-9-2, to loiter or prowl, as said words are used in § 9-2-4 of this Code, or to be in a manner or in circumstances manifesting an intent to commit a "sex offense" as defined in Wis. Stats., § 301.45(b), and/or a crime against children, under the following circumstances:

- A. Within 500 feet of real property that supports or upon which there exists a facility for children, a public park/beach, a public swimming pool, a public library, or a public recreational trail; or
- B. Attendance at public events that are children focused, engage in trick-or-treating festivities, or engage in the wearing of costumes in public where the wearing of such costume is likely to attract children.

§ 9-9-6 Appeal.

The residency restrictions of this chapter may be waived upon approval of the City Council through an appeal by the affected offender. Such appeal shall be made, in writing, to the City Clerk, who shall forward the request to the City Manager and the Chief of Police. The Chief of Police shall forward a report on the appeal request to the City Council. The City Council will convene within 30 days of the appeal being filed with the Clerk to hear from the Chief of Police and the affected offender or their counsel. After deliberation, the City Council shall act on the recommendation. A written copy of the decision shall be provided to the affected offender by the City Clerk. The City Council may reject a waiver request when the request is filed with the City Clerk within 90 days of denial by the committee of a prior identical waiver request of the requester, absent a change in circumstances.

§ 9-9-7 Violations and penalties.

[Amended 8-16-2021]

Any person found guilty of violating this chapter shall be penalized by forfeiture not less than \$100 and not to exceed \$1,000, plus court costs. Each day an offender maintains a residence in violation of this chapter constitutes a separate violation. The City may also seek equitable relief.

§ 9-9-8 Severability.

Should any portion of this chapter be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this chapter shall not be affected.

ORDINANCE

AN ORDINANCE to amend Municipal Code Section 9-9-2 entitled "Definitions"; and 9-9-3 entitled "Domicile Restrictions".

The Council of the City of Two Rivers ordains as follows:

SECTION 1. That Section 9-9-2 of the Municipal Code shall hereby be amended as follows:

PERMANENT RESIDENCE

The place where a person sleeps, abides, lodges or resides for 14 or more consecutive days or which qualifies as a residence under the laws of the State of Wisconsin, and may be mobile or transitory. The place where the person's habitation is fixed, without any present intent to move, and to which, when absent, the person intends to return. A permanent residence does not include lodging or other locations where the intended purpose is to temporarily stay. No person gains a residence in the City regardless of length of stay while there for temporary purposes only.

TEMPORARY RESIDENCE-TEMPORARILY RESIDE

- A. A <u>condition</u> place where the person sleeps, abides, lodges or resides for a period of <u>not</u> <u>more than</u> 14 or more days in the aggregate during any calendar year, and which is not that person's permanent residence as defined in this section;
- B. A place where the person routinely sleeps, abides, lodges or resides for a period of four or more consecutive or nonconsecutive days in any month, and which is not that person's permanent residence as defined in this section; or
- C. A place where a person sleeps, or which qualifies as a temporary residence under the holdings of the Wisconsin Supreme Court, and which may include more than one location, and may be mobile or transitory.

SECTION 2. That Section 9-9-3 of the Municipal Code shall hereby be amended as follows:

- A. Residency prohibited. No offender shall be permitted to reside in the City, and no supervised release of such offender shall be established in the City, for more than 14 days in the aggregate during any calendar year unless the offender was domiciled as a permanent resident in the City at the time of an offense resulting in such conviction or the person previously resided in the City for a continuous period of at least five years and that such residency has not lapsed for 10 or more years.
- B. Exemptions. An offender does not commit a violation of this chapter if any of the following apply:
- (5) Temporarily reside as defined in this section.
- C. It is unlawful for a property owner to let, rent, or lease any place, structure, or part thereof, trailer, other conveyance, to any person other than to allow such person to temporarily reside in the City as defined in this section, if the property owner knows or

should have known that it will be used as a permanent or temporary residence by any offender prohibited from establishing residency in the City under the provisions of this chapter. Factors in considering whether a property owner knows or should have known an offender's status is the presence of the offender's name listed on the State of Wisconsin's Sex Offender Registry which is readily available to public inspection on the state's website.

SECTION 3. This ordinance shall take effect and be in force from and after its date of passage and publication of same.


