a. Considering an Ordinance on Crisis Pregnancy Centers - CMs Wilken and Bishop, Party for Socialism and Liberation (PSL)

Presented by CM Wilken and CM Bishop. CM Bishop provided an introduction for Ronnie and Leslie Owens from the party for socialism and liberation. Ronnie shared a PowerPoint presentation on Crisis Pregnancy Centers. Ronnie explained that Crisis Pregnancy Centers (CPC) are a public safety threat because of their spread of misinformation and their efforts to prevent women from obtaining healthcare services. Ronnie reviewed a study that detailed advertised CPC services. Leslie Owens presented a CPC disclosure proposal to protect residents from misinformation and predatory practices.
