## a. Public Input

**Sarah Nixon** urged Council to reject the FOP contract when it comes before them. Expressed concerns about the transparency of the collective bargaining process and disciplinary clauses for law enforcement.

#### b. Audit Presentation FY 2022 - HRF

Presented by Shaennon Clark the Finance Director and Jamie Wilkey the auditor from Lauterbach & Amen LLC. The complete report can be found at this <u>link</u>. Wilkey shared a PowerPoint Presentation and shared that the City obtained an Unmodified Opinion, or the highest-level opinion the City is eligible to receive. The City was also awarded recognition for the FY 2021 audit report. Wilkey reported there were no significant findings or issues with financial procedures. Questions and discussion ensued.

#### c. Housing and Homeless Initiatives Grant Update - CD

Presented by Grants Coordinator Breaden Belcher. Belcher shared that this process in partnership with the City of Champaign has yielded \$5.3 million in grants available to address housing gaps and homeless services. Projects from six categories were eligible including: supportive services, housing navigation, TBRA, affordable housing, housing gaps, and noncongregate shelter. Belcher shared a process timeline and reviewed steps taken. Agreements will be separated and executed by the impacted City and funding source. Belcher shared the programs that the City of Urbana will be funding at this time. Questions and discussion ensued.

# a. American Rescue Plan Act (ARPA) Continuing Discussion

Will Kolschowsky the management analyst reviewed the Council's unofficial poll results in support of funding ARPA applications and asked the Council to provide staff direction. Council has been asked to decide if they supported full funding, partial funding, maybe funding, or not funding at all for each application. Council suggested dropping applications who have received 6 and above no funding poll responses. Council suggested reviewing applications that received at least 4 poll responses for fully funding or 5 poll responses for partial funding. 19 Projects totaling \$12.3 million meet the above criteria for yes full funding and yes partial funding. Council suggested information being provided in a layout showing all responses for each application being reviewed at the next meeting. Staff suggested Council bring tentative funding allocations to the next meeting to inform the discussion.
