A. CALL TO ORDER, ROLL CALL AND DECLARATION OF QUORUM

Ann Panthen called the meeting to order at 6:02 p.m. The Recording Secretary took the roll. A quorum was present.

Commissioners accepted the agenda without change.

C. APPROVAL OF MINUTES

1. May 21, 2024

Ms. Panthen called for a motion to approve the minutes from the previous meeting. Peter Resnick so moved. Shalini Smith seconded the motion. The commissioners approved the motion by a voice vote.

2. Consideration of EEO Workforce Statistics

Ms. Panthen inquired as to whether the submission by PJ Hoerr was an update. Another company, Hoerr was recently certified. They are separate companies in communities near each other.

Mr. Resnick move to approve certification of seven companies as follows:

JPMorgan Chase Bank, N.A.	2 years
Schaefer Plastics North America, LLC	2 years
Locality Media Inc. (d/b/a First Due)	2 years
Commerce Bank	2 years
ABC Sanitary Hauling & Recycling	2 years
PJ Hoerr, Inc.	1 year
Broeren Russo Builders, Inc.	1 year

Vahagn Chiflikyan seconded the motion.

Mr. Resnick explained recommending PJ Hoerr and Broeren Russo Builders for one year certification as the two are union shops. He hopes to see a proposal to come before the commission at a future meeting regarding companies utilizing union labor. One-year certifications now would give the commission flexibility pending that proposal.

Ms. Smith pointed out Commerce Bank's employee information was from the end of 2022. In the discussion it was suggested that a large corporation might have shared their most recent annual report, but a definite explanation was unknown. An update to the application form could add room to explain such an appearance of information not appearing to be recent.

Mr. Chiflikyan asked about applicants appearing to leave some answers blank. It was explained some questions allow for skipping. One applicant had left a question unanswered, but when answered, they were found to be in good standing.

Schaefer Plastics had left the question about "sub-contractors" blank. In response to a question from Mr. Resnick, Mr. Chiflikyan stated he was comfortable moving forward with certification even as staff reviews the question.

Following discussion, the motion carried on a voice vote.
