1. Call to Order and Roll Call

a. Fourth Quarter 2023 Update on Mayor/Council Strategic Goals

Presented by Carol Mitten, City Administrator with William Kolschowsky, Senior Management Analyst and Assistant to the City Administrator available for questions. Questions and discussion ensued.

6. New Business

a. Ordinance No. 2024-03-015: An Ordinance Amending the Urbana Zoning Map - (205 North High Cross Road / Plan Case No. 2483-M-23) - CD

Presented by Kevin Garcia, Principal Planner. Ordinance seeks to amend the zoning map for a parcel owned by OSF Healthcare at 205 North High Cross Road to change the zoning district from B-3 (General Business) to B-1 (Neighborhood Business). This Ordinance is following up on previous City Council actions that rezoned the parcel from B-1 to B-3 through Ordinance No. 2020-04-023 and the Resolution No. 2023-11-094R where City Council reconsidered the appropriate zoning designation for the parcel and directed the Zoning Administrator to file an application to rezone the parcel from B-3 to B-1. Images displaying the plot and illustrating surrounding current land use, current zoning, and future land use were shared. Stated that the Plan Commission reviewed the proposed rezoning and voted to recommend approval for City Council. Questions and discussion followed.

b. Resolution No. 2024-02-013R: A Resolution Adopting Mayor/Council Strategic Goals for 2024-2025 - Exec

Presented by William Kolschowsky, Senior Management Analyst and Assistant to the City Administrator. Resolution seeks to approve the adoption of the Mayor/Council Strategic Goals for 2024-2025. The goals were developed over 3 facilitated discussions with Mayor Marlin, City Council, and City staff. It features 4 strategic areas, 12 strategies, and 30 action items. This resolution was forwarded from the 02-19-2024 Committee of the Whole. Questions and discussion ensued.

Motion to approve to the regular agenda by CM Bishop, seconded by CM Wu

CM Kolisetty proposed a friendly amendment to strategy 1.3 B to read "Continue to fund community partners and projects that promote health, wellness, drug and alcohol treatment, and that support families suffering from domestic violence with continual program monitoring and evaluation."

CM Wu proposed a friendly amendment to strategy 1.1 A to read "Develop and implement alternative emergency response models (specifically addressing for mental health crisis and domestic disputes)."

CM Wilken proposed a friendly amendment to strategy 3.3 C to read "Create and implement a grant program for community environmental projects."

CM Kolisetty addressed the public input question regarding why Resolution No. 2024-03-013R was passed during the previous City Council meeting. Stated that she personally believed it captured the diverse range of opinions heard during public input as best as possible and that she is open to continuing the conversation if people would like to reach out. **CM Wu** expressed that a considerable amount of time was spent thinking on the topic of Resolution No. 2024-03-013R, but her statement made during 03-04-2024's Committee of the Whole meeting during the discussion of the resolution still reflects her stance now.
