CM Evans provided an introduction to Joe Trotter from Champaign Urbana Public Health Department. Trotter explained their harm reduction services such as needle exchange, Narcan distribution, community trainings, and counseling. Questions and discussion ensued.

Marion Harrington submitted a petition against the HOPE Village Development to preserve the Carver Park Subdivision with 285 signatures. Elderess Melinda Carr read the letter from the submitted petition. Andrew Valentine spoke in support of Urbana getting a skate park. Robert Louis expressed concerns about the HOPE Village development. James spoke in support of a skatepark in Urbana. CM Wu read on behalf of Julie Watkins (attached). Coleman spoke in support of a skate park in Urbana.

To Urbana City Council:

Please read this email during public comment.

Thank you for the opportunity to share my observations.

The Council is now in the process of updating the Mayor and City Council strategic goals for 2024-2025. Last week, before the beginning of the Goals discussion, the only department that made a presentation was the Police Department. This seems lopsided. Especially as in the staff report that Chief Boone led, he said he's understaffed for what he wants to do. He also mentioned an "all hands approach" in his report as something new which was also suggested and discussed during the Goals discussions according to the reports back from the small group discussions.

I realize he's new to his position and has ideas and apparently wants to plan for growth. I also understand the budget has already been passed, but I try to watch every city council meeting and budget amendments come up frequently. The strategic goals for the city will have budget effects. The council will be setting goals for the next two years. At the listening session that I attended a few days after last week's meeting there were a couple, maybe more, about "why more officers?"

I wanted to comment upon the problematical timing of a request that would mean a budget increase coinciding with your updating of Strategic goals for the city.
