Mayor Marlin summarized staff efforts and stressed to the public that the City intends to continue to enforce the Human Rights Ordinance. Council continued to ask clarifying questions around Crisis Pregnancy Centers and Housing Discrimination. Council asked City Staff for a written follow-up on their questions and to present options for actionable steps.
