A. CALL TO ORDER, ROLL CALL AND DECLARATION OF QUORUM

Ann Panthen called the meeting to order at 6:01 p.m. The Recording Secretary took the roll. A quorum was present.

Peter Resnick seconded the motion.

During discussion, Mr. Resnick sought to clarify the cut-off for automatic certification. It is 14 employees and below.

Due to a reduction in the percentage of minority workers since their previous certification, Mr. Schroeder sought to clarify the status of Lochmueller Group regarding union workers. Documents presented to the Commission from the OHRE had some contradictory information. The company is not a union shop.

Mr. Resnick suggested asking the company for more information regarding their turnover in the past two years. Mr. Schroeder accepted a friendly amendment to his motion to defer action on Lochmueller Group until the next meeting.

Mr. Schroeder sought to determine possible reasons MGT of America would show a high number of employees not reporting ethnicity. Carla Boyd explained that is generally by employee choice. The company had made note of the numbers in the application's comment section.

Following the discussion, the motion with the friendly amendment carried on a voice vote.

Certified for One Year: A&R Mechanical Services; Daniel L. Ribbe Trucking; Remco Electrical.

G. OFFICER'S REPORT

Ms. Boyd shared her monthly report. Highlights included:

- Status of complaints
- Calls and referrals
- Mailed flyers to 80 property owners/managers in Illinois beyond Champaign County; preparing mailing for those with property here, but who live outside of Illinois
- Delivering similar posters and brochures in the nearby areas
- Electronic versions of the new materials are available for posting on a property's website
- One of Urbana's Neighborhood Associations has scheduled her to attend a meeting

Follow Up: Mr. Resnick wondered whether non-citizen residents might be eligible to serve on this commission. Ms. Boyd will check on that before the next meeting.

Ms. Panthen stated she will plan to attend community events when her schedule allows. Shalini Smith will also plan to attend. Ms. Boyd will update the two of them on upcoming dates
