a. Public Input

Esther Patt asked that at the next COW meeting to have a resolution requiring the City to enforce the Urbana Human Rights Ordinance and State act to protect against source of income discrimination. Shared information about the history of source of income discrimination protection.

Mayor Marlin reminded the public about the Public Safety Review being conducted by BerryDunn and encouraged the public to respond to the survey online. a. Ordinance No. 2023-04-007: An Ordinance Revising the Annual Budget Ordinance - Budget Amendment #7 - HRF

Presented by Alyana Robinson. Robinson explained that this is the seventh budget amendment for the year. The estimated ending fun balance in the general operating fund would be \$11.7 million which is 29.93% of recurring expenditures. Questions and discussion ensued.

Item amends the fee schedule, item will be placed on file for 30 days and will be voted on at a later City Council meeting. Clark provided information about specific changes.
