4. Public Input and Presentations

a. Mayoral Proclamation: African American History Month

Presented by Mayor Marlin. Mayor Marlin read a proclamation in recognition of African American History month for the month of February in the City of Urbana.

b. Public Input

Marlin Mitchell spoke in support of the FirstFollowers grant items on the agenda and shared how previous year's grant funding has impacted the organization and community in a positive

way. *Dennis Roberts* shared information about the Urbana Sister City's fundraiser to support the exchange of students from France to visit their peer counterparts at Uni-High School. Shared message from teacher of French students. *Claudia Lenhoff* from Champaign County Health Care Consumers expressed concerns about Council discussion at the last meeting regarding the funding for CCHCC's ARPA application. She then provided clarity on some of the Council's questions at the last meeting regarding terms. *Brian Dolinar* spoke in opposition to the FOP contract especially considering what has occurred in Memphis. Hopes to see greater review of Police Officers by the Civilian Police Review Board. *CM Evans read into the record written input from Luke Lee, Morris Galagher, and Sarah Blanco.*

5. Staff Report

1. First Quarter 2023 Update on Mayor/Council Strategic Goals

Presented by Carol Mitten the City Administrator. Mitten shared progress towards completing some of the Mayor/Council Strategic Goals. Mitten announced the firm who will be conducting the community safety review, the upcoming ABLE train the trainer training for the Police Department, vendor selection for electric vehicle charging stations, building safety code updates, business list and registry creation, and the public realm study will be presented along with recommendations. Questions and discussion ensued.

6. New Business

a. Ordinance No. 2023-02-004: An Ordinance Revising the Annual Budget Ordinance (Budget Amendment #6 - Omnibus) - HRF

Presented by Alyana Robinson the Financial Analyst. Item amends the FY 2023 Budget to reallocate existing funds in vacancy savings to pay for a temporary contract employee for administrative work, legal fees to cover the Carle litigation, a transfer of vacancy savings to pay for contract electrician services, reallocate state motor fuel funds to litigation for the Windsor Road Resurfacing case, transfer of TIF funds to cover professional consulting services with the closure of TIF2, a transfer in the machinery funds from last year's budget to cover an equipment replacement this FY. Questions and discussion ensued.

f. Resolution No. 2023-02-010R: A Resolution Certifying a Community Housing Development Organization for the Urbana HOME Consortium (Habitat CHDO Certification PY 2022) - CD

Presented by Sheila Dodd the interim Community Development Director and Grants Manager. Item certifies Habitat for Humanity as a CHDO vendor and eligible for funding.

g. Resolution No. 2023-02-011R: A Resolution Approving and Authorizing the Execution of an Urbana HOME Consortium Community Housing Development Organization Agreement (Habitat CHDO Operating PY 2022) - CD

Presented by Sheila Dodd the interim Community Development Director and Grants Manager. Item approves funding to cover operating and staffing costs for the programming.

Approved in omnibus.

h. Resolution No. 2023-02-012R: A Resolution Approving and Authorizing the Execution of an Urbana HOME Consortium Community Housing Development Organization Agreement (Habitat CHDO Developer PY 2022) – CD

Presented by Sheila Dodd the interim Community Development Director and Grants Manager. Item approves the funding for Habitats programmatic request for facility construction costs.

Approved above in omnibus.

9. Discussion

a. American Rescue Plan Act Continuing Discussion

Mayor Marlin led the discussion and reminded the public that there would be no final action taken at this meeting and that the following discussion would be tentative. The following projects were discussed and considered for straw polls.

Urbana Roof Repair program was considered for \$150k, with a straw poll resulting in 7 up and 1 down.

FirstFollower Community Peace Hub project was considered for \$92k, with a straw poll resulting in 3 thumbs up and 4 thumbs down. A subsequent straw poll for \$79,200 resulted in 5 thumbs up 2 thumbs down.

City of Champaign Township STRIDES shelter program was considered for \$750k, with a straw poll resulting in 7 thumbs up.

HACC single room occupancy project was considered for \$200k, with a straw poll resulting in 7 thumbs up.

Solia Gratia Farm Community Farm Expansion was considered for \$275k, with a straw poll resulting in 2 thumbs up and 4 thumbs down. A subsequent straw poll considered \$200k, resulting in a straw poll of 7 thumbs down. A final straw poll considered \$150k, resulting in 6 thumbs up and 1 thumb down.

Urbana Champaign Independent Media Center program was considered for the median figure from the draft allocation in a straw poll resulting in 6 thumbs up.

HACC Frist time homeownership counseling program was considered for \$25k and received 6 thumbs up.

Carle Hope Village project was considered for \$750k and received a collective thumbs down. A second straw poll considered \$1million and received 4 thumbs up and 4 thumbs down. \$675k the median value from the draft allocation received 3 thumbs up and 4 thumbs down. The final straw poll considered \$850k and received 5 thumbs up.

\$213k left of 10 million has been tentatively allocated. Council agreed to analyze how the funding breakdown applies to the Council Strategic Goals and revisit it next week to do a final pass.

Council decided to revisit the CCHCC staffing and conducted a straw poll to allocate \$500k without any staffing stipulation and it passed via thumbs up.

Council decided to revisit the Steer place renovation project and conducted a straw poll to allocate \$500k for asbestos specifically and it passed via thumbs up.

Council asked for dollar amount and projects breakdown as they apply to council strategic goals for the next meeting. Further questions and discussion ensued.

10. Council Input and Communications

CM Quisenberry shared information about the upcoming schoolboard meeting and asbestos abatement to Wiley school. **CM** Bishop shared statement reflecting on Black History month. **CM** Wilken shared thoughts about ARPA process and thanked those who applied for the work they do to support our community, thanked Will and Carol from City staff and RPC for their work to support this allocation and application process. **CM** Wu spoke to the effort taken in the ARPA allocation process and thanked everyone involved in the process for their time and commitment.

11. Adjournment

With no further business before the committee of the whole Chair Evans adjourned the meeting at 8.55 p.m.
