With a quorum present, Mayor Marlin called this meeting of the Urbana City Council to order at 7:29 p.m. Mayor Marlin took a moment to honor the memory and life of Senator Scott Bennett who passed away suddenly on Friday. Marlin read the following statement into the record:

“Illinois State Senator Scott Bennett was the sort of person we long for in public office. He had a delightful sense of humor, the ability to work with people and politicians across the spectrum, and a pragmatic approach to the legislative process. His legal expertise coupled with his life experience and integrity made him perfect for his role as a State Senator.

I attended the candidate forum in the fall of 2015 showcasing a number of people vying for the appointment to the Senate seat vacated by Treasurer-elect Mike Frerichs. Each candidate made the case for themselves. All of them brought passion and ideas to the table but one person stood out for me, and that was Scott Bennett. It was clear that Scott had the ability to navigate both Champaign and Vermilion County. That proved to be very true.

What made him such a standout public servant was his presence in the district. He showed up, listened to his constituents, and did the work. You would find him across the table, in the audience, at the meetings and on the Senate floor working to find solutions. People felt a personal connection with Scott, and the only way you develop that is one conversation at a time.

We have lost a wonderful man way too soon. I deeply respected Senator Scott Bennett and more importantly, just plain liked Scott Bennett very much. On behalf of the City of Urbana, I extend my heartfelt condolences to his beloved family.”
