2. Resolution No. 2023-05-033R: Resolution in Support of Fair Housing for All Regardless of Source of Income - Council

Presented by CM Wu. Item ensures that residents will not face discrimination in housing due to source of income. Questions and discussion ensued.

Motion to amend as read, in the last paragraph "THEREFORE, BE IT RESOLVED, that the City of Urbana prohibits discrimination in housing based on source of income, including a landlord's refusal to rent to a person solely because a Housing Choice Voucher or other rent subsidy or assistance program will pay a portion of the rent, and including a landlord's refusal to comply with requirements to accept such payment." by CM Wilken and seconded by CM Wu.

shared that due to a lack of resource time that the pursuit of this project would redirect from other existing projects.

Thank you for the Resolution about Source of Income Discrimination.

On the issue of income discrimination in rental housing, I support the idea of fining "no voucher" discrimination in advertisements. If city staff is making choice of "Education not Punishment" council should direct staff to fine landlords that continue to publish discriminating advertisements after notification.

If staff is choosing education over taking action, is that staff deciding the 3 month window doesn't matter? Considering what was said last week, I agree that 3 month window is too short. I agree that hard to meaningfully enforce against income discrimination so a complaint can be resolved without losing the voucher and having to start over.

Since the 3 months is not a local decision, we have to do all we can locally to help achieve more voucher successes. I think it's time to start fining discrimination in advertisements when it's not changed upon "education" or advertisements republished without change.
