Please read the following at the Urbana City Council Committee of the Whole meeting tonight.

Urbana is a union town. Tomorrow will be the union election for the workers at the Vine Street Starbucks.

There have been disgusting instances of retaliation against Starbucks workers nationally and as nearby as Peoria.

I ask that Urbana take a stand for workers rights. Please say loudly and clearly to the Vine Street Starbucks management that we will not tolerate nor accept any retaliation against the workers in our community, in our union town.

No one likes a bully, and abuses by management will not be ignored. I hope that the Urbana City Council we now have will voluntarily take this matter to task without the need for any pressure campaign.

Whether it's a proclamation or a resolution or a visit to the Starbucks, I ask the Urbana City councilpersons and the Mayor to please be open with our community about how you are working to ensure management does not so much as attempt to retaliate against the workers at the Vine Street Starbucks.

The rights we have are not enough. You need to step up to ensure our community is not going to join Peoria in being a witness to the gross retaliation efforts of the Starbucks Corporation.

Oh and by the way, the management that attempted the retaliation in Peoria was ultimately fired.
