

The location of your proposed improvements within the County Right-Of-Way as shown by the accompanying notice is approved. Contractor shall notify Waller County Road and Bridge at (979) 826-7670, a minimum of 48 hours prior to construction.

Your attention is directed to Art. 1436A (for power lines) and Art. 1416 (communication lines) Vernon's Annotated Texas Civil Statutes with particular attention to the following provisions:

- 1. The Commissioners Court may designate the place along the right-of-way where such lines shall be constructed.
- 2. Placement of buried lines shall be a minimum of 36-inches below the flow line of the existing ditch. For installations parallel to the right-of-way, the utility shall be located within three (3) feet of the edge of the right-of-way, unless otherwise approved by the County Engineer.
- 3. All placement of lines beneath roadways and asphalt or concrete paved driveways shall be jacked and bored. No open cut will be allowed within five feet of the edge of roadways or such driveways. Open cuts on unpaved driveways shall be performed only with a trenching machine and shall not be excavated. In such cases the trench shall be backfilled and compacted. The driveway surface shall be restored to its original or better condition.
- 4. All buried water lines shall be marked thoroughly with detectable tracer wire. All other lines shall be marked thoroughly with detectable underground warning tape. Public to be safe-guarded by use of construction signs and barricades. Identification markers shall be placed along right-of-way lines, that is readily identifiable, indicating name of Company, type of line and emergency contact number.
- 5. Restore roads to their original condition. Trench is to be back-tracked, dragged, graded and filled as necessary to minimize erosion and sedimentation resulting from the proposed installation. Ditches are to be left clear for drainage.
- 6. The Commissioners Court may require the owner to relocate this line, for valid reasons under the law by giving thirty (30) days written notice.

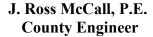

AMENDMENT TO THE TAX CODE CHAPTER 312 TAX ABATEMENT AGREEMENT BETWEEN WALLER COUNTY, TEXAS, AND TWINWOOD INDUSTRIAL OWNER, LLC

Waller County, Texas ("County"), and Twinwood Industrial Owner, LLC ("Owner") hereby amend the tax abatement agreement entered into between the County and Owner. This amendment is made and entered on October 15, 2025.

WHEREAS, County, and Owner entered into a Tax Abatement Agreement on June 14, 2023 ("Agreement"), which is identified as Contract ID# 230614-11d and is attached hereto and incorporated herein as Exhibit 1; and

WHEREAS, Owner has completed construction on the Improvements required by the Agreement, namely "Building 4," an approximately 181,000 square foot commercial building at an estimated cost of approximately \$9,000,000.00 located at 2150 Discovery Hills Parkway, Brookshire, Texas 77423, and requests an extension of the abatement period due to construction delays and market conditions; and

WHEREAS, County has determined that the extension of the abatement period would maintain and/or enhance the commercial/industrial economic and employment base of the County, otherwise further the goals of the Tax Abatement Policies and Guidelines previously adopted by the County, and would be a long-term benefit to the County; and

WHEREAS, County, and Owner wish to amend the Agreement in order to extend the abatement period;

NOW, THEREFORE the parties mutually agree as follows:

1. Section 3 of the Agreement is amended to read:

"COUNTY and OWNER agree that if a lessee/buyer does not lease the SPEC BUILDING at the PREMISES before the end of Year (3) of this abatement AGREEMENT, said AGREEMENT will hereby terminate, and OWNER will be assessed and owe all taxes payable to COUNTY commencing Year (4). For purposes of this AGREEMENT, the period from (i) January 1, 2025 through and including December 31, 2025 shall be referred to as Year (1), (ii) January 1, 2026 through and including December 31, 2026 shall be referred to as Year (2), (iii) January 1, 2027 through and including December 31, 2027 shall be referred to as Year (3), and January 1, 2028 through and including December 31, 2028 shall be referred to as Year (4).

2. Section 12(a) of the Agreement is amended to read:

"Said abatement shall be in an amount equal to the percentages listed in the following table:

Year 1 (2025) – 100%
Year 2 (2026) – 100%
Year 3 (2027) – 100%

3. Section 12(b) of the Agreement is amended to read:

"Said abatement on the SPEC BUILDING located at the PREMISES shall terminate if not occupied by a lessee or buyer by December 31 of YEAR 3 as defined in Section 12(a). In such an event, OWNER is fully liable for all ad valorem property taxes owed to the COUNTY beginning January 1, 2028/Year 4."

- 4. No other amendments or modifications to the Agreement are hereby made.
- 5. This amendment is effective as of the date of the last signature.
- 6. Signatories represent and warrant that they have the authority to bind the respective parties.

TAX ABATEMENT AGREEMENT:

This AGREEMENT is entered into by and between the County of Waller, Texas, duly acting herein by and through the County Judge ("COUNTY"), and Twinwood Industrial Owner, LLC, as of June 14, 2023.

RECITALS:

WHEREAS, on February 28, 2018 the COUNTY passed an Order establishing Twinwood Business Park as a Reinvestment Zone, and on December 22, 2021 the COUNTY amended the Order to rename the Reinvestment Zone as Waller County Twinwood Business Park Reinvestment Zone 12, both of which are included in Exhibit "C," for commercial/industrial tax abatement purposes ("ORDER"), as authorized by Texas Tax Code Chapter 312; and

WHEREAS, the COUNTY has previously adopted Tax Abatement and Incentives Policy Guidelines & Criteria ("POLICY") governing Tax Abatement Agreements and Reinvestment Zones; and

WHEREAS, the POLICY constitutes appropriate guidelines and criteria governing Tax Abatement Agreements to be entered into by the COUNTY; and

WHEREAS, the COUNTY has adopted a resolution stating that it elects to participate in tax abatement; and

WHEREAS, in order to maintain and/or enhance the commercial/industrial economic and employment base of COUNTY, to otherwise further the goals of the POLICY previously adopted by COUNTY, and for the long-term benefit of the COUNTY;

WHEREAS, OWNER owns the PREMISES or has the PREMISES under contract.

NOW THEREFORE, the PARTIES do hereto mutually agree as follows:

COVENANTS AND AGREEMENTS:

- 1. The property that is the subject of this AGREEMENT shall be referred to as the PREMISES, and the PREMISES are described in EXHIBIT "A," which is attached hereto and incorporated herein.
- 2. OWNER shall ensure a prospective lessee/buyer for the SPEC BUILDING(S) (as such term is defined in the COUNTY'S current POLICY) at the PREMISES is diligently and faithfully sought.
- 3. COUNTY and OWNER agree that if a lessee/buyer does not lease the SPEC BUILDING at the PREMISES before the end of Year (2) of this abatement AGREEMENT, said AGREEMENT will hereby terminate and OWNER will be assessed and owe all taxes payable to COUNTY commencing Year (3). For purposes of this AGREEMENT, the period from (i) January 1, 2025 through and including December 31, 2025 shall be referred to as Year (1), (ii) January 1, 2026 through and including December 31, 2026 shall be referred to as Year (2), and (iii) January 1, 2027 through and including December 31, 2027 shall be referred to as Year (3).
- 4. Upon OWNER entering into a lease with a lessee, or sales agreement with a buyer, this AGREEMENT may be amended or replaced on mutually acceptable terms by a written

- instrument duly executed by COUNTY and OWNER, based on the results of the Economic Impact Analysis as required in the COUNTY'S then-current POLICY.
- 5. A separate agreement may be made between the COUNTY and each lessee or buyer for specified new personal property, except inventory, the terms of which will be determined by the Economic Impact Analysis as required by the COUNTY'S then-current POLICY.
- 6. The improvements OWNER shall make to the PREMISES shall be referred to as the IMPROVEMENTS, and the IMPROVEMENTS shall be of the kind, number, and location specifically described in EXHIBIT "B" which is attached hereto and incorporated herein. Notwithstanding the foregoing, OWNER may amend EXHIBIT "B" with the prior written approval of the COUNTY, which approval shall not be unreasonably withheld, conditioned, or delayed.
 - a. The IMPROVEMENTS, as referenced in Exhibit "B," for Building 4, located at 2150 Discovery Hills Parkway, Brookshire, Texas 77423, shall be completed by the end of Year (1) and will cost an estimated \$9,000,000.
 - b. OWNER shall ensure the IMPROVEMENTS are diligently and faithfully undertaken and completed in a good and workmanlike manner, in compliance with all applicable federal, state, and local laws and regulations.
 - c. Notwithstanding subsection a. above, OWNER shall have additional reasonable time to complete the IMPROVEMENTS in the event of "force majeure," if OWNER is diligently and faithfully pursuing completion of the IMPROVEMENTS. "Force majeure" shall mean any contingency or cause beyond the reasonable control of OWNER including, without limitation, an act of God, public enemy, war, riot, civil commotion, insurrection, or labor strikes.

- 7. OWNER shall, until the expiration of this AGREEMENT or until a lessee or buyer occupies the building, continuously operate (or cause to be operated) and maintain the PREMISES as a SPEC BUILDING.
- 8. OWNER shall, in writing and until the expiration of this AGREEMENT, annually certify compliance with this AGREEMENT to the COUNTY.
- 9. For the duration of this AGREEMENT, OWNER, as owner of the premises, is not required to employ persons as part of this AGREEMENT.
- 10. It is understood and agreed among the PARTIES that the PREMISES shall be appraised at market value for property tax purposes beginning January 1, of YEAR 1 as defined in section 12.a., including the value of any partially completed IMPROVEMENTS.
 - a. If there are no IMPROVEMENTS on the PREMISES on January 1, of YEAR 1 as defined in section 12.a., and if OWNER'S failure to make IMPROVEMENTS is not excused under section 6.c., then this AGREEMENT is subject to termination by the COUNTY as if a default had occurred under section 13, and there shall be no tax abatement for the tax year beginning January 1, of YEAR 1 as defined in section 12.a..
 - b. Beginning January 1, of YEAR 1 as defined in section 12.a., and continuing each year thereafter, the PREMISES and any and all IMPROVEMENTS shall be appraised at market value effective January 1 of each tax year.
- 11. OWNER agrees to render the PREMISES for tax valuation purposes with the Chief Appraiser for the Waller County Appraisal District annually and within the deadline for filing renditions.

- 12. Subject to the terms and conditions of this AGREEMENT, and subject to the rights of the holders of any outstanding bonds of the COUNTY, a portion of the ad valorem property taxes which would otherwise be owed to the COUNTY for the PREMISES shall be abated.
 - a. Said abatement shall be in an amount equal to the percentages listed in the following table:

YEAR 1 (2025) – 100%
YEAR 2 (2026) – 100%

- b. Said abatement on the SPEC BUILDING located at the PREMISES shall terminate if not occupied by a lessee or buyer by December 31, of YEAR 2 as defined in section 12.a.. In such an event, OWNER is fully liable for all ad valorem property taxes owed to COUNTY beginning January 1, 2027/Year (3).
- c. The abatement percentages in subsection a. above shall be applied to the taxes assessed for each year during the abatement period (including the taxes assessed on the value of the PREMISES and any and all IMPROVEMENTS) over the base value of the PREMISES in the year in which this AGREEMENT is entered. The PARTIES understand and agree that the percentages in subsection a. above only apply to IMPROVEMENTS and property that are eligible for abatement under Texas law.
- d. Nothing in this AGREEMENT shall affect OWNER'S right to protest and/or contest any taxes assessed on the PREMISES and any and all IMPROVEMENTS, and the abatement percentages shall be applied to the amount of taxes finally determined to be due as a result of any such protest and/or contest.

e. If the certified appraised value of the real property Improvements is reduced, regardless of the initial appraised value, as the result of OWNER'S protest, the percentage of abatement granted herein will be adjusted downward by the same percentage, then rounded upward to the nearest whole percentage. For example, if the protest of the certified appraised value is reduced by 6.6% then the percentage of the tax abatement granted in any given year under this Agreement on the Improvements would be decreased by the same percentage, rounded to the nearest whole number, thereby reducing the abatement by 7%.

DEFAULT:

- 13. OWNER shall be in default if any of the following occurs:
 - a. IMPROVEMENTS are not completed substantially in accordance with this AGREEMENT, including EXHIBIT "B," as may be amended in accordance with the terms of this AGREEMENT;
 - OWNER fails to timely file annual renditions for the PREMISES and any and all IMPROVEMENTS;
 - c. OWNER allows its ad valorem taxes owed to the COUNTY, or any other taxes owed to any other taxing entity located in whole or in part in the COUNTY, to become delinquent without timely and properly following the legal procedures for protest and/or contest of any such taxes;
 - d. OWNER operates the PREMISES (or causes the PREMISES to be operated) in violation of public health and safety laws, or allows the PREMISES or any part thereof to become a public nuisance; or

- e. OWNER fails to comply with or violates any other part of this AGREEMENT.
- 14. In the event that OWNER defaults as described in section 13 above, the COUNTY shall give OWNER written notice of such default. If OWNER has not cured such default within sixty (60) days of said written notice, this AGREEMENT may be terminated by the COUNTY. Notice shall be in writing and shall be delivered by personal delivery or certified mail, return receipt requested to OWNER or its designated representative.
 - Any notice or certification to be provided pursuant to this AGREEMENT shall be
 made to the following persons, unless a substitute representative is designated in writing:

- 15. In the event of default or termination, the PARTIES acknowledge that actual damages would be speculative and difficult to determine and/or calculate. Accordingly, in the event of default or termination, as liquidated damages, OWNER shall owe all taxes which would have been paid to the COUNTY in the absence of this AGREEMENT for all prior years, and all such taxes shall be paid to the COUNTY within sixty (60) days of the expiration of the cure period described in section 14 above.
 - a. In addition to any amounts due under section 15 above, interest on any such amounts shall be charged at the statutory rate for delinquent taxes, as determined by Chapter 33 of the Texas Tax Code.
 - b. Notwithstanding subsection a. above, in the event of default or termination, no penalty shall be charged under Chapter 33 of the Texas Tax Code.

- c. If the COUNTY terminates this AGREEMENT, no abatements for the PREMISES in future years will be allowed.
- 16. Notwithstanding section 15 above, if OWNER completes the IMPROVEMENTS in compliance with this AGREEMENT, but subsequently fails to operate (or cause to be operated) and maintain the PREMISES in accordance with this AGREEMENT, then section 15 shall not apply to require payment of taxes which would have been paid to the COUNTY in the absence of this AGREEMENT for all prior years, unless OWNER was not in compliance with this AGREEMENT during those prior years. Instead, OWNER shall only be liable to the COUNTY for those taxes which are assessed for the tax years in which OWNER ceases to operate (or cause to be operated) and maintain the PREMISES in accordance with this AGREEMENT

MISCELLANEOUS:

- 17. The COUNTY represents and warrants that the PREMISES does not include any property that is owned by a member of the Waller County Commissioners Court, or owned by any party responsible for the approval of this AGREEMENT.
- 18. The terms and conditions of this AGREEMENT are binding upon the successors and assigns of all PARTIES. However, except for any collateral assignment to any lender of OWNER, this AGREEMENT cannot be assigned by OWNER without the COUNTY'S written consent, which shall not be unreasonably withheld. If any lender of OWNER becomes the owner of the Premises as a result of a foreclosure, deed-in-lieu of foreclosure or otherwise, notwithstanding anything in this AGREEMENT to the contrary, such lender shall not be liable for any amounts under this AGREEMENT except for the taxes which would have been paid to the COUNTY in the absence of this AGREEMENT for the years

- during which this AGREEMENT was in effect or, if section 16 is applicable, then such lender shall only be liable for the amounts for which OWNER is liable under section 16.
- 19. This AGREEMENT may be replaced by a subsequent Tax Abatement Agreement consistent with COUNTY'S POLICY based on a qualifying lessee/buyer, COUNTY, and OWNER, in the event of a lease, all being parties to a mutually acceptable agreement. The Tax Abatement provided by any subsequent AGREEMENT SHALL BE BASED ON THE MERITS OF AN ECONOMIC IMPACT ANALYSIS AND APPLIED CONSISTENTLY WITH THEN-CURRENT COUNTY POLICIES.
- 20. It is understood and agreed between the PARTIES that OWNER is acting independently in the performance of its obligations hereunder, and the COUNTY assumes no responsibilities or liabilities for OWNER'S performance of this AGREEMENT. OWNER agrees to defend, indemnify, and hold harmless the COUNTY, including but not limited to the COUNTY'S officials, officers, employees, agents, and affiliates, and the affiliated appraisal district, from any and all claims, losses, damages, injuries, suits or judgments relating to OWNER'S performance of this AGREEMENT or OWNER'S PREMISES or IMPROVEMENTS.
- 21. OWNER agrees that the COUNTY and its agents or employees shall have the reasonable right of access to the PREMISES to inspect the IMPROVEMENTS to ensure that the IMPROVEMENTS have been made and are being made in accordance with this AGREEMENT. After completion of the IMPROVEMENTS, the COUNTY shall have the continuing right to ensure that the PREMISES are thereafter maintained and operated in accordance with this AGREEMENT, during the term of this AGREEMENT. However, the COUNTY will neither inspect for nor ensure that OWNER is in compliance with federal,

- state, or local laws or regulations. The COUNTY'S inspections, if any, shall not constitute an acknowledgment or certification to OWNER or any third party that OWNER is in compliance with federal, state, or local laws or regulations.
- 22. This AGREEMENT shall be construed and interpreted in accordance with Texas law, and it is performable in Waller County, Texas. Should any part of this AGREEMENT be found unenforceable by a court of competent jurisdiction, all other parts of this AGREEMENT shall continue in full force and effect, and this AGREEMENT shall be reformed to as closely as possible reflect the original terms of this AGREEMENT.
- 23. OWNER'S rights and obligations arising under this AGREEMENT shall be effective upon OWNER'S acquisition of the PREMISES.
- 24. This AGREEMENT was authorized by the minutes of the Commissioners Court of Waller County, Texas at a meeting on June 14, 2023, whereupon it was duly determined that the County Judge would execute the AGREEMENT on behalf of Waller County, Texas.
- 25. Venue for disputes arising under or related to this AGREEMENT shall lie exclusively in Waller County, Texas.
- 26. All amendments and additions to this AGREEMENT and its EXHIBITS must be approved by the Waller County Commissioners Court.
- 27. Signatories to this AGREEMENT represent and warrant that they have authority to bind the respective PARTIES.

This Detention Facilities Maintenance Agreement ("Agreement") is made by and among the Brookshire-Katy Drainage District, a political subdivision of the State of Texas ("District") and Fort Bend County Municipal Utility District No. 213, a political subdivision of the State of Texas ("MUD 213") and to be effective as of August 24, 2020 (the "Effective Date"). (District and "MUD 213" sometimes herein collectively referred to as "the Parties" or individually as "the Party" or "a Party").

RECITALS

WHEREAS, the MUD 213 is the owner of certain real property described as follows:

FOUR (4) tracts of land, a 0.8591 acre tract, a 0.8943 acre tract, a 0.9776 acre tract, and a 0.9801 acre tract, described in Deed dated June 29, 2020 from TWINWOOD (U.S.), INC., a Texas Corporation as Grantor to FORT BEND COUNTY MUNICIPAL DISTRICT NO. 213, a political subdivision of the State of Texas, as Grantee recorded in the Official Public Records, Waller County, Texas, under Clerk's File No. 2006203 and being more particularly described as follows:

TRACT ONE (1): A 0.8591 acre tract being out of a called 82.3025 acre tract in Nathan Brookshire League, Abstract 16, Waller County, Texas, as described in deed to Twinwwod (U.S.), Inc. as recorded in Volume 1393, Page 101, Official Public Records, Waller County, Texas, more particularly described by metes and bounds in Exhibit "A"

TRACT TWO (2): A 0.8943 acre tract being out of a called 82.3025 acre tract in Nathan Brookshire League, Abstract 16, Waller County, Texas, as described in deed to Twinwood (U.S.), Inc. as recorded in Volume 1393, Page 101, Official Public Records, Waller County, Texas, more particularly described by metes and bounds in Exhibit "A"

TRACT THREE (3): A 0.9776 acre tract being out of a called 477.895 acre tract of land in the William Cooper Survey, Abstract 20, Waller County, Texas, as described in deed to NBI Properties, Inc. as recorded in County Clerk's File No. 2006146817, Official Public Records, Fort Bend County, Texas, and Volume 998, Page 753, Official Public Records, Waller County, Texas, now known as Twinwood (U.S.), Inc. by instrument recorded in County Clerk's File No. 2012121483, Official Public Records, Fort Bend County, Texas and Volume 1330, Page 240, Official Records, Waller County, Texas, and more particularly described by metes and bounds in Exhibit "A"

TRACT FOUR (4): A 0.9801 acre tract being out of a called 477.895 acre tract of land in the William Cooper Survey, Abstract 20, Waller County, Texas, as described in deed to NBI Properties, Inc. as recorded in County Clerk's File No. 2006146817, Official Public Records, Fort Bend County, Texas, and Volume 998, Page 753, Official Public Records, Waller County, Texas, now known as Twinwood (U.S.), Inc. by instrument recorded in County Clerk's File No. 2012121483, Official Public Records, Fort Bend County, Texas and Volume 1330, Page 240, Official Records, Waller County, Texas,

and more particularly described by metes and bounds in Exhibit "A" attached hereto

hereinafter the "Property", which Property is located within the jurisdiction and boundaries of the Waller County, Texas, (hereinafter sometimes referred to as "County"), and the Brookshire-Katy Drainage District (hereinafter sometimes referred to as the "District"), and

WHEREAS, MUD 213 proposes to build Detention Facilities within the Property according to Detention Plans as herein defined and are expressly made a part hereof, as approved by the District, and MUD 213 agrees to provide for management of storm water within confines of the Property as hereinabove described to be made subject to this Agreement; and

WHEREAS, MUD 213 is desirous of constructing said Detention Facilities on the Property and the District is desirous of such development being commenced and completed in such manner as will provide for storm water drainage and detention in the area adjacent to the Property, and

WHEREAS, the County, District and MUD 213, and their successors and assigns, agree that the health, safety and welfare of the residents of Waller County and Brookshire-Katy Drainage District require that the Detention Facilities be constructed and maintained on the Property hereinabove described and to be made subject to this Agreement; and

WHEREAS, the County and District requires that the Detention Facilities as shown on the Detention Plans be constructed and adequately maintained by the MUD 213, its successors and assigns, the location and dimensions of which is shown and more particularly described by the Detention Plans dated March 27, 2020 ("Detention Plans") as shown in the attached Exhibit "B"; and

WHEREAS, this Agreement encumbers or will encumber the Property hereinabove described or to be made subject to this Agreement (defined herein), said Property being located in Waller County and Brookshire-Katy Drainage District, Waller County, Texas; and

WHEREAS, in association with the improvement of the Detention Facilities in accordance with this Agreement, MUD 213 seeks to construct, install, and maintain certain Detention Facilities defined in Exhibit "B" ("Detention Plans") attached hereto and made a part hereof, on the Property; and

WHEREAS, the District has required that MUD 213 enter into an agreement with the District regarding the construction, installation, maintenance, repair, and replacement of the Detention Facilities as a condition for approval of the Detention Plans; and

WHEREAS, the District, and the MUD 213, have agreed herein that a permit is to be issued and Property should be impressed with covenants and restrictions running with the land for the purpose of insuring proper storm water drainage and detention on the following terms and conditions; and

WHEREAS, the District, and MUD 213 desire to enter into this Agreement for the purpose of satisfying the foregoing condition;

NOW THEREFORE, in consideration of the premises and the mutual covenants contained herein and other valuable consideration the sufficiency and receipt of which are hereby acknowledged by the Parties, District, MUD 213 agree as follows:

MUD 213 and the District, for and in consideration of the premises and for other valuable consideration the receipt of which is hereby acknowledged, does hereby agree with respect to the Property described hereinabove, to be made subject to this Agreement, that this Agreement shall be deemed and considered as a covenant and restriction running with the land, and which shall be binding upon MUD 213, its successors and/or assigns as follows, to-wit:

Article I Definitions

For the purposes of this Agreement, the following words and phrases shall have the meanings set forth herein unless the context clearly requires otherwise:

"Detention Areas" means the areas on the Property where the Detention Facilities will be constructed, installed and maintained by MUD 213, as more particularly described on the Plans in **Exhibit "B"** attached hereto, to be made subject to this Agreement.

"Detention Facilities" means those certain storm water drainage and detention facilities, which may include but not be limited to, surface drainage swales, underground storm water pipes, additional collection tanks, pumps, controls, and storm water detention ponds to be constructed and installed by MUD 213 within the Property; The Detention Facilities includes all pipes, channels or other conveyances built to convey storm water to the Detention Facilities, as well as all structures, improvements, and vegetation provided to control the quantity and quality of the storm water. Adequate maintenance is herein defined as necessary activity by MUD 213 to maintain Detention Facilities in good working condition so that these facilities are performing their design functions with the design detention capacity and flow rates.

"<u>Detention Plans</u>" means any design and construction plans for the Detention Facilities located on the Property and approved by District, being Exhibit "B", attached hereto and a part of this Agreement.

"Development Regulations" means the ordinances, regulations, and policies, adopted by the County and District, as presently in effect and as adopted or amended after the Effective Date, which are applicable to the development and use of the Detention Facilities.

"Property" means the real property being:

FOUR (4) tracts of land, a 0.8591 acre tract, a 0.8943 acre tract, a 0.9776 acre tract, and a 0.9801 acre tract, described in Deed dated June 29, 2020 from TWINWOOD (U.S.), INC., a Texas Corporation as Grantor to FORT BEND COUNTY MUNICIPAL DISTRICT NO. 213, a political subdivision of the State of Texas, as Grantee recorded in the Official Public Records, Waller County, Texas, under Clerk's File No. 2006203 and being more particularly described as follows:

TRACT ONE (1): A 0.8591 acre tract being out of a called 82.3025 acre tract in Nathan Brookshire League, Abstract 16, Waller County, Texas, as described in deed to Twinwwod (U.S.), Inc. as recorded in Volume 1393, Page 101, Official Public Records, Waller County, Texas, more particularly described by metes and bounds in Exhibit "A"

TRACT TWO (2): A 0.8943 acre tract being out of a called 82.3025 acre tract in Nathan Brookshire League, Abstract 16, Waller County, Texas, as described in deed to Twinwwod (U.S.), Inc. as recorded in Volume 1393, Page 101, Official Public Records, Waller County, Texas, more particularly described by metes and bounds in Exhibit "A"

TRACT FOUR (4): A 0.9801 acre tract being out of a called 477.895 acre tract of land in the William Cooper Survey, Abstract 20, Waller County, Texas, as described in deed to NBI Properties, Inc. as recorded in County Clerk's File No. 2006146817, Official Public Records, Fort Bend County, Texas, and Volume 998, Page 753, Official Public Records, Waller County, Texas, now known as Twinwood (U.S.), Inc. by instrument recorded in County Clerk's File No. 2012121483, Official Public Records, Fort Bend County, Texas and Volume 1330, Page 240, Official Records, Waller County, Texas,

and more particularly described by metes and bounds in Exhibit "A" attached hereto

Article II Term

The term of this Agreement shall begin on the Effective Date and shall be perpetual, subject, however, to termination by the Parties as provided herein.

Article III Design and Construction

- 3.1 Specifications. The Detention Facilities shall be designed and initially constructed and/or installed by MUD 213 on the Property in compliance with the County's Regulations, and District's Rules and Regulations, Detention Plans and the Development Regulations.
- 3.2 <u>Silt Accumulation</u>. MUD 213 shall cause silt to be removed from the Detention Facilities, as necessary, for the Detention Facilities to serve their intended purposes of detention storage and flow rates.

3.3 <u>Inspection and Acceptance of the Detention Facilities.</u>

A. The inspection and approval of the Detention Facilities by County and District shall be conducted in the same manner as inspection and acceptance of other improvements constructed and/or installed in association with the development of property in Waller County, Texas, and Brookshire-Katy Drainage District, pursuant to the Rules and Regulations, as amended, and the current policies and procedures of the Waller County and Brookshire-Katy Drainage District.

B. MUD 213, its successors and assigns, shall cause its engineer to visually inspect the Detention Facilities annually and complete and deliver to the County and District, an annual inspection certificate, on a form substantially similar to the form attached hereto as Exhibit "C", attesting that the Detention Facilities have the capacity and ability to function in substantial conformity with the Detention Plans attached hereto as Exhibit "B".

C. MUD 213, its successors and assigns, hereby grant permission to the County or District, its authorized agents and employees, to enter upon the Property and to inspect the Detention Facilities whenever the County or District deems necessary.

Article IV Maintenance, Repair, Replacement, and Removal

4.1 <u>Detention Facilities to be Maintained by MUD 213.</u> Subject to and in accordance with the provisions of this Agreement, MUD 213, shall cause the Detention Facilities to be maintained and repaired at no cost to the County or the District. MUD 213 agrees to cause the Detention Facilities to be maintained in good working condition for their intended purpose of detention storage capacity and flow rates in accordance with the Detention Plans and appropriate Orders, Ordinances, Rules and Regulations.

4.2 <u>Maintenance Detention Facilities.</u>

A. In the event MUD 213 fails to repair or maintain the Detention Facilities as required by Section 4.1, above, the District may provide written notice to MUD 213 reflecting same. On or before the sixtieth (60th) calendar day after MUD 213 receives written notice from the District stating that the District believes MUD 213 has failed to maintain the Detention Facilities required by Section 4.1 above, MUD 213 shall perform such repairs and/or maintenance necessary and shall cause its engineer to provide an updated inspection certificate, on a form substantially similar to the

form attached as Exhibit C, reflecting that the Detention Facilities met the requirements of Section 4.1 above.

B. In the event MUD 213, its successors and assigns, fails to maintain the Detention Facilities in good working condition as specified herein, the County or District its authorized agents and employees, may enter upon the Property and take whatever steps necessary to correct deficiencies and shall invoice MUD 213 for work performed.

It is expressly understood and agreed that the County or District is under no obligation to routinely maintain or repair the Detention Facilities, and in no event shall this Agreement be construed to impose any such obligation on the County or District, such obligation is that of MUD 213.

C. Until such time as the Detention Facilities are abandoned, MUD 213 shall hold the District and County harmless from any property damages, personal injury, suits, actions, liabilities, damage, costs, or any other loss, claim, or cause of action arising from any damage, injury, or loss of life which may occur in connection with the operation or presence of the Detention Facilities installed in connection therewith, or enforcement by County or District of this Agreement.

4.3 Annual Inspection Certificate

- A. MUD 213 shall annually, on or before the first January 31st after the one (1) year anniversary date of this Agreement and on or before every January 31st thereafter until this Agreement is vacated as allowed in paragraph 4.3 D, deliver to the District an Annual Inspection Certificate executed by a Texas registered professional engineer, attesting that the Detention Facilities conform to the plans and specifications contained in the permit application and this Agreement, on a form substantially similar to the form attached as Exhibit "C".
- B. In the event an ambiguity exists in such form, District reserves the right to amend such form and require an amendment to such form to cure such ambiguity.
- C. If this Annual Inspection Certificate reflects changes or deviation in any manner or degree at any time this Agreement is in effect, MUD 213 must bring the Detention Facilities to compliance with this Agreement within sixty (60) days of the date of the Certification and provide the District with an updated Annual Inspection Certificate verifying compliance.
- D. At such time as a determination has been made that the use of the Detention Facilities is no longer necessary and such determination has been approved in writing by the District and any other governmental agency exercising control, direct or indirect, over such Detention Facilities, the Board of Supervisors of the District shall execute a recordable instrument vacating this Agreement, and such instrument shall expressly provide that the covenants and restrictions running with the land for the purpose of ensuring proper storm water drainage and said detention no longer apply to the Property nor will they thereafter be binding upon MUD 213 its successors and/or assigns.
 - E. MUD 213 shall contemporaneously with the execution of this Agreement, submit the certification by its registered professional engineer that the amount of drainage that results from the

Detention Facilities shall not exceed existing condition drainage and that the Detention Facilities and storm water releases shall not adversely impact adjacent and/or downstream property.

Article V Use of the Detention Facilities

5.1 Access. MUD 213 represents access to the Detention Facilities identified as the aforementioned 0.8591 acre tract, 0.8943 acre tract, 0.9776 acre tract, and 0.9801 acre tract is provided by a Temporary Easement and ultimately the record subdivision plat, and set out in Exhibit "D".

Article VI

Miscellaneous

6.1 Notices. When notice is permitted or required by this Agreement, it shall be in writing and shall be deemed delivered when delivered in person or on the date when placed, postage prepaid in the United States mail, certified return receipt requested, and addressed to the Parties at the address set forth below. A Party may designate from time to time another and different address for receipt of notice by giving notice of such change or address.

- 6.2 Address Change. By giving to the other parties hereto at least thirty (30) days written notice thereof, the parties hereto shall have the right at any time during the term of this Agreement to change their respective addresses to any other address within the United States of America.
- 6.3 Binding Effect. This Agreement shall be binding on and inure to the benefit of the Parties and their respective successors and permitted assigns.
- 6.4 Severability. In the event any section, subsection, paragraph, sentence, phrase or word herein is held invalid, illegal or unconstitutional, the balance of this Agreement shall be enforceable and shall be enforced as if the Parties intended at all times to delete said invalid section, subsection, paragraph, sentence, phrase or word.
- 6.5 Governing Law. The validity of this Agreement and any of its terms and provisions, as well as the rights and duties of the Parties, shall be governed by the laws of the State of Texas; and venue for any action concerning this Agreement shall be in a State Court of competent jurisdiction in Waller County, Texas. The Parties agree to submit to the personal and subject matter jurisdiction of said court.
- 6.6 Entire Agreement. This Agreement embodies the entire Agreement between the Parties and supersedes all prior Agreements, understandings, if any, relating to the Subdivision Plat, Detention Area, and Detention Facilities and the matters addressed herein and may be amended or supplemented only by written instrument executed by the Party against whom enforcement is sought.
- 6.7 Recordation of Agreement; Memorandum of Agreement. A copy of this Agreement shall be recorded in the Official Real Property Records of Waller County, Texas.
- 6.8 Recitals. The Recitals to this Agreement are incorporated herein as part of this Agreement.
- 6.9 Exhibits. All exhibits to this Agreement are incorporated herein by reference for all purposes wherever reference is made to the same.
- 6.10 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.
- 6.11 <u>Headings</u>. The headings of this Agreement are for the convenience of reference only and shall not affect in any manner any of the terms and conditions hereto.

- 6.12 Covenants Run With Land. The provisions of this Agreement are hereby declared covenants running with the Property and are fully binding on MUD 213 and each and every subsequent party designated as the "Declarant" under the Declaration.
- 6.13 Permit. This Detention Facility Agreement and Permit issued concurrently by the District, contains the entire Agreement between the parties hereto relative to the subject matter hereof and no variations, modifications or changes herein or hereof shall be binding upon any party hereto unless set forth in a document duly executed by or on behalf of such party.

6.14 Enforcement

- A. This covenant and Agreement shall run solely to and in favor of the District and shall be enforceable by the District, its successors and/or assigns. If any persons or persons shall violate or attempt to violate the foregoing Agreement or covenant, it shall be lawful for the District, its successors and/or assigns, to prosecute proceedings at law or in equity against the person or persons violating or attempting to violate the Agreement or covenant, and to obtain a temporary restraining order, and/or a temporary or permanent injunction to enforce this Agreement. If any part or provision of this Agreement or covenant herein contained shall be declared invalid or unenforceable by a Judge or Court Order, the same shall in no wise affect any of the other provisions of this Agreement. Any suit brought to enforce this Agreement, to determine the validity, as reasonable or otherwise, of any act or decision of MUD 213, including its representatives and employees, or its successors and/or assigns, shall be brought in a Court of competent jurisdiction in Waller County, Texas. The successful party in such suit shall be reimbursed by the other party for any reasonable attorncy's fees, pre-judgment and post judgment interest and all other costs of litigation incurred by the successful party seeking enforcement of this Agreement or the permit.
- B. District agrees not to bring an action hereunder until MUD 213 has been given written notice of default and MUD 213 has failed to cure such default within 60 days of receipt of such notice of default from the District.
- 6.15 No consent or waiver, express or implied, by either party to any breach or default by any other party in the performance by the other of its obligations hereunder shall be deemed to construe to be a consent or waiver to or of any other breach or default in the performance by such other party of the same or any other obligations hereunder. Failure on the part of any party to complain of any act or failure to act of any other party or to declare the other party in default, irrespective of how long such failure continues, shall not constitute a waiver by said party of its rights hereunder.
- 6.16 This Agreement shall inure to the benefit of and be binding upon the undersigned parties and their respective successors and assigns. Whenever, in this instrument, a reference to any party is made, such reference shall be deemed to include a reference to the heirs, executors, legal representatives, successors, and assigns or such party but not any third parties.
- 6.17 This Agreement may be signed in any number of counterparts, each of which shall be an original for all purposes, but all of which taken together shall constitute only one Agreement. The production of any executed counterpart of this Agreement shall be sufficient for all purposes without producing or accounting for the other counterparts hereof.

- 6.18 This Agreement is intended to be, performed in accordance with, and only to the extent permitted by, all applicable laws, ordinances, rules, and regulations of the State of Texas.
- 6.19 If any provisions of this Agreement, or the applications thereof to any person or circumstance, shall, for any reason and to any extent, be invalid or unenforceable, the remainder of this Agreement and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.
- 6.20 The rights created herein, in favor of the District shall be enforced by the District in its sole discretion and shall not constitute an obligation by the District to commence any action authorized in this Agreement.
- 6.21 The County, District and MUD 213 reserve their Sovereign Immunity as provided by the Common Laws, Statutes, and Constitution of the State of Texas.
- 6.22 This Agreement imposes no liability of any kind whatsoever on the County or District.
- 6.23 Indemnification. TO THE EXTENT PERMITTED BY APPLICABLE LAW, MUD 213 AGREES TO HOLD THE COUNTY OR DISTRICT HARMLESS FROM ANY LIABILITY IN THE EVENT THE DETENTION FACILITIES FAIL TO OPERATE PROPERLY. MUD 213 COVENANTS AND AGREES AND DOES HEREBY INDEMNIFY, HOLD HARMLESS AND DEFEND THE COUNTY AND DISTRICT, ITS REPRESENTATIVES, AGENTS, SERVANTS, AND EMPLOYEES, FROM AND AGAINST ALL COSTS, EXPENSES, LOSSES, DAMAGES, CLAIMS OR CAUSES OF ACTION WHATSOEVER ARISING, OR WHICH MIGHT ARISE, FROM THE FAILURE OF MUD 213 OR ANY FUTURE OWNERS OF THE ABOVE FACILITY PROPERTY TO MAINTAIN THE DETENTION FACILITIES, INCLUDING, BUT NOT LIMITED TO THE BED AND BANKS OF THE DETENTION POND; ANY DAMAGES CAUSED TO PERSON OR PROPERTY DUE TO (1) FLOODING OF THE POND AND ITS BANKS, (2) SLOPE FAILURE OF THE BANKS OF THE POND, OR (3) FAILURE OF THE POND OR ITS BANKS TO OPERATE IN A MANNER CONSISTENT WITH COUNTY OR DISTRICT CRITERIA TO PERFORM ANY OTHER DUTIES OR OBLIGATIONS HEREUNDER.

PURCHASE AND SALE AGREEMENT

This PURCHASE AND SALE AGREEMENT ("Agreement") is made and entered into as of the date this Agreement is countersigned by the Controller of the City of Houston, Texas (the date of such counter-signature being hereafter referred to as the "Effective Date") by and between CITY OF HOUSTON, TEXAS, a municipal corporation and home-rule city situated in Harris, Fort Bend and Montgomery Counties, Texas (the "City" or "Seller"), and WALLER COUNTY, TEXAS, a political subdivision of the State of Texas ("Waller County" or "Purchaser"), and together the "Parties".

WHEREAS, the City, acting through HAS, is the holder of a Clean Water Act dredge and fill permit No. 21948(01)/SWG-2000-02727 (the "Permit"), attached hereto as Exhibit "C-1" and incorporated herein for all purposes, issued under cover of letter dated April 8, 2002, by the U.S. Army Corps of Engineers, Galveston Branch ("USACE"), as later amended on April 8, 2002, attached hereto as Exhibit "C-2", and incorporated herein for all purposes, for the impact to the jurisdictional waters of the United States (wetlands) for several major capital improvement projects at George Bush Intercontinental Airport/Houston ("IAH"), including the north runway, the Consolidated Rental Car Facility, East Cargo and other associated projects which commenced in 1999; and

WHEREAS, the Permit required the City of Houston to, among other things, secure a conservation easement on the 915-acre tract of land in Montgomery County ("Bahr Woods Preserve") and construct wetlands and preserve in perpetuity a 600-acre parcel out of an approximately 1,431-acre tract (the "Property" as more particularly described below and shown in Exhibit "C-3") owned by the City in Waller County in the Katy Prairie ("Waller County Mitigation Site" or "Westside Mitigation Site"); and

WHEREAS, on August 25, 2014, USACE notified the Houston Airport System ("HAS") that the wetland mitigation criteria for the Permit was satisfied (attached hereto as Exhibit "D") and that the Permit number was changed to SWG-2000-02727; and

WHEREAS, on May 19, 2021, Waller County adopted a Parks, Trails, & Open Space Master Plan in an effort to ensure that the County grows responsibly while retaining its natural legacy. The County desires to pursue opportunities to formalize a plan for County-operated parks, trails, and other open space facilities through the development of a formal parks system; and

WHEREAS, Waller County was appropriated funds by the 89th Legislature of the State of Texas, Regular Session of 2025 in Senate Bill 1 for a Waller County Regional Stormwater Detention Basin, and desires to acquire the Property from the City for such a purpose, as well as future public park, trails, open space or other public purposes with uses on the 600 acres that would be compatible with the Permit; and

WHEREAS, the City satisfied the conditions of the Permit and the Property does not now, nor will it in the future, serve a civil aviation purpose for the City; and

WHEREAS, the proceeds from the sale of the Property will serve to benefit civil aviation in the City;

NOW, THEREFORE, for and in consideration of the premises, mutual benefits, covenants and agreements contained herein, Waller County and the City agree as follows:

AGREEMENT:

Seller and Purchaser hereby agree as follows:

1. <u>SALE AND PURCHASE</u>. Seller hereby agrees to sell, convey, and assign to Purchaser and Purchaser hereby agrees to purchase and accept from Seller, for the Purchase Price (hereinafter defined) and on and subject to terms and conditions herein set forth certain tracts or parcels of land being designated as:

Tract 1: 706.172 acres (30,760,837 square feet) tract of land situated in the H. & T.C.R.R. Surveys, Section 79, Abstract 157 and Section 81, Abstract 158 and the J. G. Bennett Survey, Section 82, Abstract 290 in Waller County, Teas and being out of those certain tracts described in the deeds recorded in Volume 23, Pages 585 and 587 of the Waller County Deed Records (W.C.D.R.).

<u>Tract 2:</u> 719.600 acres (31,345,772 square feet) tract of land situated in the H. & T.C.R.R. Surveys, Section 69, Abstract 152 and the J. G. Bennett Survey, Section 68, Abstract 289 in Waller County, Texas and being out of that certain 1,283.366-acre tract described in the deed recorded in Volume 21, Page 116 of the Waller County Deed Records (W.C.D.R.).

Tract 3: 5.982 acres (260,574 square feet) tract of land situated in the H. & T.C.R.R. Survey, Section 79, Abstract 157, in Waller County, Teas and being out of that certain tract described in the deed recorded in Volume 23, Page 587 of the Waller County Deed Records (W.C.D.R.).

Waller County Appraisal District Property IDs: 10838, 10918, 10919, 10933, 13044, and 13059

together with all rights and interests appurtenant thereto, including all of Seller's right, title and interest, if any, in and to adjacent streets, alleys, rights-of-way, easements, any adjacent strips or gores of land, any awards made or to be made as a result or in lieu of condemnation, any awards for damage to the Property (as hereinafter more specifically defined) or any part thereof by reason of casualty (all of the above being hereinafter collectively referred to as the "Land"); and all improvements of every kind and description in, on, over and under the Land ("Improvements"). The Land and Improvements are herein collectively called the "Property." All of the Property shall be conveyed, assigned and transferred to Purchaser at Closing (as hereinafter defined) free and clear of all liens, claims, easements and encumbrances whatsoever, except for the Permitted Encumbrances (as hereinafter defined).

PURCHASE PRICE. The price ("Purchase Price") for which Seller agrees to sell and convey the Property to Purchaser, and which the Purchaser agrees to pay to Seller, subject to the terms hereof, is:

NINETEEN MILLION SEVEN HUNDRED FORTY THOUSAND AND 00/100 DOLLARS (\$19,740,000.00).

Purchaser shall pay the Purchase Price to Seller in good funds on the Closing Date, as hereinafter defined, subject to any adjustments provided elsewhere in this Agreement.

- 3. <u>SELLER'S REPRESENTATIONS, WARRANTIES AND COVENANTS</u>. Seller hereby represents and warrants to, and covenants with Purchaser that:
 - a. Seller will have as of the Closing Date (as hereinafter defined), good and indefeasible title in fee simple to the Land and Improvements, subject only to the Permitted Encumbrances, and free and clear of all liens;
 - b. Seller shall use good faith efforts to promptly notify in writing Purchaser of any material change with respect to the Property or with respect to any information heretofore or hereafter obtained by Seller respecting the Property;
 - c. There are none and, as of the Closing Date (as hereinafter defined), there will be none of the following:
 - (i) Tangible personal property and fixtures ("Personalty") of any kind owned by Seller and attached to, located on or used in connection with the ownership, maintenance, or operation of the Property that will not be conveyed to Purchaser at Closing,
 - (ii) Leases, franchises, licenses, occupancy agreements or other agreements (collectively, "Leases") demising space in, providing for the use or occupancy of, or otherwise similarly affecting or relating to, the Property, or prepaid rents ("Rents"), or deposits, security or otherwise (collectively, "Deposits") made by tenants, and,
 - (iii) (contracts or agreements, such as maintenance, service or utility contracts; (warranties, guaranties, indemnities or claims; licenses or permits; or other property owned or held by Seller which relates, in any way, to the design, construction, ownership, use, leasing, maintenance, service or operation of the Property, Personalty, Leases, Rents, or Deposits;
 - d. There are no actions, suits, claims, assessments, or proceedings pending or, to the actual knowledge of Seller, threatened that could materially adversely affect the ownership, operation, or maintenance of the Property or Seller's ability to perform hereunder;

- e. From the date hereof until the Closing Date (as hereinafter defined), Seller shall:
 - (i) maintain the Property in a good and business-like manner in accordance with good and prudent business practices, and not commit or consent to be committed any waste to the Property,
 - (ii) not enter into any agreement or instrument or take any action which would constitute an encumbrance of the Property, which would bind Purchaser or the Property after Closing or which would be outside the normal scope of maintaining and operating the Property, without the prior written consent of Purchaser, and
 - (iii) afford Purchaser and its representatives the continuing right to inspect the Property during the Inspection Period (as hereinafter defined) at reasonable hours and upon reasonable notice, and any and all books, records, contracts, and other documents or data pertaining to the ownership, insurance, operation, or maintenance of the Property;
- f. All bills and other payments due from Seller with respect to the ownership, operation, and maintenance of the Property have been (or by the Closing Date will be) paid by Seller and no liens or other claims for the same have been filed or asserted against any part of the Property;
- g. Seller has full right, power and authority to execute, deliver, and perform this Agreement without obtaining any consents or approvals from, or the taking of any other actions with respect to any third parties, and this Agreement, when executed and delivered to Seller and Purchaser, will constitute the valid and binding agreement of Seller, enforceable against Seller in accordance with its terms; and,
- h. Seller is not a "foreign person" (as defined in Internal Revenue Code Section 1445(f)(3) and the regulations issued thereunder).
- i. This Agreement is subject to approval of this Agreement, by the City Council of the City of Houston, Texas; the signature of this Agreement by the Mayor; and counter-signature of the City Controller of the City of Houston, Texas, but otherwise without obtaining any consents or approvals from, or the taking of any other actions with respect of, any third parties (or if any such consents, approvals, or other actions are required, the same will be accomplished prior to the Closing Date, as hereinafter defined).
- j. This Agreement is further subject to advanced, written approval by the Federal Aviation Administration ("FAA") and the United States Army Corps of Engineers ("USACE").

k. This Agreement, when executed and delivered by Seller and Purchaser, in the manner and subject to the approvals described above, will constitute the valid and binding agreement of the Parties, enforceable by one Party against the other in accordance with its terms.

4. PURCHASER'S REPRESENTATIONS, WARRANTIES, AND COVENANTS.

- a. Purchaser (i) is not in receivership or dissolution; (ii) has not made any assignment for the benefit of creditors; (iii) has not admitted in writing its inability to pay their debts as they mature; (iv) has not been adjudicated a bankrupt; (v) has not filed a petition in voluntary bankruptcy, a petition or answer seeking reorganization, or an arrangement with creditors under the federal bankruptcy law, or any other similar law or statute of the United States or any state; and (vi) does not have any such petition described in (v) filed against Buyer.
- b. Purchaser hereby represents and warrants to, and covenants with, Seller that Purchaser has full right, power, and authority to execute, deliver, and perform this Agreement subject, however, to approval of this Agreement and the appropriation of funds related thereto by the Commissioners Court of Waller County.
- c. Purchaser must maintain the Waller County Mitigation Site authorized by the Permit in good condition and in conformance with the terms and conditions of the Permit, or any modification thereof. Purchaser is not relieved of this requirement if Purchaser abandons the permitted activity, although Purchaser may make a good faith transfer to a third party by obtaining the signature of the new owner in the space provided in the Permit and forward a copy of the Permit to the USACE to validate the transfer of this authorization. Should Purchaser wish to cease to maintain the permitted activity or should Purchaser desire to abandon it without a good faith transfer, Purchaser must obtain a modification of this Permit from the USACE, which may require restoration of the area.
- d. Purchaser shall assume the responsibilities of the permittee, City of Houston, to protect the 600-acre Waller County Mitigation Site in perpetuity. Purchaser will not sell or transfer the property, nor allow the property to be developed in any fashion, including placement of fill material into or draining of the wetlands that currently exist or exist at any point in the future on the property, without the approval of the USACE. All passive management activities on the site must have USACE written approval prior to their implementation.
- e. Within six (6) months' of the Closing, Purchaser shall convey a conservation easement on the 600-acre Waller County Mitigation Site to a conservation organization, such as the Coastal Prairie Conservancy (formerly the Katy Prairie Conservancy). The Purchaser will make a one-time monetary contribution to a stewardship fund of the conservation organization. The monetary contribution shall be determined by the conservation organization. This contribution will be dedicated to the long-term management of the Waller County Mitigation Site area

- in perpetuity. Purchaser shall also pay any other fees required for the conservation organization's acceptance of a conservation easement.
- f. Purchaser shall perform ongoing maintenance activities at the Waller County Mitigation Site to include, but not limited to, mowing of upland and wetland areas (during dry periods) to control invasive species, berm and water control structure inspection and maintenance, fertilization of upland areas, erosion control, and overall land use management.

5. TITLE REPORT AND SURVEY.

- a. Within thirty (30) days following the Effective Date, Seller, at its sole cost and expense, shall deliver or cause to be delivered to Purchaser a Commitment for a Texas form Owner Policy of Title Insurance ("Title Commitment") issued by Stewart Title Guaranty Company, as underwriter, through its local agent Texas American Title Company ("Title Company"), whose address is 3000 Research Forest Drive, Suite 110, The Woodlands, TX 77381 (primary contact: Shannon Gandy), setting forth the status of the title of the Property and showing all liens, claims, encumbrances, easements, rights-of-way, encroachments, reservations, restrictions, and any other matters affecting the Property.
- b. Seller shall permit Purchaser, at Purchaser's sole cost and expense, to have a survey (the "Survey") prepared by a licensed surveyor acceptable to the Title Company, which Survey shall (i) reflect the actual dimensions of, and area within, the Land, the location of any easements, set-back lines, encroachments, or overlaps thereon or thereover, and the outside boundary lines of all Improvements; (ii) identify all easements, set-back lines, and other matters referred to on the Title Commitment by volume and page reference; (iii) include the surveyor's registered number and seal, the date of the Survey, and a certificate satisfactory to Purchaser, in its reasonable discretion; (iv) be sufficient to cause the Title Company to delete (except for "shortages in area") the printed boundary exceptions in any Owner's Title Policy, if Purchaser elects to obtain same at its cost; (v) reflect any area within the Land that has been designated by the Federal Insurance Administration, the Army Corp of Engineers, or any other governmental agency or body as being subject to special flooding hazards; and (vi) in general, comply with the requirements of the Texas Surveyor's Association for a Category I Condition 2A Survey.
- c. Purchaser shall have until the later of (a) five (5) days' prior to the Closing Date or (b) thirty (30) days after receipt of the items to be delivered pursuant to Sections 5(a), and 5(b) above (the "Title Inspection Period") to examine such items and to specify to Seller those items affecting the Property which Purchaser finds objectionable (the "Encumbrances"). Items shown in the Title Commitment or Survey and not objected to by Purchaser in its written objections within such Title Inspection Period shall be deemed items which Purchaser will accept title subject to (the "Permitted Encumbrances"). The Title Company shall deliver at Closing an

amended Title Commitment, to the extent Seller cures the Encumbrances, reflecting the cure of such matters. Notwithstanding anything to the contrary herein, any monetary liens affecting the Property shall be Encumbrances, whether or not so specified in any notice by Purchaser, and Seller shall cause the same to be released at or prior to Closing except real estate taxes and other assessments not yet due and payable, which shall be customarily prorated at closing.

- d. If Seller fails or is unwilling to cause all of the Encumbrances to be removed or cured by the Closing Date, or if the Title Commitment or Survey indicates that Seller does not own indefeasible fee simple title to the Property, Purchaser shall have the following rights, as its sole and exclusive remedies:
 - i. Purchaser may terminate this Agreement by giving Seller written notice thereof, in which event the Earnest Money which shall be paid to Seller, shall be returned to Purchaser, and neither party shall have any further rights, duties, or obligations hereunder; or
 - ii. Purchaser may elect to waive the Encumbrances not so removed or cured and close the purchase and sale contemplated by this Agreement without any reduction in the Purchase Price in accordance with the remaining terms and provisions, whereupon the Encumbrances not so removed or cured shall become Permitted Encumbrances to be treated in the manner provided herein for Permitted Encumbrances.

6. <u>INSPECTION PERIOD</u>.

a. Purchaser acknowledges that it had a period of thirty (30) days (the "Inspection Period") during which time Purchaser conducted, at Purchaser's sole cost and expense, such inspections, studies and evaluations of the Property as Purchaser deemed necessary or desirable to assist Purchaser in determining the suitability and condition of the Property (the written products of such inspections, studies and evaluations being hereinafter collectively referred to as the "Environmental Reports"). Such studies and evaluations may have included, without limitation, an environmental study conducted by an environmental engineering company selected by Purchaser and may have included such soil testing and other invasive and noninvasive procedures as may be indicated to detect the presence of environmental pollutants or hazards on or under the Property, within any surface or underground water on the Property or within the structure of any building or other improvements on the Property. If Purchaser obtained an environmental site assessment during the Inspection Period and the assessment indicated that additional testing should be performed to determine the extent of contamination, Purchaser could have extended the Inspection Period for up to thirty (30) days for such additional testing. Purchaser acknowledges that no additional time for inspection, verification or additional testing was requested and hereinafter waives the right to conduct same.

- b. Purchaser acknowledges that it had the right and option, at its sole and absolute discretion, to terminate this Agreement at any time on or before the expiration of the Inspection Period and did not exercise that right/option.
- 7. <u>CLOSING</u>. The consummation by the parties of the transaction contemplated by this Agreement and the date of such event is herein called the "Closing." Closing shall take place after the expiration of the Inspection Period at the offices of Title Company, with the exact time and date (the "Closing Date") of Closing to be specified in a written notice from Seller to Purchaser given at least seven (7) days in advance of such date. The time, date and location shall be mutually agreed upon by Seller and Purchaser. At the Closing, the following (which are mutually concurrent conditions) shall occur:
 - a. Purchaser, at its sole cost and expense, shall deliver or cause to be delivered to Seller, through the Title Company:
 - i. The balance due for the Purchase Price as set out in Section 2 hereof, adjusted as provided for in Sections 7(c) and 13 hereof, such amount to be by warrant or wire-transfer to the respective title company;
 - ii. Evidence satisfactory to Seller and the Title Company that the person executing the Closing documents on behalf of Purchaser has full right, power, and authority to do so; and,
 - iii. Such other instruments duly executed by Purchaser as are customarily executed in Texas to effectuate the conveyance of property similar to the Property as may be reasonably required by the Title Company.
 - b. Seller, at its sole cost and expense, shall deliver or cause to be delivered to Purchaser, through the Title Company, the following:
 - i. A Special Warranty Deed in form and substance substantially equivalent to the form of that attached hereto as Exhibit "E," fully executed and acknowledged by Seller, conveying to Purchaser good and indefeasible fee simple title in and to the Land and any Improvements thereon, subject only to the Permitted Encumbrances, which shall be set forth in an exhibit thereto and attached prior to recordation of such instrument;
 - ii. An executed and acknowledged affidavit in form and substance substantially equivalent to the form of that attached hereto as Exhibit "F," that Seller is not a "foreign person" as described in Section 3(h) herein, pursuant to 26 U.S.C. § 1445 and Treasury Regulations § 1.1445-2(b)(2)(iii);
 - iii. A certificate confirming that there are no unpaid bills, claims, debts, or liens relating to the Property arising through or under Seller as of the Closing Date except with respect to specified bills, claims, debts, or liens;

- iv. Such other instruments duly executed by Seller as are customarily executed in Texas to effectuate the conveyance of property similar to the Property as may be reasonably required by the Title Company with the effect that, after the Closing, Purchaser will have succeeded to all of the rights, titles and interests of Seller related to the Property and Seller will no longer have any rights, titles or interests in and to the Property.
- Seller shall pay, in addition to any other costs to be paid by Seller as provided c. elsewhere herein, Seller's own attorneys' fees and any costs and recording and filing any releases of Encumbrances and the cost to cure or otherwise obtain any such release. Purchaser shall pay, in addition to any other costs to be paid by Purchaser as provided elsewhere herein, the title insurance premium for any title insurance acquired by Purchaser, any costs of inspecting or evaluating the Property, the costs for obtaining tax certificates, recording and filing the Special Warranty Deed, and Purchaser's own attorneys' fees. Any escrow fees and delivery fees charged by the Title Company shall be split equally by Seller and Purchaser, and all normal and customarily proratable items, including without limitation, real estate and personal property taxes, and utility bills, if any, which have become due and payable within the calendar year in which the closing occurs shall be prorated as of the Closing Date, Seller being charged and credited for all of the same up to such date and Purchaser being charged and credited for all of same on and after such date. Seller and Purchaser hereby acknowledge that neither Party is subject to ad valorem taxes. The provisions of this Section 7(c) shall survive the Closing.
- d. On the Closing Date, Seller shall (i) vacate the Property; (ii) remove all personal property of any kind owned by Seller and attached to, located on or used in connection with the ownership, maintenance, or operation of the Property; and (iii) deliver to Purchaser possession of the Property with all parts of the Property in the same condition as of the Effective Date herein.
- **NOTICES.** Any notice provided or permitted to be given under this Agreement must be in writing and may be served by depositing same with the United States Postal Service, addressed to the party to be notified, postage prepaid and in registered or certified form, with return receipt requested, or by deposit with a reputable overnight courier for overnight delivery. Notice given as aforesaid shall be effective on the date actually received at the address to which such notice was sent, or if delivery is refused or not accepted, such notice shall be effective on the date of such refusal or failure to accept delivery. Notice given in any other manner shall be effective only upon receipt by the party to whom it is addressed. For purposes of notice, the addresses of the parties shall be as follows:

Either party may change its address to another location in the continental United States, upon five (5) days' prior written notice to the other given in the manner provided above.

9. BROKERAGE COMMISSIONS. Purchaser has not contracted for the payment of any real estate commission, brokerage, finder or other fees with respect to the sale of the Property to Purchaser. Purchaser warrants to Seller that Purchaser has not contracted with an agent for the purchase of the Property. Purchaser warrants to Seller that Purchaser has not contracted for the payment of any real estate commission, brokerage, finder, or other fees with respect to the purchase of the Property from Seller. In no event shall Seller be responsible for any broker, agent, finder or other fees and commissions associated with the purchase of the Property by Purchaser.

10. ASSIGNMENT.

Purchaser may not assign this Agreement or any right or interest hereunder. Seller may not assign this Agreement or any right or interest hereunder. This Agreement shall inure to the benefit of and be binding on the parties hereto and their respective heirs, legal representatives, successors and permitted assigns.

11. **GOVERNING LAW**.

- a. This Agreement shall be governed and construed in accordance with the laws of the State of Texas. Any action brought to enforce or interpret this Agreement shall be brought in the court of appropriate jurisdiction in Waller County, Texas.
- b. Should any provision of this Agreement require judicial interpretation, Seller and Purchaser hereby agree and stipulate that the court interpreting or considering the same shall not apply the presumption that the terms hereof shall be more strictly

- construed against a party by reason of any rule or conclusion that a document should be construed more strictly against the party who prepared the same, it being agreed that all parties hereto have participated in the preparation of this Agreement and that each party had full opportunity to consult legal counsel of its choice before the execution of this Agreement.
- c. The City Attorney or his or her designee shall have the right to enforce all legal rights and obligations under this Agreement without further authorization from other City officials, and Seller covenants to provide the City Attorney with all documents and records that the City Attorney reasonably deems necessary to assist in determining Seller's compliance with this Agreement, with the exception of those documents made confidential by federal or State law or regulation.
- 12. <u>EARNEST MONEY</u>. Within thirty (30) days after Purchase and Sale Agreement has been signed by Houston Airport Director Jim Szczesniak, Purchaser shall submit earnest money payable to the City of Houston, Texas in the amount of **ONE MILLION NINE HUNDRED SEVENTY-FOUR THOUSAND AND NO/100 DOLLARS (\$1,974,000)** ("Deposit") with Texas American Title Company which shall be held in an interest-bearing account as earnest money to bind the transaction contemplated hereby. Unless otherwise delivered to Seller or Purchaser pursuant to the terms thereof, the Earnest Money, together with all interest thereon, together with all interest thereon, shall be credited to the Purchase Price at the Closing.

13. <u>REMEDIES</u>.

- a. If Purchaser fails or is unable to perform its obligations pursuant to this Agreement for any reason other than Purchaser's termination hereof pursuant to a right granted to Purchaser in this Agreement to do so, or breach by Seller of its representations, warranties or agreements hereunder, then Seller, as its sole and exclusive remedy, shall have the right to terminate this Agreement by giving Purchaser written notice thereof, in which event neither party hereto shall have any further rights, duties, or obligations hereunder and the Earnest Money shall be retained by Seller, as liquidated damages (and not as penalty) for the breach by Purchaser. Seller and Purchaser hereby acknowledge that the amount of damages resulting from a breach of this Agreement by Purchaser would be difficult or impossible to accurately ascertain.
- b. If Seller fails or is unable to perform any of its obligations or agreements hereunder, either prior to or at Closing, or if any of Seller's representations or warranties made hereunder, or any of the information furnished by Seller pursuant hereto, should be either false or misleading in any material respect, Purchaser, shall have the right and option, as its sole and exclusive remedies, to:
 - (i) terminate this Agreement by giving Seller written notice thereof, in which event neither party hereto shall have any further rights, duties, or obligations

- hereunder and the Seller shall return the Earnest Money to be delivered to Seller, to Purchaser; or
- (ii) enforce specific performance of the obligations of Seller to convey and assign the Property to Purchaser pursuant to the terms hereof and perform its other obligations hereunder.
- 14. DAMAGE OR TAKING PRIOR TO CLOSING. Prior to Closing, risk of loss with regard to the Property shall be borne by Seller. If, prior to Closing, the Property, or any portion thereof, is materially damaged or becomes subject to a taking (other than by the Purchaser) by virtue of eminent domain, Purchaser shall have the option, which must be exercised by it within fifteen (15) business days (and the Closing will be automatically extended, if necessary, to provide Purchaser with such fifteen (15) business day period) after its receipt of written notice from Seller advising of such damage, or taking (which Seller hereby agrees to give), to terminate this Agreement or to proceed with the Closing. If Purchaser elects to terminate this Agreement, all rights, duties, obligations and liabilities created hereunder shall cease, and the Earnest Money to be delivered to Seller, shall be returned to Purchaser. If Purchaser elects to proceed with the Closing, all rights, duties, obligations and liabilities created hereunder shall continue and Purchaser shall be entitled to any and all insurance proceeds or condemnation awards payable as a result of such damage or taking and Seller shall assign to Purchaser at Closing Seller's rights to such proceeds or awards.
- 15. <u>ENTIRE AGREEMENT</u>. This Agreement is the entire agreement between Seller and Purchaser concerning the sale of the Property and no modification thereof or subsequent agreement relative to the subject matter hereof shall be binding on either party unless in writing and signed by the party to be bound.

- d. Time is of the essence in this Agreement.
- e. This Agreement is subject and subordinate to the terms and conditions of any existing or future agreement entered into between the Purchaser and the United States of America for the improvement or operation and maintenance of airport property owned by the Purchaser, the execution of which has been or may be required as a condition precedent to the transfer of federal rights or property to the Purchaser, or the expenditure of federal funds for the improvements or development of airports owned or operated by the purchaser.
- f. Following the execution of this Agreement by Seller, the Director of the Houston Airport System shall have the authority to act on behalf of the Seller in making extensions to the date of Closing of up to one (1) year or to make other non-substantive modifications to this Agreement for the purposes of enabling the achievement of the Purchaser's objectives to acquire the Property from Seller.



WESTSIDE MITIGATION SITE SITE LAYOUT MAP JUNE 6, 2005

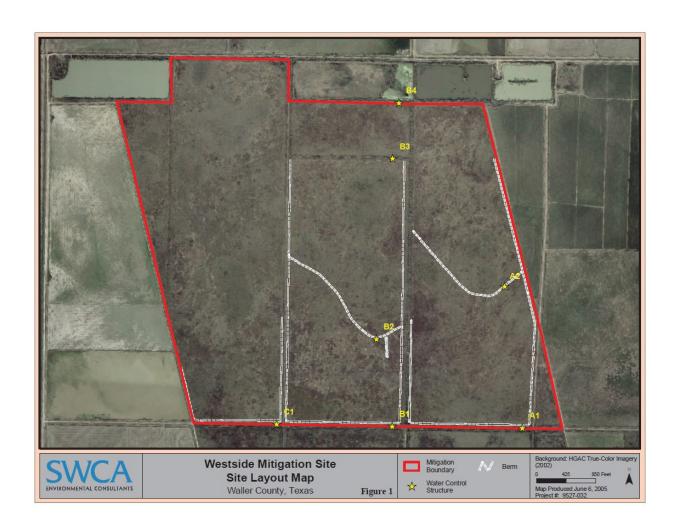



WESTSIDE MITIGATION SITE SITE LAYOUT MAP JUNE 6, 2005

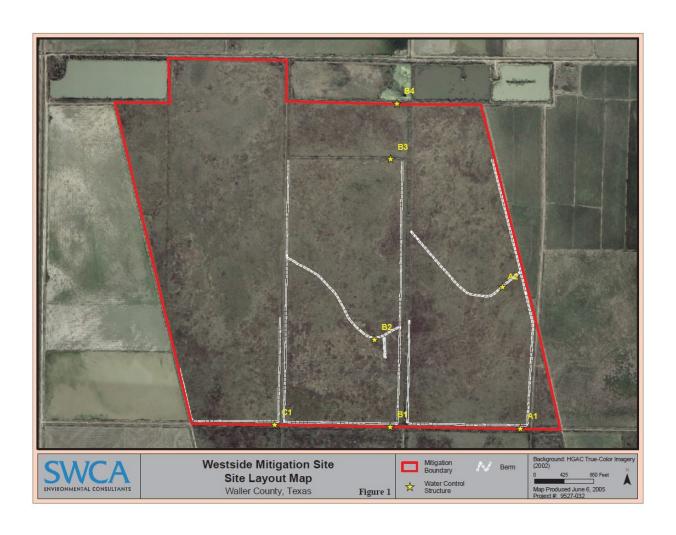

A governing body may cast all its votes for one candidate or distribute them among candidates for any number of directorships.

The vote must be by resolution. The resolution, or a certified copy thereof, together with the complete OFFICIAL BALLOT, must be delivered to Becky Gurrola, Chief Appraiser, at 900 13th Street, Hempstead, Texas 77445 (mailing address P.O. Box 887, Hempstead, Texas 77445), before, December 15, 2025.

Before December 31, 2025, the chief appraiser will count all timely cast votes and declare elected the five candidates which receive the highest number of votes. The election results will be submitted to the governing body of each voting taxing unit and to the candidates. The chief appraiser shall resolve a tie vote by any method of chance.
