- 3. TAP Grant Update: City-Wide Bicycle and Pedestrian Master Plan RFP Results and Summary: Second RFP resulted in 2 proposals; City in contract negotiations with selected consultant and WisDOT, using WisDOT's three-party contract process. Project is anticipated to start in late fall.

The Community Engagement portion of the project will seek feedback from the public, this task force, and other stakeholders. The task force provided the following suggestions & locations for the Community Engagement portion of the project:

Stakeholders may include employers, such as TREK (many TREK employees live in Watertown).

Bike & Pedestrian Plan will take into account new developments, including Rock River Ridge, the Fire Station, etc.

- 4. Update: S. First Street and Western Avenue project: Project area scheduled for construction in 2025 is S. First Street between Milwaukee Street and Western Avenue, and Western Avenue from S. First Street to S. Third Street. Proposed project improvements include on-street bike lane improvements, lane makings, crosswalk, signage, etc. Glacial River Trail runs through this project area. A detour will be in place during construction. No comments from Task Force.
- TAP Grant Update: S. Church Street Shared-use Path: City received grant award for construction of a shared-use path along S. Church Street, between Jefferson Road and Air Park Drive. Next steps: City staff to post a Request for Proposals (RFP) for design services in 2025.

Subject: Tivoli Island Historic Bridge Study Update

Background

The City of Watertown was awarded a Transportation Alternatives Program (TAP) Grant from WisDOT for an evaluation of Tivoli Island Historic Bridge. This is the first step in assessing the condition of this unique structure, to be used in future grant and funding alternatives to protect the structure into the future. This bridge is used to access Tivoli Island and is primarily used for pedestrians and bicyclists. Cars and other vehicles do not use this bridge.

An Request for Proposals (RFP) for a consulting firm to evaluate the historic nature of this bridge is currently posted; proposals are due May 16, 2025. After selection of a consultant, City staff will work with the consultant and WisDOT on the third-party contract format that is use for these grants. Project work is anticipated to start this winter.

Budget Goal

- 1. Proactively maintains and improves our parks and infrastructure to ensure safety, quality, and equity
- 2. Fosters community growth by assessing opportunities, stakeholder input, environmental needs, and modern code and policy priorities
- 3. Maintains a safe and healthy community, with an eye toward future needs and trends

Financial Impact

The WisDOT TAP Grant funds 80% of the study, up to \$25,600.00.

Subject: S. Church Street Shared-use Path TAP Grant- Update

Background

The City of Watertown was awarded a Transportation Alternatives Program (TAP) Grant from WisDOT for construction of the S. Church Street Shared-use Path. The proposed path will run along S. Church Street, between Jefferson Road and Air Park Drive.

An Request for Proposals (RFP) for a consulting and engineering firm to design the path is currently posted; proposals are due May 13, 2025. Design is planned for 2025 and 2026, with construction in 2027.

Budget Goal

- 1. Proactively maintains and improves our parks and infrastructure to ensure safety, quality, and equity
- 2. Fosters community growth by assessing opportunities, stakeholder input, environmental needs, and modern code and policy priorities
- 3. Maintains a safe and healthy community, with an eye toward future needs and trends

Financial Impact

The WisDOT TAP Grant funds 80% of construction of the path, up to \$1,213,256.66. The City is paying for design.

Subject: City-wide Bike and Pedestrian Plan Community Advisory Group Meeting

Background

The City of Watertown was awarded a Transportation Alternatives Program (TAP) Grant from WisDOT to develop a city-wide bicycle and pedestrian path network. Jody Rader from HKGi, Inc. is leading this planning project, and will present project goals, background information, and community engagement results so far to the Task Force. The Task Force members are encouraged to provide information about bicycle and pedestrian activities, connecting paths, destinations, and other feedback during this time.

The study is currently planned to be completed in February 2026.

Budget Goal

- 1. Proactively maintains and improves our parks and infrastructure to ensure safety, quality, and equity
- 2. Fosters community growth by assessing opportunities, stakeholder input, environmental needs, and modern code and policy priorities
- 3. Maintains a safe and healthy community, with an eye toward future needs and trends

Financial Impact

The WisDOT TAP Grant funds 80% of this planning study, up to \$80,000.00. The City will pay for the remaining 20% of the project.
