LICENSING BOARD

Wednesday, August 10, 2022

The Licensing Board met on the above date at 4:15 p.m. in person at the Municipal Building 106 Jones St in Room 0041 and via GoToMeeting. The following members were present: Mayor McFarland, Ald. Bartz, Ald. Smith and Erin Schroder. Absent: Cheri Martin Staff present were: Chief Kaminksi

- 1. Call to order. Mayor McFarland called the meeting to order at 4:17 p.m.
- 2. **Review and approve minutes.** Ald. Bartz moved to approve the minutes of July 13 as presented, seconded by Ald. Smith and carried by unanimous voice vote.

3. Business

- A. Review and take action: application for "Class A" Retail License for the Sale of Fermented Malt Beverages and/or Intoxicating Liquor from Pine Hill Farm Wellness LLC, DBA Pine Hill Farm 200 W. Main Street. (Jacalyn Philips, Agent) Mayor McFarland presented the application for consideration and noted this is for their new location. Schroder moved to approve the application as stated, seconded by Bartz and carried by unanimous voice vote.
- B. Review and take action: application for Temporary Premises Amendment by Local Waters, 109 S. Third Street (Kara Pugh, Agent) on Sat October 8th, 2022, 11am-11pm.
 Ms. Pugh was present to explain her desire to have an event outside of Local Waters; she is first trying this behind her building in hopes it goes well and can be held in front of the bar in the future. This event will be for an Octoberfest type event. Ms. Pugh talked through the map and spoke about the fencing and entry/exit points. Chief Kaminski stated there were concerns about Drafty Cellar having a tent space there. Ms. Pugh shared she is employing Drafty Cellar employees for that evening, she is doing the ordering, and they are selling the product she ordered. Discussion ensued about entry and exit points; Chief Kaminski shared that if she does an entry/exit in the fencing/parking lot that would be acceptable as long as there is an employee monitoring that point of entry/exit. Discussion also ensued about a special event permit; Mayor McFarland shared she instructed Ms. Pugh to apply for one because it is a city parking lot; if that is incorrect, we will take back the special event permit. There was then discussion about outdoor music; Chief Kaminski shared that the limitation for sound is four hours in a 24 period and no more than four events in a month. Ald. Bartz moved to approve the application as stated, seconded by Schroeder and carried by unanimous voice vote.
