A. Review and take possible action: restrict parking at intersection of N. Church Street and W. Cady Street

- When a vehicle parks on the NE corner of N. Church Street and W. Cady Street, it is sometimes difficult for cars turning left from Cady St. onto Church St. to see oncoming vehicles.
- MOTION: Blanke made a motion to direct staff to 1) check to make sure that the curb is painted
 the correct distance from the fire hydrant and 2) ask the attorney what the next step would be
 to do an extended no parking sign in that location while the Main St. Bridge is under
 construction and traffic is heavier on Cady St. Motion was seconded by Schmid and passed
 unanimously.
- B. Review and take possible action: Traffic concerns in Riverside Middle School area

 - Mr. Rollins shared his concern about the traffic during dismissal time at RMS. During that period of time 1) parents wait in their cars for their children and block driveways and fire hydrants and 2) Mr. Rollins is concerned that a student could be potentially injured crossing the streets and walking down streets without sidewalks.
 - Principal Widiker explained that a change in the bus traffic flow in September has improved traffic around the campus, but is causing parents to wait for students off campus on side streets
 - Andrew Beyer explained that a crossing walk in that area would not meet guidelines and would not be safe.
 - MOTION: Board made a motion to request that staff check to make sure all approved School
 Crossing signs around RMS have been installed and to install any signs that are missing. Motion
 was seconded by Schmid and passed unanimously.

RE: Awareness of Special Events for BFTS

Committee Members,

These events were finalized last December and early January after the 10/31 list was approved and prior to the new Special Event Ordinance. These were booked based on previous Special Event directions.

The WRMC will be hosting a Breastfeeding Coalition event all day on Saturday, August 3, 2024. They submitted a special event since they will be inviting food trucks, having kids activities (bounce house) and closing the road for safety reasons. No alcohol will be sold.

The Parks, Recreation, & Forestry department finalized contracts with The Last Bees Concert on September 7, 2024, part of the Summer Concert Series, from 7-9pm.

The Back Bay Band on September 14, 2024, part of the Summer Concert Series, from 7-9pm. These two concerts will run just as the previous ones approved last fall. We did not have all contracts signed at the 10/31 deadline. The Summer Concert Series includes road closure during event and setup, food trucks, fermented malt beverage sales and amplified sound. We have auxiliary scheduled for all Summer Concert Series events.

ORDINANCE TO

CREATE SECTIONS 428-8(A) DEFINITIONS, 428-8(G) SUBSECTION 3 OPEN CONTAINER, & 428-8(G) SUBSECTION 7 WRISTBANDS OF THE CITY OF WATERTOWN GENERAL ORDINANCES

SPONSOR: ALDERPERSON DAN BARTZ FROM: BENTZIN FAMILY TOWN SQUARE COMMISSION

THE COMMON COUNCIL OF THE CITY OF WATERTOWN DOES ORDAIN AS FOLLOWS:

SECTION 1. <u>428-8(A) OPEN CONTAINER DEFINITION</u> -A paper or plastic cup which does not exceed 16 fluid ounces in size, bearing the "outdoor open container entertainment event's" printed name and/or logo or the beverage distributors logo, located within the "outdoor open container entertainment event" boundaries.

SECTION 2. 428-8(G) SUBSECTION 3 OPEN CONTAINER. No container in which a fermented malt beverage is dispensed and removed from the event licensed premises shall exceed 16 fluid ounces in size. No container in which wine is dispensed and removed from an event licensed premises shall contain more than 6.5 fluid ounces of wine. The container shall bear the outdoor open container entertainment event's printed name and/or logo.

(a) Nonalcoholic beverage containers shall bear the outdoor open container entertainment event's printed name and/or logo. The nonalcoholic beverage container shall be a different hue (color) than the open container for fermented malt beverages and/or wine.

SECTION 3. 428-8(G) SUBSECTION 7 WRISTBANDS. Possession or consumption of alcoholic beverages by an underage person within an outdoor open container entertainment event is prohibited at all times except as otherwise permitted by law. All individuals wishing to possess or consume a fermented malt beverage and/or wine within an outdoor open container event must have a wristband with the outdoor open container entertainment event's printed name and/or logo issued by an authorized event licensee which sold the fermented malt beverage and/or wine to the individual.

SECTION 4. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 5. This ordinance shall take effect and be in force the day after its passage and publication.

RE: Amend Section 428-8(g) Subsections 3 & 7 Open Container

Committee Members,

The Parks, Recreation, & Forestry Department has put together recommended changes to the ordinance 428-8(g) Subsections 3 & 7 Open Container. This will update the existing requirement for logoed 16 oz containers and logoed wristbands, when serving alcoholic beverages, to allow for generic options to these items. These logoed items are very costly and would help reduce expenses.

We are looking for a recommendation to move forward to common council. It has been reviewed and approved by Police Chief Brower.
