DRAFT ORDINANCE TO TO REGULATE BOATING UPON THE ROCK RIVER AND PRESCRIBING PENALITIES FOR VIOLATION THEREOF OF THE CITY OF WATERTOWN GENERAL ORDINANCES

SPONSOR: ALDERPERSON DANA DAVIS FROM: PUBLIC SAFETY AND WELFARE COMMITTEE

WHEREAS, the State of Wisconsin is removing and replacing the Main Street (Cole) Bridge in Watertown, WI in 2024; and,

WHEREAS, an ordinance placing navigational waterway markers/aids in the Rock River is required by the Wisconsin Department of Natural Resources (WDNR); and,

THE COMMON COUNCIL OF THE CITY OF WATERTOWN DOES ORDAIN AS FOLLOWS:

SECTION 1. Intent: The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interests and the capability of the water resources.

SECTION 2. Creation of Section 247-5(D): Section 247-5 (D) is hereby created to read as follows:

247-5 (**D**) **Prohibited Acts Boating Prohibition Area**: No person shall operate a boat - motorboat and/or nonmotorized boat - as defined in s. 30.50(6), Wis. Stats., and/or s. 30.50(7), Wis. Stats., on the Rock River between the upstream and downstream navigational waterway markers of the Main Street (Cole) bridge. Said navigational waterway markers located at GPS coordinates 43.195657, -88.724676 upstream and GPS coordinates 43.193239, -88725351 downstream of the Main Street (Cole) bridge.

SECTION 3. Effective Date: This ordinance shall take effect and be in force the day after its passage and publication.

Review and take possible action: Approve Ordinance to Regulate Boating Upon the Rock River

<u>Background:</u> At the Main Street (Cole) Bridge preconstruction meeting held on April 24th, it was pointed out by the WDNR that boating needed to be excluded both upstream and downstream of the bridge during demolition and construction. WDNR stated that it would fall on the City to prepare and submit a Waterway Marker application and permit. It turns out that the category of permit the City needs requires an ordinance to be passed prior to the placement of the navigational aids. Being this was the first time City staff was aware of this requirement, we have been working with the WDNR to get temporary buoys in until such time as we could prepare and bring forward to Public, Safety & Welfare Committee and Common Council an ordinance to exclude boating upstream and downstream of the bridge during demolition and construction. A draft ordinance and site map showing the locations of the proposed "boat excluded" navigational aids will be placed. Demolition of the bridge deck began on May 14th, so time is of essence to get the aids placed.

If the Committee approves moving forward the draft ordinance to Common Council, the ordinance is on tonight's Common Council agenda. If the Committee does not approve moving forward the ordinance, the agenda item will need to be tabled at Council.
