# Madison Street Doty Street to Lincoln Street City of Waupun, Dodge County

The City of Waupun will host a public information meeting to present the preliminary engineering plan for improvements to Madison Street in the City of Waupun, Dodge County. The project begins at Doty Street and extends north to Lincoln Street. Additional utility work and sidewalk construction may be completed from the Waupun Utilities facility located south of Libby Street to Doty Street.

The proposed project consists of reconstructing the existing roadway with an urban roadway section including curb and gutter, bike lanes, sidewalk, storm sewer, sanitary sewer and water main. Driveways, service walks, and lawn areas will be removed and replaced as necessary to accommodate construction.

The project is currently scheduled for 2021 construction.
