A RESOLUTION AUTHORIZING THE REMOVAL OF THE RESTRICTION ON RESERVED COMMUNITY CENTER FUNDS FOR THE PURPOSE OF LAND ACQUISITION AND FUTURE CAPITAL PROJECTS

WHEREAS, the Common Council of the City of Waupun, Dodge and Fond du Lac Counties, Wisconsin, by this Resolution adopted by a majority vote of the Common Council on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

WHEREAS, the City of Waupun previously designated funds for the construction costs of the new Community Center; and

WHEREAS, the Common Council recognizes that the acquisition of land and funding capital projects is a necessary step towards future development projects that will benefit the community; and

WHEREAS, the Common Council has determined that it is in the best interest of the City to remove the restriction on the aforementioned funds to allow for their use for future capital project needs;

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Waupun, Wisconsin, that the restriction on the funds previously set aside for the Community Center construction is hereby removed, and said funds are authorized to be used for the acquisition of land and to fund future capital projects as determined by the City:

BE IF FURTHER RESOLVED, that the City Administrator and Finance Director are hereby authorized and directed to take all actions necessary to reclassify the funds and carry out this resolution in accordance with municipal financial policies.

ISSUE SUMMARY:

As part of a strategy to improve access to public information, we are seeking to update our camera system in the council chambers. Staff secured two estimates to complete this work and is recommending the solution from 323TV, which is the most cost effective of the solutions analyzed. The upgrade is needed to improve livestreaming and on-demand access with online platforms such as YouTube to record, broadcast and archive meetings. The proposed camera system includes a control panel, making it easier to start and control meetings. Additionally, the system provides multi-camera views, using automation to switch between speakers, presenters and public commentors to capture individuals speaking, which will reduce confusion for online viewers, increase transparency and make it easier for residents to engage with public meetings. The existing system will be repurposed and used to increase virtual connections for other city facilities.

Good afternoon Angie,

I am in receipt of the claim that has been filed by Lynette Terbeest against the City of Waupun for injuries sustained as a result of a trip and fall on a public sidewalk. As you are aware, the City is self-insured for this loss, and should the City decide to settle this matter, the settlement would come from City funds.

Based on the information that I have received, it is my understanding that the City does take corrective action to address defects on city sidewalks when they are made aware of known problems. I have also been advised that the City had no prior notice of any dangerous condition on this particular area of sidewalk. Based on this, it is my opinion that the city is meeting the standard of reasonable care, which is the standard that municipalities are held to.

In addition, it is my opinion that the City would be immune from liability under Wis. Stat. 893.80 (4), which provides immunity for discretionary actions by municipalities. It is my opinion that when and how often a municipality inspects and maintains their sidewalks is a discretionary decision, for which the City would have immunity based on the above statute.

Under Wisconsin law, a municipality does not face liability unless there is a "known danger" that is compelling enough to warrant specific, non-discretionary action by the municipality. Lodl v. Progressive Northern Insurance Co., 2002 WI 71, 253 Wis. 2d 323, 646 N.W.2d 314. Wisconsin courts have developed a three-step test to determine whether the known and compelling danger exception applies in a given case: (1) whether something happened to create a compelling danger; (2) whether a government actor "[found] out about the danger, making it a known and compelling danger"; and (3) whether the government actor addressed the danger by taking one or more precautionary measures or instead "[did] nothing and let the danger continue." Heuser v. Community Ins. Corp., 2009 WI App 151, ¶¶27-28, 321 Wis.2d 729, 774 N.W.2d 653.

In this case, it is my opinion that there is no evidence to show any liability on the part of the City.

Based on all of the above, it is my opinion this claim should be denied.
