ORDINANCE NUMBER 21-

AN ORDINANCE TO AMEND CHAPTER SIXTEEN OF THE MUNICIPAL CODE OF THE CITY OF WAUPUN ENTITLED "ZONING CODE."

THE COMMON COUNCIL OF THE CITY OF WAUPUN, DO ORDAIN:

SECTION 1: Section 16.02 of the Waupun Municipal Code entitled "Definitions" is amended to add the following subsection:

(5a) ADULT DAY CARE FACILITY - An adult day care facility means a facility that provides services for part of a day in a group setting to adults who need an enriched social or health-supportive experience, or who may need assistance with activities of daily living (ADL), supervision and/or protection. Services may include personal care and supervision, provision of meals, medical care, transportation, and activities designed to meet physical, social, and leisure time needs.

SECTION 2: Section 16.03 of the Waupun Municipal Code entitled "Residential District Requirements" is amended to add the following subsection:

SECTION 16.03(1)(d) CONDITIONAL USES. Is amended to add:

- (iv) Adult Day Care Facility
- (v) Group Child Care Center

SECTION 16.03(2)(d) CONDITIONAL USES. Is amended to add:

- (iv) Adult Day Care Facility
- (v) Group Child Care Center

SECTION 16.03(3)(d) CONDITIONAL USES. Is amended to add:

- (v) Adult Day Care Facility
- (vi) Group Child Care Center

SECTION 16.03(4)(d) CONDITIONAL USES. Is amended to add:

- (ix) Adult Day Care Facility
- (x) Group Child Care Center

SECTION 16.03(5)(d) CONDITIONAL USES. Is amended to add: (viii) Adult Day Care Facility (ix) Group Child Care Center

SECTION 2: This Ordinance shall be in full force and effect upon its passage and publication as provided by law.

ORDINANCE # 21 - ____

AN ORDINANCE TO AMEND CHAPTER SIXTEEN OF THE MUNICIPAL CODE OF THE CITY OF WAUPUN ENTITLED "ZONING CODE."

THE COMMON COUNCIL OF THE CITY OF WAUPUN ORDAINS:

<u>SECTION 1:</u> Section 16.01 (10) of the Municipal Code of the City of Waupun entitled "Zoning Map" is amended so that real estate currently owned by Fox Valley Savings Bank at 409 E Jefferson Street presently zoned in the R-5 Mixed Residential Zoning District is rezoned to the B-2 Central Business Zoning District The real estate to be rezoned is described as follows:

ISSUE SUMMARY

Staff will provide an overview of the stormwater quality plan, based on a 2017 stormwater quality study and talk through implications from the presentation given August 17 where we highlighted the appeal process we're undertaking with WIDNR. Some fundamental points to know about our stormwater plan:

- The City of Waupun is located entirely within the Rock River Watershed and drains to 3 distinct reaches/tributaries to the Rock River.
- Under Wisconsin Administrative Code NR216, the City is required to have an separate storm sewer system (MS4) which is permitted by WIDNR as authorized by USEPA. The MS4 permit requires the City to perform the following activities: (1) Public Education & Outreach, (2) Public Involvement & Participation, (3) Illicit Discharge Detection & Elimination, (4) Construction Site Pollution Control, (5) Post Construction Management, (6) Pollution Prevention, and (7) Stormwater Quality.
- The City must comply with the Total Maximum Daily Load (TMDL) standards set for the Rock River Basin as defined in the City's MS4 permit in accordance with Admin. Code NR 216.07(6)(b) and NR 151.13. NR 151 requires a 20% reduction in total suspended solids (TSS). In addition, TMDLs establish the maximum amount of total suspended solids (TSS) and total phosphorus (TP) that the City's storm system may release into the Rock River. In addition to the TSS reductions, the City's current Permit (expiring 2024) requires additional reductions of TSS and TP in each of the City's three (3) reaches.
- In 2008, the City established a stormwater utility to fund the structural and operational best management practices (BMPs) required to comply with the City's MS4 permit and TMDL limits. BMPs include a practice, or combination of practices, determined to be an effective and practicable means of preventing or reducing the amount of pollution generated by nonpoint sources to a level compatible with water quality goals.
- In 2017, the City developed a stormwater quality plan that identified an inability to meet defined TMDL standards without additional BMPs. In that study, 21 sites across the community were identified to constructed new BMPs. Only 15 of the locations are recommended for construction (due to performance, cost-effectiveness, or other reasons). Additional BMPs will need to be identified. Total estimated construction of all recommended BMPs was approximately \$8.4M in 2017. Implementation experience suggests that costs will exceed this estimate.
- City staff have submitted an appeal to WIDNR to extend the length of time to achieve the current permit standards. The official determination on that request is pending WIDNR review, with final plan due October 31, 2021. Staff also submitted a planning grant request to study alternative BMPs and identify functional sites in the community for additional ponds. That grant request was not approved.
- At present, the city is conducting a rate analysis to evaluate revenues for the utility. Additional capital will be required to support stormwater construction requirements to move the City toward permit compliance on a timeline yet to be determined.

Staff will highlight recommendations to move the city toward compliance with our MS4 permit.




Figure 8: Proposed Structural BMPs

ISSUE SUMMARY

The Fiscal Trends Monitoring System (FTMS) is a tool developed by the International City/County Management Association (ICMA) as a method for monitoring the financial condition of local governments. This system identifies factors that affect financial condition to aid decision-making. Financial condition is the ability of a locality to maintain existing service levels, withstand local and regional economic disruptions, and meet the demands of natural growth, decline, and change. FTMS analysis adjusts for inflation to convert current dollars into constant dollars based on CPI, recognizing that money available to you today is worth more than the same amount of money at a future date. For the purpose of this presentation, we examined a handful of indicators to assess trends, examining 2016 budget data compared to 2020 to understand budget constraints. Trends we will review include:

- 1. Revenue
- 2. Expense
- 3. Capital expenditures
- 4. Debt capacity





Revenues (2016 – 2020 when adjusted for inflation)













Equalized Value (2016-2020 adjusted for inflation)





Expenses (2016-2020 adjusted for inflation)










Executive Summary – Concluding Remarks

- Declining revenues continue to challenge city operations, driven largely by declining state shared revenues. This has and continues to shift more of the burden to the local taxpayer. Consideration should be given to the need to diversify revenue sources
- Continued erosion of revenue streams over time may result in cuts to city services and/or challenge the City's ability to generate capital needed for improvements.
- When adjusted for inflation, expenditures have declined while service levels remain constant, showing staff remain strong fiscal stewards of tax dollars. Operationally, work to pursue projects that eliminate waste and create efficiency are key to maintaining service levels.
- As we approach our levy limit, growth (measured by net new construction) is essential to increase our levy. This places particular importance on the role of economic development and investments will need to be made to support this growth.
- The City maintains a strong cash position as measured by unassigned fund balance. Maintaining fund balance is essential to help manage cash flow to support operations.
- Analysis of equalized value from all surrounding communities shows that the City continues to maintain an extremely affordable cost of living for residents, despite increases in the tax levy in recent years.
- Debt is an essential piece of the equation to achieve a balanced budget and meet demand to replace aging infrastructure. Managing borrowing in the context of strategic priorities will be imperative to maintain our strong bond rating position and manage overall debt capacity.
- The indicators as outlined are intended to help guide you to monitor status of fiscal condition. Continued investment in strategic priorities remains essential to move the community forward.

ISSUE SUMMARY:

City of Waupun Ordinance 9.03 governs tree or plant diseases in the city. Staff have been receiving a number of complaints from citizens about trees damaged or diseased on private property. You may be receiving similar complaints. We would like to review current ordinance and discuss implications so that we are operating from a uniform interpretation of the rules.

9.03 - TREE OR PLANT DISEASES. (Rep. & recr. #08-03)

- (1) DECLARATION OF PUBLIC NUISANCE. The existence of trees, shrubs and other flora within the City are determined to be valuable public and private assets which substantially enhance the public welfare and are aesthetically significant and economically important in terms of increased value which accrue to public and private lands as a result of their existence. The continued existence of injured or diseased trees or other plantings, or the failure to properly treat the same if treatment is available, which is likely to cause the spread of disease or endanger persons because of the deteriorated condition, is hereby declared to be a public nuisance requiring abatement.
- (2) EXAMPLES. The following conditions are exemplary, but not an inclusive list, of matters declared to be public nuisances under this section:
 - (a) Any dead or defective tree.
 - (b) Any elm tree infected with the Dutch elm disease fungus or which harbors any carrier of the same.
 - (c) Any oak tree infected with the oak wilt fungus or which harbors any carrier of the same.
 - (d) Any tree, bush, shrub or other plant which is infected with an insect or disease capable of infecting other plants.
- (3) ABATEMENT PROCEDURE.
 - (a) <u>Notice</u>. If the City Forester determines that a dead or diseased tree or plant exists on any private property in violation of this section, a notice may be issued, in writing, by the Forester to the property owner directing, as appropriate, that such tree or plant be removed or treated as therein specified to protect surrounding trees or plants. A notice issued under this section shall provide a reasonable period of time, which shall not be less than 72 hours, within which to perform. The notice shall also state that the existence of the facts which gave rise to the notice constitute a public nuisance which may be abated by the City upon failure of the property owner to comply with the terms of the notice.
 - (b) <u>Court Proceedings</u>. If the corrective action set forth in the notice is not taken by the property owner within the time set forth in the notice, and likelihood that other trees or other plants will be infected, damaged or destroyed, or that persons will be injured, the City Forester shall request the commencement of a nuisance abatement action under Ch. 823, Wis. Stats..
 - (c) <u>Summary Abatement</u>. If, in the judgment of the City Forester, delay is likely to cause injury to persons or the spread of disease to other trees or plants, then the City Forester may enter upon the property and take all necessary action including, but not limited to, trenching to separate root systems, inoculation or other treatment, or removal of the nuisance.
 - (d) <u>Appeal</u>. Appeal from the determination of the Public Works Director or the Recreation Coordinator as contained in any order under this section shall be to the Board of Public Works in accordance with the procedures set forth in Ch. 68, Wis. Stats. A written request for an appeal shall be made in writing within 10 days of the date of delivery of the notice. An appeal shall not delay the right of the Public Works Director or the Recreation Coordinator to summarily abate the nuisance as set forth in subsection (3)(c) of this section, but a ruling of such appeal in favor of the property owner shall relieve the owner of any obligation to pay the costs of such summary abatement.
 - (e) <u>Costs</u>. Costs of judicial abatement of any nuisance under this section shall be taxed and collected pursuant to Ch. 823, Wis. Stats. Costs of summary abatement shall be invoiced to the property owner and collected as a debt or, if permitted by law, may be assessed against the real estate and collected as a special tax against the property.

- 1. The north exterior wall in the NW corner of the main building is pulling away from the foundation and would need to be fully reconstructed to renovate the existing structure at a cost TBD.
- 2. A large percentage of the furnaces in the building are not working. During the winter of 2020/2021 we experienced a burst pipe due to failing HVAC systems. The winter of 2021/2022 is likely to see similar challenges with maintaining the building.
- 3. It is costing the City money to hold the building (i.e., utility and maintenance/repair).
- 4. The types of projects that fit with the building would likely be based on tax-credit funding mechanisms, which would take time to secure and would yield only minor incremental value to the TID.
- 5. The City has secured a developer for the green space and removing the building clears the way to secure additional development to optimize the space and return it to the tax roll.

The property has been included in TID 6. The TID will absorb the cost of the demolition.

BACKFILLING

The Contractor shall level the site. Leave subgrade 6" below ground level for black dirt. The City of Waupun will finish grade the site.

EROSION CONTROL

The Contractor shall be responsible for obtaining an Erosion Control Permit and complying with the land-disturbing Erosion and Sediment Control Ordinance as set for in Chapter 23 of the Municipal Code for the City of Waupun.

DEMOLITION TECHNIQUES.

The Work shall be performed in accordance with accepted demolition techniques of the National Association of Demolition Contractors, incorporated herein by reference. During the demolition, the Contractor shall sort metals for recycling. The consolidation process will reduce the building to a size that can effectively fit in demolition trailers. Water shall be used as a dust suppressant whenever practicable.

SAFETY AND SECURITY

The Contractor shall give all notices required by law and comply with all laws, ordinances, rules and regulations pertaining to the project. The Contractor shall also be liable for all violations of the law in connection with work furnished by the Contractor. If the Contractor observes that the drawings or specifications are at variance with any law or ordinance, rule or regulation, he/she shall promptly notify the City of Waupun Director of Public Works in writing and any necessary changes shall be made by written instruction or change order. Safety & Security - The Contractor shall execute and maintain its work so as to avoid injury or damage to any person or property. The Contractor shall comply with the requirements of the specifications relating to safety measures applicable in particular operations or kinds of work.

- I. <u>Cancellation/Non-Renewal</u> No policy of insurance required to be maintained hereunder shall be cancelled, non-renewed, or voided without 30 days prior written notice to City of Waupun, except where cancelation is due to the non-payment of premiums, in which event, 10-days prior written notice shall be provided.

POLLUTION EXPOSURES LIABILITY INSURANCE REQUIREMENTS

The Contractor shall not commence work on contract until proof of insurance required has been provided to the applicable department before the contract or purchase order is considered for approval by the City of Waupun.

It is hereby agreed and understood that the insurance required by the City of Waupun is <u>primary coverage</u> and that any insurance or self insurance maintained by the City of Waupun, its officers, council members, agents, employees or authorized volunteers will not contribute to a loss. All insurance shall be in full force prior to commencing work and shall remain in force until the entire job is completed and the length of time that is specified, if any, in the contract or listed below, whichever is longer.

1. <u>CONTRACTORS POLLUTION LIABILITY</u>

- A. Definition of "Covered Operations" in the policy must include the type of work being done for the City of Waupun.
- B. Limits of Liability:
 \$2,000,000 Each loss for Bodily Injury, Property Damage, Environmental Damage
 \$2,000,000 Aggregate for Bodily Injury, Property Damage, Environmental Damage(Environmental Damage includes Pollution and Clean-up costs)
- C. Deductible must be paid by Contractor
- D. If Subcontractors are used in the work, then this policy must also cover the Subcontractors

2. MOTOR VEHICLE / AUTOMOBILE POLLUTION LIABILITY – required "if" the exposure exists

- A. Definition of "Covered Operations" in the policy must include the type of work being done for the City of Waupun
- B. Limits of Liability: \$1,000,000 Each loss for Bodily Injury, Property Damage, Environmental Damage
 - \$1,000,000 Aggregate for Bodily Injury, Property Damage, Environmental Damage (Environmental Damage includes Pollution and Clean-up costs)
- C. Deductible must be paid by Contractor
- D. If Subcontractors are used in the work, then this policy must also cover the Subcontractors
- E. Must cover Motor Vehicle loading and unloading (Please show on Certificate of Insurance)

3. ADDITIONAL PROVISIONS

- A. <u>Acceptability of Insurers</u> Insurance is to be placed with insurers who have an *A.M. Best* rating of no less than A- and a Financial Size Category of no less than Class VI.
- B. <u>Additional Insured Requirements</u> The following must be named as additional insureds on the Contractor's Pollution and (if exposure exists) Automobile Pollution Liability coverage for liability arising out of project work City of Waupun, and its officers, council members, agents, employees and authorized volunteers.
- C. Certificates of Insurance acceptable to the City of Waupun shall be submitted prior to commencement of the work to the applicable department.

INDEMNIFICATION

hereby agrees to indemnify, defend and hold harmless the City of Waupun, its elected and appointed officials, officers, employees, agents, representatives and volunteers, and each of them, from and against any and all suits, actions, legal or administrative proceedings, claims, demands, damages, liabilities, interest, defense costs, attorneys' fees, costs, and expenses of whatsoever kind or nature in any manner directly or indirectly caused, occasioned, or contributed to in whole or in part or claimed or alleged to be caused, occasioned, or contributed to in whole or in part, by reason of any act, omission, fault, or negligence, whether active or passive, of [Third Party Name Indemnitor Here] or its agents or anyone acting under its direction or control or on its behalf arising out of, in connection with, or relating to this Agreement. This indemnification, defense and hold harmless obligation shall exist for ________ even if liability is also sought to be imposed or is alleged against City of Waupun its elected and appointed officials, officers, employees, agents, representatives and volunteers for their own acts, omissions, fault or negligence arising out of or in connection with or relating to this Agreement.

______shall reimburse the City of Waupun, its elected and appointed officials, officers, employees, agent or authorized representatives or volunteers for any and all legal expenses and costs incurred by each of them in connection therewith or in enforcing the indemnity herein provided.

In the event that ______ employs other persons, firms, corporations or entities (sub-contractors) as part of the work that is the subject of this Agreement, it shall be ______ responsibility to require and confirm that each sub-contractor enters into an Indemnity Agreement in favor of the City of Waupun, its elected and appointed officials, officers, employees, agents, representatives and volunteers, which contains identical indemnity, defense and hold harmless provisions and obligations as this Indemnity Agreement.

This indemnity provision shall survive the termination or expiration of this Agreement.
