<b>REGARDING</b> :	Public Safety Building Space Needs Analysis Update

Cedar Corporation is nearing the completion of the Space Needs Analysis for the Public Safety Facility. As we are approaching the conclusion to our analysis, we wanted to provide the City with an update on the process, the status of study, and the anticipated next steps. The Public Safety Analysis began as a result of the Strategic Facilities Study and Citizen Participation Survey completed in 2019. As part of this process, we analyzed the existing Public Safety Building, evaluated the space needs of the Police and Fire Departments, and are now in the process of developing options to provide both departments a functional facility that will serve the community for the next 50 years.

Through our review of the existing facility and departments needs, it become apparent the existing facilities are functionally obsolete, undersized, and have extensive maintenance, improvement, and expansion needs over the next several years. As we reviewed the existing facilities, we have developed an understanding of the limitations, challenges, benefits, and opportunities that exist with the current facilities.

Some of the benefits and opportunities include:

- The current facility is located in a good location for responses.
- Structure is in good condition and is a candidate for renovation and expansion.
- The Fire and Police Departments benefit from being together with shared resources.

Some of the challenges and limitations include:

- The existing facility is severely undersized, and the currently owned site is limited in size.
- The facility has become functionally obsolete for both departments.
- Site access, response, and vehicle movements have limited site lines.
- Many components of the facility, including the roof and HVAC, require extensive maintenance and replacement.

As we continue our final space needs assessment, we are finalizing conceptual layouts that identify options for renovation and expansion of the existing facility. Through our process, we have also evaluated options that include a new facility and separate facilities. We have now centered our vision on a renovation and expansion option that will meet the needs of the departments and community. As previously indicated, the site size is limited, and we are currently evaluating options for a two-story facility and an expanded and shared parking opportunities.

The next step is anticipated to occur at the May Council meeting and is anticipated to include a presentation to the City Council with the intent to select an option for implementation. As we progress through the process, we will continue to evaluate opportunities for funding and continue to develop refined implementation for the project. The implementation plan will include a vision for the future of the Public Safety Facility, define the goals, and outline a timeline and funding.
