

At the June 11, 2019 Board of Public Works Meeting, members of the Marshview Riders (Carrey Terlisner, Mike Schwandt, Bridget Mayes) returned to request for the allowance of ATV/UTV access on City streets. Daane spoke with LAPWA regarding ordinances and Rasch spoke with the DNR. Safety is the main concern when mixing ATV/UTV with general traffic. Other concerns are signage costs and the confusion the signs may cause. Terlisner comments that the club would consider assisting in payment of signage and would welcome sitting down and mapping out routes. Board Member Hull comments this could be accepted on a temporary basis, to be revisited and considered for a permanent ordinance change, in order to measure its usage and economic impact.

A motion was made to move forward to establish an ordinance to include all city streets, with no more than 35 mph. The motion failed due to no second. Matoushek then made a motion for the following route: City limits from County Road M (S. Madison St) to Libby Street; Libby Street turns into Mayfair Street then to Shaler Drive; Shaler Drive to Gateway Drive to Kelly Avenue. Route would also include 1700 block of Shaler Drive. This motion failed due to a tie vote.



ISSUE SUMMARY:

On August 12, 2019, Waupun Utilities Commission recommended a resolution authorizing a lower water property tax equivalent (also known as payment in lieu of tax or PILOT) for the years 2019 to 2026 at level of 14% of total annual water revenues. Common Council previously authorized a lower water property tax equivalent on October 28, 2014 for the years 2015 to 2017 at a level of 13.5% of total annual water revenues.

Authorizing a lower water property tax equivalent will provide financial relief to the water utility ensuring water rates continue to be adequate to meet operation and maintenance needs and continue to replace aging water infrastructure. Water infrastructure replacement projects are very costly. The cost to replace water mains, hydrants, and services on Madison street was over \$1.2 million and we have several more projects to complete in the next five years including Rock and Newton.

Under the state statute calculation for property tax equivalent, as the water utility invests in replacing aging infrastructure the following year the water utility realizes a large increase in the property tax equivalent payment. The general rule is for every \$1,000,000 in investment in capital the water utility makes, the tax equivalent payment will increase \$18,000. Since 2007, the property tax equivalent payment calculation has increased \$197,842 or 114%. Unfortunately, this expense increase is unsustainable when the water utility has had flat revenues over the last 10 years.

It is also important to note that this is not new territory or an isolated concern for Waupun's water utility. According to an investigation completed by the Wisconsin Public Service Commission in 2013, approximately 23% of municipalities have already lowered the water property tax equivalent payment due to the cost burden.




Resolution Authorizing Lower Water Property Tax Equivalent PILOT Graphs

WHEREAS, the City of Waupun recognizes the importance of investing in replacing aging water infrastructure while maintaining affordable water utility rates for residential, commercial, and industrial customers;

WHEREAS, under Wisconsin statutes municipally owned water and electric utilities in Wisconsin are subject to a payment in lieu of local general property taxes, or property tax equivalent; and

WHEREAS, the water property tax equivalent has increased \$197,842 or 114% from \$174,132 to \$371,974 annually since the new water treatment plant was built in 2007; and

WHEREAS, for every \$1,000,000 invested in replacing aging infrastructure the water utility property tax equivalent increases by approximately \$18,000; and

WHEREAS, water sales consumption have declined since 2007 from water conservation and from higher than average existing water rates; and

WHEREAS, the water property tax equivalent payment represents a substantial portion of the revenue requirement at 14.4% of total water revenues in 2018 and is projected to increase to 16.2% of total water revenues in 2022 making it difficult to continue to replace aging infrastructure without a rate increase; and

WHEREAS, the City of Waupun previously provided financial relief by authorizing a lower water utility property tax equivalent for the years 2015 through 2017 in the amount of 13.5% of total annual water revenues.

NOW, THEREFORE, BE IT RESOLVED, that the City of Waupun authorizes a lower water utility property tax equivalent in the amount equal to 14% of total annual water revenues effective the calendar year 2019 through 2026.

How Does a Complete Count Committee Work?

The Census Bureau cannot do this alone. We require the assistance of partners—individuals, groups, and organizations across the nation that can help us build awareness about the census, educate about its importance, and encourage their community to participate. One very effective way to accomplish this is through **Complete Count Committees.**

What Is a Complete Count Committee?

A Complete Count Committee (CCC) is a volunteer committee established by tribal, state, and local governments, and/or community leaders, to increase awareness about the census and motivate residents in the community to respond. The committees work best when they include a cross section of representatives from government agencies, education, business, faith-based and community-based organizations, and the media. Establishing a Complete Count Committee is not an exact science or technical endeavor.

The Purpose and Goals of a Complete Count Committee

The CCC is charged with developing and implementing a 2020 Census outreach, promotion, recruitment, and enumeration assistance plan of action designed to target and address the needs of their communities.

The overall purpose of the Complete Count Committee is three-fold:

- It provides high-level oversight for participation in the 2020 Census
- It provides a group of "trusted voices" to act as Census ambassadors
- 3. It serves as a knowledgeable contact point for the regional director in meeting the goal of a timely, accurate and cost-effective complete count.

The goals of the Complete Count Committee are to act as "champion" for the 2020 Census by:

- Motivating the community to self-respond;
- Educating the public about the importance of the Census to the local community;
- 3. **Informing** the community about the Census activities and timelines;
- 4. Involving the community in activities to build awareness;
- 5. **Increasing** the response rate.
