# **REPORT - CITY ATTORNEY**

Mr. Doody noted that Council training will be scheduled in April or May.

# **REPORT - CITY MANAGER**

Mr. Cassel explained that due to issues with traffic, the engineering department will conduct a study. Based on the results of this study Mr. Cassel is recommending that the speed limit on all roads be 30 mph. A resolution will be prepared for the next meeting with further details. The Board requested the opinion of the sheriff, who expressed that the speed limit should remain a constant 25 mph in the gated neighborhoods and a constant 30 mph on all other roads. The Board is in consensus to move forward with these changes.

Mr. Cassel suggested that applications for the upcoming vacancy for the Vice Mayor seat should start being accepted as of March 15, 2022, thru the March 30, 2022. A workshop will be held on April 4, 22 for interviews. The open seat will then be filled at the April meeting. The Board was in consensus with this timeline.

Mr. Cassel confirmed that the time frame to received applications for the Art in Public Places Board is open.
