WORKSHOP AGENDA

A. FourthFest Location Discussion

Acting City Manager Ms. Burgess introduced the FourthFest location discussion for the 2026 celebration, noting it will also be the City's 10-year anniversary.

Discussion ensued, and use of the park was proposed, with assurance it would be ready by July. Mr. Massey expressed confidence in the location, despite some ongoing work on utilities, confirming that the space for food vendors would be workable. Discussion clarified that the park was the main focus for the event, maintaining high interest and approval for the plan.

B. Park Update - Phase II and III

Mr. Wheeler discussed the Seminole Improvement District's ongoing park development plans, specifically Phase II, which focuses on infrastructure.

Clarifications regarding cost estimates were given, with two options presented, one "bare bones," and one with full utilities. The recommended plan was projected at \$1.41 million, while recognizing funding constraints. It was premature to begin without financial support.

Phase III will potentially require adjustments if funding is delayed, including possible early developments like entrances. Grant updates suggested funding by the next fiscal year, and the SID confirmed current maintenance of the park's well-prepared grounds.

C. Seminole Improvement District's Personnel Services for Special Events

Acting City Manager Ms. Burgess introduced this item an interlocal agreement with Seminole Improvement District. Ms. Burgess detailed the need for SID utility personnel services for the holiday pop-up market that's happening this weekend, but also for any future events.

She outlined the services SID personnel provides, personnel help us greatly prior to an event, day of the event and then post event.

Acting City Manager Burgess concluded by noting legal has been reviewing an interlocal agreement that will come before you all at the regular council meeting.


PUBLIC COMMENTS


