**NEW BUSINESS/CONTINUING BUSINESS**

A. Discussion: Rockin' the Farm - August 5, 2023

Staff Planner Quagliata went over the layout for the Rockin' the Farm event. A temporary liquor license was obtained for the event. Kickstand Brewery would be serving beer, wine and seltzer inside the barn. There would be food tents set up, along with a kids' area. Kickstand and Dickey's BBQ would be selling food. A VIP tent would be set up, with VIP passes to purchase from the Lakes Area Chamber of Commerce. The gates would open at 5:00 P.M. The VIP pass would provide extra snacks and a closer, shaded view of the bands. Ava James and the Rumors would

be the pre-show band and Power Play Detroit was the main band to be featured. There was a \$5 entrance fee; kids 12 years old and under would be free. The fee would be split between the Chamber of Commerce and the White Lake Historical Society.

Chairperson Carlock requested recycling bins at the event. Staff Planner Quagliata made note. It was suggested to turn on the hanging lights in the barn for ambiance. The event would be advertised through the Township's Facebook pages, and the Chamber of Commerce was promoting the event as well.

B. Discussion: Trunk -or- Treat - October 21, 2023

The event would be held from 6:00-8:00 P.M. The CERT team would help with parking organization. Preparations were being made to handle the expected turnout. The event would need more candy and refreshments than last year. The event committee would meet closer to the event. Food trucks were suggested to have at the event since it was during dinner time.
