NEW BUSINESS

A. Review and consideration draft Oakland County Tax Sharing Agreement

Director O'Neil updated the Board regarding the status of the draft Oakland County Tax Sharing Agreement. The 35% capture remained in place. Some of the strike through language included construction costs and deadlines. The County wanted the right to keep whatever money that remained by the end of the year, and the Township wanted to make sure if funds were being used towards a project, that they could continue to be funded until the project's competition. Reporting periods were also changed to meeting with the County's Ad-Hoc Committee at the County's request, not on a periodic basis.

WHITE LAKE TOWNSHIP CORRIDOR IMPROVEMENT AUTHORITY APRIL 4, 2024

Member Walklet wanted clarification on County revenue capture. Director O'Neil said if the 3.7 million captured from Oakland County were collected before the 20-year period was over, there was opportunity to extend the plan.

MOTION by Member Christoper, seconded by Member Lennis, to recommend the Township Board approve of the draft Oakland County Tax Sharing Agreement, subject to any changes between the County and the Township Board, and to authorize the Chair to sign where needed. The motion carried with a voice vote: (4 yes votes).

OTHER BUSINESS

There were minor edits to the draft Tax Sharing Agreement that required minor changes to the TIF Plan. The County had the new edits and were reviewing them. The overall projected capture was changed slightly.

The May meeting would be canceled. There would be a special Board meeting to approve the draft Tax Sharing Agreement on May 2.
