APPROVAL OF AGENDA

NEW BUSINESS

A. Groya Consulting – Parks & Recreation Master Plan - Update

Leah Groya summarized the changes made to the draft Plan since the Committee reviewed the previous draft. She discussed the proposed Long Term Nonmotorized System Plan and the ideas behind the plan in terms of desired locations. Developer donations could be used for pathways. A Long Term Nonmotorized System Priorities Map was also included in the Plan. There was also discussion about Capital Improvement priorities.

The Committee liked the plan and directed staff to move forward with publishing the draft Plan for public review. The public hearing would be held at the January 11, 2023 Parks and Recreation Committee meeting. The Committee would make a recommendation to the Township Board to adopt the plan at that time.

He added the Township was going to pursue a construction grant from the Wilson Foundation for the Triangle Trail. The tree lighting would be at Fisk Farm on December 2, 2022 at 6:00 p.m. There would be various activities accompanying the tree lighting. The Holiday Extravaganza parade was Saturday December 3, 2022 in Pontiac.

b. Member Comments

Trustee Voorheis noted some of the floats from the Detroit Thanksgiving parade were featured in the Pontiac parade. White Lake received a donation of property near Lowe's. Christmas at Fisk Farm was December 3 and 4 and was put on by the Historical Society.
