I would like the opportunity to speak to the White Lake Township Board regarding amending the Storm Water Management Agreement for Preserve at Hidden Lake. The current Storm Water Management Agreement lists the cottage homes on unit 71,72,73,74,89,90,91,92,93&94 with 16'x10' stamped patios that encroach in the storm water easement area. My request is simply to also allow a 10' privacy fence between the same units in this area. There would be one fence between 71&72,73&74, 89&90 91&92, 93&94. A total of 5 fences (sample photos below). I believe removing a fence in this area if necessary is much easier than removing a stamped concrete patio as already approved by the White Lake Township Board. I would appreciate your consideration and look forward to discussing this matter at the upcoming White Lake Township Board meeting.
