The members present discussed the purpose of this commission and how elements from Community TV and Community Involvement can be incorporated into the mission of the EOC. We identified key words and phrases that should be included in our mission statement. We also agreed that each member will work on drafting a mission statement, and examples will be brought to the next meeting for the commission to review and vote on.

We then discussed membership and officer roles. Our intention is to vote on officers at the next meeting. We agreed that the commission should consist of five members: one representative from the Whitewater School District, one representative from the University of Whitewater, and the remaining members being citizens. A quorum will require three members present.

Duties and powers will remain unchanged. Meetings will continue to be held quarterly unless a special meeting is called by the commission chair or requested in writing by three members.
