Explanation of Issue:

City Council committee and board appointments are made to ensure effective representation and continuity of governance. The most recent comprehensive update to mayoral appointments occurred in Spring 2025, concurrent with Councilmember Mora's appointment to City Council.

At this time, the administration is recommending no wholesale changes to committee assignments. Instead, this action reflects a limited and targeted update, addressing only the vacancies created by the departure of Councilmember Jason Hartmann at the conclusion of his term. All other committee appointments remain as previously adopted by Council.

The proposed updates are identified in the attached appointments list, with vacated positions noted in yellow. This approach preserves institutional continuity while ensuring all committees remain fully staffed and functional.

Council Options:

City Council has the following options available at this time:

- 1. Confirm the updated committee appointments as presented.
- 2. Modify the proposed appointments.
- 3. Defer action and request additional information.
- 4. Take other action as desired by Council.

Fiscal Analysis:

There is no direct fiscal impact associated with confirming these committee appointments. Staff support for committees is an existing operational function. Management of staff time related to committee coordination, meeting preparation, and follow-up continues to account for approximately 4–8 hours per month, inclusive of support for monthly meetings and associated administrative work.

Diversity Equity Inclusion & Stakeholder Analysis:

In filling the identified vacancies, consideration was given to representation, lived experience, and the value of bringing forward new perspectives, while also maintaining necessary institutional knowledge on standing committees.

In particular, committees with complex operational or interjurisdictional responsibilities—such as the Bingen–White Salmon Joint Wastewater Committee—benefit from continuity and familiarity with historical agreements, funding structures, and ongoing negotiations. The proposed appointments seek to balance these considerations while supporting effective governance and inclusive representation.

Policy & Plan Implications:

Confirming the proposed committee appointments supports effective City governance and ensures continued participation in required advisory, operational, and interlocal bodies. Maintaining continuity while addressing only necessary vacancies aligns with Council best practices and minimizes disruption to ongoing committee work.

Recommendation of Staff/Committee:

It is recommended that City Council confirm the committee appointments as presented, maintaining all previously adopted assignments and approving only the limited changes required to fill vacancies resulting from the conclusion of Councilmember Hartmann's term.

NATURE OF GRIEVANCE:

Excessive and unexplainable water bill from 11/15/2023 through 12/03/2023 which states usage of approximately 6500 gallons per day for 18 days, 116,000 gallons used or \$1025.00 for billing period 11/06/2023 thru 12/06/2023.

Historical usage on this property averages 4,000 gallons per month.

Timeline contact with City of White Salmon:

We received a high usage rate notice on 12/11/2023.

We contacted Troy Rosenburg at the city on 12/12/2023.

Troy arranged to have a city worker "Jeff" to meet our friend at the property (we were also video called and present for this inspection). Upon inspection Jeff determined that there were no leaks inside or outside of the property coming from any source. Jeff mentioned that it might be a mis-read meter, mentioning something about the new meters not having a decimal?

Property facts:

- 1. Duplex property with one tenant on one side and owner occupied on the other. Owners of the property are traveling and have not occupied the property for a year.
- 2. Hillside property with no irrigation system and landscaping predominantly shrub plants.
- 3. No swimming pool or hot tub.
- 4. No leaks inside or outside of the structure have been found.

Conclusion:

We are completely baffled by this over usage and have no answer to this mystery, nor are we experts in the area. However, we strongly believe something is seriously amiss. We are asking the city to explore all possible options of computer error, equipment error, human error or infrastructure malfunction.

Until such time as a resolution to this mystery/grievance has been resolved we will continue in good faith to pay our standard water bill monthly.





Good Evening,

I am submitting a grievance report regarding a notice I received in September for unusually high water usage or a possible leak at 913 NE Vine. I contacted Ryan, a staff member for the city of White Salmon. Ryan went to the property and checked for a possible leak. Ryan reported no sign of an active leak on the property, and no leak alarm was activated. I called a plumber and had the property thoroughly checked, and he could not find any signs of a past leak or active leak. The plumber also explained that to produce the amount of water that the meter read shows for August and September, water would need to be running from a hose, faucet, or toilet all day, every single day for two months straight. No such occurrences have happened. Perhaps there is something wrong with the meter, and the city needs to investigate further, but I cannot pay a bill without proof that my property produced this amount of water within the stated time frame.





Action Required:

Council is asked to authorize the Mayor to execute the 2026 Interlocal Agreement with Klickitat County for West District Court Services.

Motion for Business Item / Proposed Motion for Consent Agenda:

Move to authorize the Mayor to execute the 2026 Interlocal Agreement with Klickitat County for West District Court Services.

Background of Issue:

The City of White Salmon contracts with Klickitat County for West District Court Services through an interlocal agreement. The attached agreement is the proposed contract for calendar year 2026.

The agreement is largely consistent with the City's prior contract. The only substantive changes are:

- A change in the term of the agreement from two years to one year, allowing for annual review and adjustment
- Clarification and formal inclusion of interpreter services billing, which was requested by the City to close a previously open issue and align practice with contract language

All other provisions, including cost allocation methodology, billing structure, and service scope, remain unchanged.

Council Options:

City Council has the following options available currently:

- 1. Accept the Staff Recommendation.
- 2. Revise the Staff Recommendation.
- 3. Other action as may be desired by the City Council.
- 4. Refer this issue back to staff for further work.
- 5. Take no action on this matter.

Fiscal Analysis:

There is no new or unanticipated fiscal impact associated with approval of this agreement.

Court service costs continue to be calculated based on the City's pro rata share of West District Court filings, consistent with prior years and the adopted District Court budget. Interpreter services will be invoiced separately, as clarified in the agreement, consistent with governing law and current practice.

Recommendation of Staff/Committee:

Approval of the agreement as presented.

Follow Up Action:

INTERLOCAL AGREEMENT BETWEEN THE CITY OF WHITE SALMON AND KLICKITAT COUNTY FOR DISTRICT COURT SERVICES

THIS AGREEMENT is made this ____ day of _____ by and between the CITY OF WHITE SALMON, a municipal corporation, hereinafter called "City" and KLICKITAT COUNTY, a political subdivision of the State of Washington, hereinafter called "County."

WHEREAS, the County has an established District Court System; and

WHEREAS, the City has been utilizing the services of West District Court with an interlocal agreement; and

WHEREAS, the City has historically paid its pro rata share of the Judge's salary and benefits; and

WHEREAS, the County had entered into a contract in 2024-2025 expanding the pro rata share paid by the City to include the salary and benefits of the Judge and salaries and benefits of West District Court personnel; and

WHEREAS, the purpose of this Interlocal Agreement is to set for the terms of usage of West District Court by the City pursuant to RCW 39.34.180;

NOW THEREFORE, BE IT AGREED by and between the parties as follows:

(1) West District Court Services. The County and its District Court shall furnish to the City the facilities and services of the West District Court for all cases wherein the City is the plaintiff in the West District Court, over which the West District Court has jurisdiction, for purposes of enforcing violation of state statutes or city ordinances committed by persons within the City's jurisdiction that constitute gross misdemeanors, misdemeanors, or civil infractions. Nothing in this Agreement shall permit the City to regulate the administration of the court.

(2) Compensation.

The method for determining the current year's annual charge shall be determined by the average percentage of the municipality's previous 3 years of total Court Filings. The adopted District Court budget expenses shall multiply this percentage for the year.

- (a) <u>Calculation of Percentage of Usage.</u> The parties have determined, and do hereby agree, that in return for facility usage and services of the District Court, the City shall pay the County, the City's pro rata share of the total costs of the salaries and benefits of the West District Court judge and courtroom personnel. The Washington State Caseload Reports will be the source for this utilization. The pro rata share shall be an amount equal to the ratio of the total number of violations filed wherein the City is the plaintiff, whether infractions or criminal violations, to the total number of (1) violations filed by all jurisdictions in West District Court, plus (2) felony complaints filed in West District Court, plus (3) small claims cases filed, plus (4) civil cases filed, plus (5) civil protection orders, plus (6) petitions for anti-harassment orders, plus (7) parking infractions.
- (b) Costs to be Allocated by Percentage. The total costs allocated by paragraph (2)(a) above shall include, but are not limited to, and the salaries and benefits of the West District Court judge and salaries and benefits of the West District Court personnel, for the adopted budget year excluding (i) the costs of public defense for criminal defendants in West District Court; and (ii) the costs of housing of prisoners that are reflected in a separate budget line and in agreement with the Klickitat County Department of Corrections.
- (c) <u>Time Period for Determining Percentage</u>. The ratio described above in paragraph (2) (a) shall, for each year, be determined by the average percentage of the City of White Salmon's previous 3 years of total Court filings.

- (d) <u>Interpretation Costs.</u> Interpreter fees and expenses are not subject to waiver and will be invoiced quarterly to the City of White Salmon and must be paid in accordance with this Agreement, except where prohibited by governing law.
- (3) **Billings.** The County will invoice the City annually for the City's pro rata share of the agreed- upon figure for the calendar year. All sums due to the County shall be paid within thirty (30) days of mailing such invoice, via regular mail or electronic mail.
- (4) **Distributions of Revenues to the City**. All money received by the West District Court pursuant to court action in a case filed by the City, including penalties, fines, bail forfeitures, fees and costs, except as otherwise prohibited herein, shall be paid by the West District Court to the City; provided that the County may retain all money received as payments of assessments for probation costs ordered in the City's cases. The City shall not be entitled to any revenue received by West District Court other than revenues received pursuant to court action in a case filed by the City.
- (5) **Term.** This Agreement shall be effective upon execution by the parties and recording with the Klickitat County Auditor and shall remain in effect through December 31, 2026, unless earlier terminated pursuant to the terms of this Agreement or extended by written amendment. The Parties will negotiate the cost of West District Court Services every year. The County is responsible for sending a proposal to the City no later than October of 2026.
- (6) **Termination and Notice of Termination.** This Agreement is terminable by either party without cause if such party provides written notice of intent to terminate in accordance with RCW 3.50.810 and 35.20.010. Any such notice from the City must be received by the Chairperson of the Klickitat County Board of County Commissioners by the statutorily required date, and any such notice from the County must be received by the Mayor of the City by the statutorily required date.
- (7) **Ownership of Property.** All real and personal property used in the operation of West District Court has been and shall continue to be acquired by the County, owned by the County and may be disposed of at the discretion of the County.
- (8) Waiver of Binding Arbitration. Provided that this Agreement is not earlier terminated pursuant to the terms stated above, this Agreement will expire on December 31, 2026, unless a written renewal Agreement is executed prior to such date. The City and the County waive and release any right to invoke binding arbitration under RCW 3.62.070, 35.20.010, 39.34.180 or other applicable law as related to this Agreement, any extension or amendment of this Agreement, or any discussions or negotiations relating thereto.
- (9) Indemnification Regarding City Ordinances. The City agrees that the County does not assume any liability or responsibility for or release the City from any liability or responsibility which arises in whole or in part from the existence or effect of City ordinances, rules or regulations, policies or procedures as well as any and all case filed by the Municipal Prosecutor and/or cited by members of City Police Departments. If any cause, claim, suit, action or administrative proceeding is commenced in which the enforceability and/or validity of any City ordinance, rule, regulation, policy or procedure is at issue or conduct or acts of Municipal Prosecutor and/or City Police Departments the City shall defend the same at its sole expense and if judgment is entered or damages are awarded against the City, the County, or both, the City shall satisfy the same, including all chargeable costs and attorney fees. This provision shall survive the termination of this Agreement.
- (10) General Indemnification. The City and the County each agree to defend and indemnify the other and its elected and appointed officials, officers, employees and agents against all claims, losses, damages, suits, and expenses, including reasonable attorneys' fees and costs, to the extent they arise out of, or result from, the negligence or willful misconduct of the indemnitor or its elected or appointed officials, officers, employees and agents in the performance of this Agreement. The indemnitor's duty to defend and indemnify extends to claims by the elected or appointed officials, officers, employees or agents of the indemnitor or of any contractor or subcontractor or indemnitor. The indemnitor waives its immunity under Title 51 of the Revised Code of Washington solely for the purpose of this provision and acknowledges that this waiver was mutually

negotiated. This provision shall survive the termination of this Agreement.

- (11) **Captions.** The paragraph and subsection captions used in this Agreement are for convenience only and shall not control or affect the meaning or construction of any provisions of this Agreement.
- (12) **Entire Agreement.** This Agreement contains the entire Agreement and understanding of the parties with respect to the subject matter hereof, and supersedes all prior oral or written understandings, agreements, promises or other undertakings between the parties, including but not limited to the interlocal agreement executed by the parties in 2009 for District Court Services.
- (13) **Governing Law.** This Agreement shall be interpreted in accordance with the laws and court rules of the State of Washington in effect on the date of execution of this Agreement. In the event any party deems it necessary to institute legal action or proceedings to ensure any right or obligation under this Agreement, the parties agree that such action shall be brought in a court of competent jurisdiction situated in Klickitat County, Washington.
- (14) **No Third-Party Rights.** Except as expressly provided herein, nothing in this Agreement shall be construed to permit anyone other than the parties hereto to rely upon the covenants and agreements herein contained nor to give any such third party a cause of action (as a third-party beneficiary or otherwise) on account of any nonperformance hereunder.
- (15) **Amendment or Waiver.** This Agreement may not be modified or amended except by resolution or ordinance adopted by the City and the County. No course of dealing between the parties or any delay in exercising rights hereunder shall operate as a waiver of any rights of any party.

The LOCAL Program has already reviewed and approved the City's financing request under that ordinance. Acting under this existing authority, the City has proceeded with acquisition of the approved equipment and is now actively working with the State Treasurer to complete reimbursement processing.

Since adoption of the ordinance, there have been changes in City staff and designated agency representatives, as well as newly seated Council members as of January 1. As a result, Treasury's legal counsel has requested updated resolutions and certifications reflecting the City's current authorized officials to finalize reimbursement.

Council Options:

City Council has the following options available currently:

- 1. Accept the Staff Recommendation.
- 2. Revise the Staff Recommendation.
- 3. Other action as may be desired by the City Council.
- 4. Refer this issue back to staff for further work.

5. Take no action on this matter.

Fiscal Analysis:

Section 1. Reaffirmation of Prior Authorization

Motion for Business Item / Proposed Motion for Consent Agenda:

Motion to adopt Resolution No. 2026-01-638 expressing support for the White Salmon Valley School District's 2026 Educational Programs & Operations (EP&O) Levy renewal and Capital Bond measure.

Explanation of Issue:

The White Salmon Valley School District (WSVSD) has placed two measures on the February 2026 ballot for voter consideration: a renewal of the Educational Programs & Operations (EP&O) Levy and a Capital Bond measure to modernize aging school facilities and establish a unified K–12 campus.

The attached resolution expresses the City of White Salmon's support for these measures, recognizing the interconnectedness of strong public schools, a resilient community, and long-term economic vitality. While the City does not operate or fund the WSVSD, City Council has the ability to express a policy position acknowledging the broader community impacts of educational infrastructure, enrollment stability, and school facility conditions.

Over the past year, WSVSD has conducted an extensive public engagement and outreach process, including the work of a Citizens Committee, technical and financial analysis, and community input, culminating in the proposal now before voters.

Council Options:

City Council has the following options available at this time:

- Adopt the resolution as presented.
- Amend the resolution.
- Defer action for additional information or discussion.
- Take other action as desired by Council.

Fiscal Analysis:

There are no fiscal impacts to the City's budget associated with adoption of this resolution. The resolution does not commit City funds, impose costs, or obligate City resources.

For contextual purposes, the School District continues to experience declining enrollment, which results in reduced per-capita state funding. The proposed Capital Bond is structured to maximize anticipated state construction assistance, leveraging local property tax contributions with approximately \$34 million in projected state match funding. Adoption of the resolution does not alter or affect City finances.

Diversity Equity Inclusion & Stakeholder Analysis:

Washington State's school funding formulas continue to disadvantage rural districts, where declining enrollment and per-capita funding structures create persistent inequities compared to urban systems.

The School District's approach seeks to address these challenges by maximizing per-dollar state match opportunities and investing in facilities that equitably serve all students. From a broader equity perspective, modern, safe school facilities support educational access, staff retention, and community confidence in rural education systems. The resolution acknowledges these structural considerations without directing or influencing voter outcomes.

Policy & Plan Implications:

Adoption of the resolution is consistent with the City's broader goals related to community vitality, economic resilience, and support for families. Expressing support for the School District's measures recognizes that educational infrastructure is a key component of long-term community stability and workforce retention.

The resolution does not create new policy obligations or modify existing City plans.

Legal Considerations

Expressing institutional support through adoption of a resolution does not conflict with Washington State laws governing municipal electioneering, provided no public funds or resources are used to advocate for or against a ballot outcome. The proposed resolution is limited to stating the City's policy position.

The Council meeting at which this resolution is considered will include an opportunity for public comment, allowing residents to speak in support of or opposition to the City taking this action prior to Council deliberation.

Recommendation of Staff/Committee:

It is recommended that City Council adopt Resolution No. 2026-01-638 expressing support for the White Salmon Valley School District's 2026 EP&O Levy renewal and Capital Bond measure, recognizing the importance of strong schools to a strong community while maintaining clear fiscal and legal boundaries for the City.

CITY OF WHITE SALMON RESOLUTION NO. 2026-01-638

A RESOLUTION OF THE CITY OF WHITE SALMON EXPRESSING SUPPORT FOR THE WHITE SALMON VALLEY SCHOOL DISTRICT'S 2026 EDUCATIONAL PROGRAMS & OPERATIONS (EP&O) LEVY RENEWAL AND CAPITAL BOND PROPOSITION NO. 1 AND 2.

WHEREAS, the White Salmon Valley School District has approved submission to voters within the District the consideration of Proposition No. 1 and 2: the renewal of the Educational Programs & Operations (EP&O) Levy and a Capital Bond to modernize aging facilities and create a unified K–12 campus, and;

WHEREAS, strong communities are built on strong public schools, and the City of White Salmon recognizes that safe, modern, and adaptive school facilities are essential to the long-term success, well-being, and economic vitality of our residents; and

WHEREAS, the EP&O levy is not a new tax, but a renewal of existing local funding that covers approximately 16% of the district's annual budget—supporting classroom staffing, programs, athletics, safety needs, and student services that the State of Washington does not fully fund, and:

WHEREAS, the District's proposed \$77.8 million bond is the culmination of multiple years of study, technical analysis, extensive community engagement, and the work of the District's Citizens Committee, which unanimously recommended a unified K–12 campus as the most effective, efficient, and future-ready solution for addressing aging and outdated school facilities, and;

WHEREAS, the district's current facilities no longer meet the needs of today's students or teachers, are spread across aging and inefficient buildings, and lack the flexibility necessary to support next-generation learning environments; and

WHEREAS, the bond is projected to unlock approximately \$34 million in anticipated state construction assistance funds, maximizing local investments through significant state match opportunities, and;

WHEREAS, the District's finance subcommittee identified a critical timing factor: due to state formulas and declining enrollment trends, the available state match (SCAP value) would decrease by roughly \$8 million if a bond does not pass in 2026—meaning that delaying action would leave substantial state dollars on the table and diminish long-term fiscal efficiency for local taxpayers, and;

WHEREAS, approving the bond in 2026 positions the community to capture all available state matching funds, avoid unnecessary cost escalation, and invest wisely in long-term community assets that benefit families and future generations; and

WHEREAS, modern, safe, and well-designed school facilities are essential for attracting and retaining educators, supporting student achievement, and ensuring that children in White Salmon, Bingen, and the broader valley have spaces that reflect the value our community places on education; and

WHEREAS, the City recognizes that thriving schools strengthen neighborhoods, bolster workforce stability, support economic development, and reinforce the shared identity and resilience of the entire White Salmon Valley;

WHEREAS, in compliance with RCW 42.17A.555, the public meeting notice included the title and number of the White Salmon Valley School District Proposition No. 1 and 2, and members of the public were given an equal opportunity to express opposing views on the measures.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WHITE SALMON, WASHINGTON, THAT the City of White Salmon hereby expresses its support for the White Salmon Valley School District's 2026 EP&O Levy renewal and Capital Bond Proposition No. 1 and 2, recognizing these proposals as fiscally responsible, community-driven investments that maximize state funding opportunities and address urgent facility modernization needs.

BE IT FURTHER RESOLVED that the City encourages all eligible voters to become informed about these measures and to participate in the February 10, 2026, election.
