September 4, 2025

Call to Order:

The meeting was called to order at 4:00 p.m. by Jason Knight, Parks Director and acting Board Chair.

New Business

1. Arbor Day Event – October 30, 2025

The board discussed plans for the upcoming Arbor Day event scheduled for October 30, 2025. Ideas included educational signage, a short presentation on proper tree care, and involving local school groups or community volunteers in planting or mulching activities. Holmes offered to assist with providing educational materials and suggested highlighting the city's Tree City USA status as part of the event promotion.

2. General Discussion of Needed Tree Work

The board engaged in a general discussion of tree maintenance needs throughout the city, including pruning of low limbs along sidewalks and trails, removal of declining trees in high-traffic areas, Knight agreed to coordinate with Public Works to prioritize locations and to consult with MDC on best practices for pruning and hazard mitigation where necessary. Holmes reiterated MDC's willingness to provide technical guidance on site-specific issues.

Old Business

1. Follow-Up on October Planting

Knight provided an update on the planned planting at the Frisco trailhead and other designated areas, scheduled for October. Grant funding for the project has been confirmed. Holmes restated that a fall planting timeline remains appropriate but noted that site preparation—such as vegetation control and soil assessment—should be completed in advance. Clark-Berry again expressed support for prioritizing native species in the planting plan. Holmes confirmed that using native trees will continue to benefit the city's scoring for related grants and cost-share opportunities.

Adjournment

Flint made a motion to adjourn the meeting. The motion was seconded by Stenberg. The meeting was adjourned at 4:45 p.m.
