Motion by Mr. Hren, second by Mr. Mohorcic, to accept the application for a Special Events Permit for the 30th Annual Homecoming Festival for St. Mary Magdalene Church.

Discussion: It was expressed that nothing has changed from previous years. Vote: All ayes. Motion carried.

Remarks - New Business

Consideration to accept the application for a Special Events Permit for the $50^{\rm th}$ Year Anniversary Celebration for Giuseppe's Pizza Inc. located at 30441 Euclid Ave, from May $6^{\rm th}$, 2022 to May $7^{\rm th}$, 2022.

Motion by Mr. Hren, second by Mr. Mohorcic, to accept the application for a Special Events Permit for the $50^{\rm th}$ Year Anniversary Celebration for Giuseppe's Pizza Inc.

Discussion: Mr. Carden stated that this approval would be pending the Health department, Fire department and Police department requirements. There was discussion regarding the tent size of 20x30, Patty Catanese advised that the tent size is smaller than the original plan of 30x30 due to the size of the parking lot. Mr. Carden asked if there would be a need for any road closures. Patty Catanese stated that there is no need for road closures or closure of either of the entrances/exits. Patty Catanese stated that there will be cones around the tent so that patrons know where not to go. Mr. Carden asked about the live band that will be playing at the event, Patty Catanese stated that this is not a full band, this is a duo of brothers playing at the event. The board wanted to make sure that Patty and Joseph Catanese were aware of the noise ordinance. Mr. Hren asked if both the entrance/exits will be open and operational, Patty advised that yes they will both be open. Mr. Hren asked if there would be any concern as far as a barrier protecting the

building. Mr. Mohorcic stated it looks like there will be built in barriers with what they have set up, there will be a large tent as well as a truck and the cones are just an added deterrence so patrons do not drive through the area. There was some discussion regarding the traffic pattern and the location of the tent being on the side of the building and not in the parking lot of the establishment. Patty Catanese advised that as an added measure she will have an older employee monitoring the area. The board touched on the noise ordinance again and Patty Catanese stated that the celebration is set to end at 5pm. Vote: All ayes. Motion carried.
