REPORTS & COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

As part of the Mayor's report-Nik Janek-Council Liaison for the General Health District reported there are currently two known cases of TB (Tuberculosis) in the county. There is no funding source for this and the general fund will have to cover the costs for each individual reported. Treatment is approximately \$800 plus transportation per patient visit and can last between 6-16 months. The health department is currently creating an account with LakeTran dial-a-ride for a special vehicle to transport sick patients.

There was a resolution to award the 2023 clean inspection award to qualifying food services and establishments, which passed unanimously. The Willowick establishments include CP Cooler and the Willowick Senior Center.

Mayor Vanni discussed the successful eclipse event with the help of all city departments. Both police and fire chiefs are in search of grants to help cover the costs of the extra labor needed to prepare for this event.

The local government fund is continuing to move slowly but is making progress for the deadline of June 1, 2024. Meetings to continue with the western end municipalities and the ad hoc committee with a proposed completion by May 16, due to budget hearings with auditors and commissioners.

Vine Street resurfacing has begun with an expected completion of November 2024 (11/2025).

Civil Service meeting with discussions centered around the assistant fire chief position, where there are two pieces of legislation on the agenda (establishing position and establishing pay rate). If passed, the next step would be testing.

Electric company was out to cut the power at the house next door. Demolition may now take place either June or no later than July. Bids are out and currently coming back.

The CDBG grants received in the amount of \$145,900.00 for a new generator in senior center and an additional \$104,000.00 for building ADA curb ramps for Vine Street.

Meetings with all the mayors and the superintendent are held once a quarter. Superintendent Dr. Ward expressed interest in attending council meetings throughout the school district. Mayor is looking to have Dr. Ward attend prior to school starting next fall.

Zeppe's Pizza is looking to occupying one of the spaces at the strip mall once approvals are complete.

The 50th anniversary of the senior center to be held April 17.

 - b. HCAP should take care of it, if the individuals can get a ride to the hospital.
 - c. Cost is \$800 per visit plus transportation.
 - d. Typical treatment 6 -8 months but can be up to 14 -16 months.
 - e. The Health Department is creating an account for Laketran Dial-a-ride.
