ORDINANCE NO. 2025-31**AN ORDINANCE APPROVING AND CONFIRMING
THE APPOINTMENT OF GORAN VRHOVAC AS
DIRECTOR OF FINANCE, PROVIDING FOR THE
COMPENSATION OF THE DIRECTOR OF FINANCE,
REPEALING CERTAIN ORDINANCES, AND
DECLARING AN EMERGENCY.**

WHEREAS, the Mayor has appointed Goran Vrhovac as Director of Finance pursuant to the provisions of Section 5.4 of the Willowick City Charter and Council has approved said appointment.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Willowick, County of Lake, State of Ohio:

Section 1. That the appointment by the Mayor of Goran Vrhovac as Director of Finance for the City for the term commencing August 30, 2025 and terminating December 31, 2027, is hereby approved and confirmed.

Section 2. That the aforesaid Director of Finance shall be paid compensation for the period beginning August 30, 2025 and terminating December 31, 2027 at the rate of Four Thousand Thirty Eight and 46/100 (\$4,038.46) per bi-weekly pay period.

Section 3. That said Director shall respond to the inquiry of Council regarding the service of his Department and such matters that would come within his Department's responsibilities.

Section 4. That all ordinances or part thereof in conflict with the provisions of this Ordinance are hereby repealed

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance, were conducted in an open meeting of this Council and that all deliberations of the Council and any of its committees that resulted in such actions, were conducted in meeting open to the public in compliance with all legal requirements included Chapter 123 of the Codified Ordinances of the City of Willowick.

Section 6. That this Ordinance constitutes an emergency measure in that the same provided for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willowick and further, provide for the usual daily operation of a municipal department.

WHEREFORE, this Ordinance shall be in full force and effect immediately upon its passage by Council and approval by the mayor.
