Plan Review Board Minutes - July 25th, 2024

Motion made to approve the July 25th, 2024, Plan Review Board minutes by Mr. Lazor, Seconded by Chairman Brennan

New business

Arby's - Located at 31219 Vine St. - Interior Alteration

Chairman Brennan advised the board that this submittal is for an interior alteration. John Wilber with Art Vision Architect, the architect for Arby's was present representing Arby's - Located at 31219 Vine Street. Chairman Brennan stated that we have received a copy of the plans and application, Arby's will be doing an interior alteration as well as putting a canopy over the drive through. Mr. Wilber stated that

this is correct, and they will also be painting the exterior of the building. He advised that structurally there are no changes, they will be adding some canopies as well as changing out the signage. Chief Brennan asked with regards to the plans, if they will be doing something with the handicap parking, Mr. Wilber stated that they will be addressing and repairing any handicap issues. Regarding the canopy, at the drive through lane they will be replacing the speaker post with an integrated canopy, the menu board will remain. There was some discussion regarding the contractor that will be completing these alterations.

Motion made to approve Arby's - Located at 31219 Vine St. - Interior Alteration by Mr. Lazor, Seconded by Chairman Brennan.

Amazing Minds Learning Center - Located at 31809 Vine Street

Chairman Brennan advised that this submittal is to open a childcare center. Mr. Bennett and Mrs. Bennett were present representing Amazing Minds Learning Center - Located at 31809 Vine Street. Mrs. Bennett stated that they have had a daycare for 19.5 years, which is home based center, and they no longer have enough space. Cuyahoga County assisted them with securing a grant so they would be able to get a building. Mrs. Bennett advised that she has five degrees, and her daughters and Mr. Bennett have degrees as well in education. She stated that she is working on her doctorate, and they are working on their masters. She stated they live in Richmond Heights, and they would like to branch out. She provided reasoning as to why they want to be in Willowick. Chairman Brennan stated that when they previously met to go over the plans, there was a question regarding the kitchen and stated he asked for an updated modifications to the kitchen, Mr. Bennett provided the updated floor plan at this time, and it was passed around to board members to review. Chief Brennan advised the board that the kitchen on the plans is going to be a new kitchen being installed on the first floor where there was not previously a kitchen so this will all be new. Mr. Bennett stated that they will not be having a stove with a hood, it will be a small convection oven. Mr. Lazor confirmed that this is the Paramount building. Chairman Brennan referred to the application regarding hours of operation and confirmed they are seeking to be open 24 hours, he advised that the ordinance states business operation hours, the business has to be closed from 1am to 5am, he advised that if they wanted to be open 24 hours they have the right to ask City Council for their approval. Chairman Brennan recapped the ordinance regarding hours of operation. Chairman Brennan stated the second item in question would be regarding the parking, per the submitted site plan, there are certain requirements regarding parking based on the square footage of the establishment. He advised that they need a minimum of one parking space per 200 square feet, the building has 8000 square feet in the habitable area. He stated that per the site plan there are 45 parking spots on the application however on the site plan it shows that they would like to have a playground in the area of parking. He advised that you always need the parking spaces based on the square footage per the ordinance. There was a discussion regarding state requirements for a playground. Mrs. Bennett stated that they can make the playground area much smaller so not to take away from parking spaces. Chairman Brennan stated that he only counted 12 parking spaces per the site plan, he obtained a site plan off the Lake County Auditors website to show the parcel and showing the parking areas as well. There was some discussion regarding the parcel with regards to parking and property lines. Mr. Bennett asked if they put a smaller playground in to make sure there is enough parking per the ordinance. Chairman Brennan stated that what the board needs is a submittal with the correct parking showing the parking areas, labeled. He stated that per the square footage there are 40 spaces needed, the current submittal only shows 12. There was some further discussion regarding property lines. Chairman Brennan stated to submit another plan back to the board regarding parking spaces specifically only on

this buildings parcel. Chief Brennan clarified that they will using the first floor and the second floor, and the basement will just be for storage, Mrs. Bennett stated that, that is correct. Chief Brennan stated that he is going to make a recommendation that this is tabled until the revised parking space site plan is submitted for review.

Motion made to table Amazing Minds Learning Center - Located at 31809 Vine Street due to parking spot compliance by Mr. Lazor, Seconded by Chairman Brennan.
