2. Mayor Regovich stated he as well as Council have accepted the resignation of Fire Chief Joe Tennyson which is effective October 8, 2022.

The current active list for Fire Chief will expire on October 19, 2022. Candidates #2 and #3 on the list were previously interviewed and will be contacted and offered the position. If they decline then the interview process will move onto candidates #3 and #4.

Motion made by Mr. Lazor, seconded by Mr. Wittlinger allowing the Mayor to contact candidates #2 and #3 on the current Fire Chief eligibility list and offer them the Fire Chief position. If candidates #2 and #3 decline then the Mayor shall proceed with the interview process on candidates #4 and #5 from the current list.

#### **MISCELLANEOUS**

Acting Fire Chief Zak brought up a concern about the Willowick Fire Department Policy & Procedure Manual being on the book list for the upcoming captain promotional exam. He stated that the only existing paper copy of the policies & procedures only contains Series 100 through 300 and he has not been able to locate Series 400 through 700. There is shared drive that exists for viewing but is also missing Series 400 through 700. The paper copy and shared drive would need to be compared to make sure that the information on Series 100 through 300 is accurate on both.

Chariman Tobin feels that due to the discrepencies in the material that the Willowick Fire Department Policies & Procedures Manual should be removed from the exam process.

Motion made by Mr. Lazor, seconded by Mr. Wittlinger to remove from the reading list the Willowick Fire Department Policies & Procedures for the upcoming captain promotional exam.
