Cleveland Pizza / Six City Tavern (Final Plans) - located at 31222 Vine Street

Derek Jones was present as the owner of Cleveland Pizza / Six City Tavern and Mark Maltry representing Gem Construction who will be doing the work at this establishment. Chief Brennan advised that they provided the final plans for the establishment which were previously sent to the board members for review. There was some discussion regarding the final plans and Mr. Maltry indicated that the requested updates will be provided next week. He did question the comment about the additional catch basins and then there was some discussion between Mr. McLaughlin and Mr. Maltry regarding placements of catch basins both current and new. Mr. McLaughlin stated that if the plan submitted works, then he is fine with it. Mr. McLaughlin and Mr. Maltry will be communicating more throughout the process. Chief Brennan advised that there are going to be variances needed for the setback (20' needed and submitted at 16' 9"), fence requirements (currently the plan is submitted at an 8' high fence and maximum is 6'), 10' greenspace is needed per the ordinance (how it is currently submitted they won't have enough greenspace due to the parking lot size), and due to the square footage of the building per

the ordinance they are required to have 82 parking spaces (currently submitted at 70). These are the variances that they will need to submit for. Chief Brennan asked if there are any traffic concerns, and no concerns were mentioned other than making sure there is proper signage.

Motion made by Mr. McLaughlin, Seconded Chief Brennan to approve Cleveland Pizza / Six City Tavern (Final Plans) pending approval of the variances needed from Board of Zoning Appeals and City Counsil.
