#### **AGENDA ITEM:**

Consideration & Action: Award a construction contract to Humphrey & Morton Construction Company, Inc. for the 2022 Drainage Improvements, Phase I project.

# **BACKGROUND:**

On November 30, 2022, a bid opening was conducted at City Hall for the 2022 Drainage Improvements, Phase I project. A total of six (6) bids were received for three (3) separate bid schedules. Bid Schedule A consists of improvements to the Pleasant Ridge culvert crossing near El Chico, Bid Schedule B consists of regrading of an earthen channel from Sam Bass Road to Squaw Creek Road, and Bid Schedule C consists of improvements in the channel along the eastern city limits flowing to El Chico.

Staff recommends award of the contract to the lowest responsive bidder, Humphrey & Morton Construction Company, Inc. for the combination of all base bid schedules. The total contract will include the following amounts: \$158,581.00 (Bid Schedule A), \$52,874.00 (Bid Schedule B), and \$519,580.00 (Bid Schedule C) for a total project cost of \$731,035.00.

Staff recommends Council award a construction contract to Humphrey & Morton Construction Company, Inc. for the 2022 Drainage Improvements, Phase I in the amount of \$731,035.00.

We have reviewed the bids for the above referenced project. There were six bids received and accepted for three separate bid schedules. Bid Schedule A was for improvement to the Pleasant Ridge Culvert crossing near El Chico, Bid Schedule B was for improvements for the channel from Sam Bass Road to Squaw Creek Road, and Bid Schedule C was for improvements in the channel along the eastern city limits flowing to El Chico. The low bid for the combination of all base bid schedules was submitted by Humphrey & Morton Construction Company, Inc. for the total bid amount of \$731,035.00.

We've found no reason to disqualify the low bidder and do not believe that rebidding will result in better pricing at this time. We would recommend award of the total bid to Humphrey & Morton Construction Company, Inc. in the amount of \$731,035.00.
